**JOINT STATEMENT RE: FURTHER PROCEEDINGS
ON THE CLAIMS OF LANGUR MAIZE**

On July 10, 2024, this Court announced certain interlocutory oral rulings on certain of the claims tried in this adversary proceeding. Following those rulings, the parties to the Langur Maize action conferred and recently agreed to ask Judge Lopez if he would mediate the claims tried by Langur Maize (the “Langur Maize Claims”). The parties contacted Judge Lopez last Friday, August 9, to inquire as to his availability and willingness to act as a mediator.

Further proceedings are required to resolve the Langur Maize Claims. The Court has not heard closing argument on the elements of liability on the Langur Maize Claims or the defenses thereto beyond that directed to the breach of the Unsecured Indenture. The parties request a date for that argument. Platinum, Carlyle, and Senator have proposed that additional briefing should be submitted with respect to the Langur Maize Claims. Langur Maize does not believe that any further briefing is needed or warranted.

The parties intend to address the need for briefing and the scheduling of further proceedings at the status conference currently set for August 13, 2024 at 9:00 a.m. Central Time.
