**NOTICE OF INTENT TO ADDUCE TESTIMONY FROM A REMOTE LOCATION  
BY TELEPHONE AND VIDEO TECHNOLOGY**

1. The above-captioned reorganized debtor (the “*Reorganized Debtor*”<sup>2</sup> or “*Incora*” and, together with its affiliated former debtors and their successors, as applicable, the “*Reorganized Debtors*”) files this (the “*Notice*”) pursuant to Bankruptcy Local Rule 9017-1(c)(2)(B) with respect to the *Certificate of No Response Regarding Reorganized Debtors’ Ninth Omnibus Objection to Proof of Claim* [Docket No. 2869] (the “*Certificate of No Response*”).

2. This Notice pertains to the hearing on the Certificate of No Response set for **June 23, 2025, at 3:30 p.m. (Central Time)** before the Honorable United States Bankruptcy Judge Marvin Isgur at the United States Bankruptcy Court for the Southern District of Texas, Houston Division, Courtroom 404, 515 Rusk Avenue, Houston, Texas 77002 (the “*Hearing*”).

3. Parties may appear at the Hearing in-person or by remote participation. For those parties who wish to participate remotely, the audio communication will be by use of the Court’s

Video communication will be by use of the GoToMeeting platform. Connect via the free GoToMeeting application or click the link on Judge Isgur's home page (<https://www.txs.uscourts.gov/content/united-states-bankruptcy-judge-marvin-iskur>). The meeting code is "JudgeIsgur". Click the settings icon in the upper right corner and enter your name under the personal information setting.

4. The Debtors intend to call Christopher Kelly, Managing Director, Alvarez & Marsal North America, LLC and P. Joe Morrow IV, Vice President, Corporate Restructuring, Kurtzman Carson Consultants LLC d/b/a Verita Global, to testify at Hearing by telephone and video technology.

5. Any party-in-interest may object to this Notice within 3 days of its filing on the Court's docket. If no party-in-interest files a timely objection, the Court will allow the identified witnesses to give testimony remotely using the Court's telephone and video technology. If the Court does not authorize the testimony to be taken remotely, the Court will schedule a date for the witness's testimony to be given live in open court. Both the witness(es) and the objector must appear in person at the scheduled date.

6. This Notice may be withdrawn or modified at any time prior to the Hearing.
