MEMORANDUM OF POINTS AND AUTHORITIES

This motion is made pursuant to Rule 7.1 (f) of the U.S. District Court for the Northern Mariana Islands Local Rules. Due to the exigent circumstances of this case, there is good cause to shorten time and allow for an expedite briefing and hearing schedule on Team King's Motion to Quash Notice of Remote Deposition for March 18, 2025.

The parties have not made any previous request to shorten time. The reasons for the motion are twofold. First, due to previously scheduled travel by Team King's principal, Hiroshi Kaneko, as well as counsel for Team King's scheduled hearings in multiple courts, the proposed date of March 18, 2025, is simply not available. Second, the hearing to confirm the sale of Imperial Pacific International, LLC's assets to Team King is scheduled for March 25, 2025. There is no available day or time to conduct the deposition of Team King before

the sale confirmation hearing. Unless time is shortened, this dispute will likely complicate the confirmation of the sale.

Should the Court grant the Motion to Shorten Time, it will not impact any deadlines previously set. In fact, shortening time will allow the parties, with assistance from the Court, to resolve this dispute prior to the March 25, 2025 sale confirmation hearing.
