Secured creditors Joshua Gray ("Gray"), the Commonwealth of the Northern Mariana Islands (the "CNMI") (together, the "Secured Creditors"), the Official Committee of General Unsecured Creditors (the "Committee"), the debtor and debtor in possession Imperial Pacific International (CNMI), LLC (the "Debtor"), and the proposed winning bidder Team King Investment (CNMI), LLC ("Team King") (together, the "Parties"), through their counsel, hereby stipulate and agree:

- 1. The hearing date for the Joint Motion of Debtor and Official Committee of General Unsecured Creditors for Order (I) Approving the Sale of Substantially All of the Debtor's Assets Free and Clear of All Liens, Claims, and Encumbrances Pursuant to 11 U.S.C. § 363, Subject to Overbids; and (II) Authorizing the Assumption and Assignment of Certain Executory Contracts and Cure Amounts Associated Therewith (the "Motion") [ECF 367] is currently scheduled for March 25, 2025 at 9:00 a.m.
- 2. After the result of the auction of the Debtor's assets was announced, both Gray and the CNMI filed an opposition to the Motion. Gray and the CNMI also seek to conduct limited discovery related to the sale process and have adequate time to review that information prior to the hearing on the Motion. However, due to the travel schedules and other commitments of the parties responding to the discovery or who Gray and the CNMI seek to depose, it will not be possible to complete such discovery sufficiently in advance of the March 25, 2025 hearing date.
- 3. Accordingly, the Parties have agreed to adjourn the hearing on the Motion to April 15, 2025 at 9:00 a.m. (ChST), or such other date and time as is convenient for the Court.
