Secured creditors Joshua Gray ("Gray"), the Commonwealth of the Northern Mariana Islands (the "CNMI") (together, the "Secured Creditors"), the Official Committee of General Unsecured Creditors (the "Committee"), and the debtor and debtor in possession Imperial Pacific International (CNMI), LLC (the "Debtor") (together, the "Parties"), through their counsel, hereby stipulate and agree:

- 1. On April 1, 2025, the Court approved a Stipulation by the Parties moving the hearing date on the Joint Motion of Debtor and Official Committee of General Unsecured Creditors for Order (I) Approving the Sale of Substantially All of the Debtor's Assets Free and Clear of All Liens, Claims, and Encumbrances Pursuant to 11 U.S.C. § 363, Subject to Overbids; and (II) Authorizing the Assumption and Assignment of Certain Executory Contracts and Cure Amounts Associated Therewith (the "Motion") [ECF 367] to April 29, 2025 at 9:00 a.m. (ChST), permitting Gray and the CNMI to file any supplemental oppositions to the Motion by April 15, 2025, and permitting the Committee and Debtor to file their supplemental reply briefs by April 22, 2025.
- 2. On April 15, 2025, the Court approved a subsequent stipulation permitting Gray and the CNMI to file their supplemental oppositions to the Motion by April 19, 2025 at 12:00 p.m. (ChST).

The Parties continue to engage in settlement discussions to resolve the Secured Creditors' objections to the Motion, significant progress has been made since the prior Stipulation between the Parties, and the Parties believe that it is likely that a settlement will be reached.
