**FINAL ORDER (I) AUTHORIZING THE DEBTORS TO  
(A) CONTINUE TO OPERATE THEIR EXISTING CASH MANAGEMENT  
SYSTEM, (B) MAINTAIN EXISTING BANK ACCOUNTS AND BUSINESS FORMS  
AND HONOR CERTAIN PREPETITION OBLIGATIONS RELATED TO THE USE  
THEREOF, (C) MAINTAIN PURCHASING CARD PROGRAM AND HONOR  
PREPETITION OBLIGATIONS RELATED THERETO, AND (D) CONTINUE TO  
PERFORM INTERCOMPANY TRANSACTIONS; (II) MODIFYING CERTAIN  
DEPOSIT REQUIREMENTS; AND (III) GRANTING RELATED RELIEF**

Upon the motion (the “Motion”)<sup>2</sup> of the Debtors for entry of an Interim Order and a final order (this “Order”) (i) authorizing, but not directing, the Debtors to (a) continue to operate their existing cash management system, (b) maintain existing bank accounts and business forms and honor certain prepetition obligations related thereto, (c) maintain their purchasing card program and honor prepetition obligations related thereto, and (d) continue to perform intercompany funding, transfers, and transactions through their existing cash management system consistent with historical practice; (ii) extending the time for the Debtors to comply with the Bankruptcy Code section 345(b) deposit and investment requirements, to the extent necessary; and (iii) granting related relief, all as more fully set forth in the Motion; and upon consideration of the First Day Declaration and the Interim Order entered on June 5, 2024; and the Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; and the matter being a core proceeding within the meaning of 28 U.S.C. § 157(b)(2); and venue of this proceeding and the Motion in this District being proper pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court being able to issue a final order consistent with Article III of the United States Constitution; and due and sufficient notice of the Motion having been given under the particular circumstances; and the Court having reviewed the Motion and having heard the statements in support of the relief requested therein at a hearing before this Court (the “Hearing”); and the Court having determined that the legal and factual bases set forth in the Motion and at the Hearing establish just cause for the relief granted herein; and it appearing that no other or further notice is necessary; and it appearing that the relief requested in the Motion is in the best interests of the Debtors, their estates, their creditors, and other parties in interest; and after due deliberation thereon; and good and sufficient cause appearing therefor; it is hereby

**ORDERED, ADJUDGED, AND DECREED that:**

1. The Motion is granted on a final basis as set forth herein.
2. The Debtors are authorized, but not directed, to: (a) maintain and continue operating the Cash Management System and honor any prepetition obligations related thereto; (b) designate, maintain, and continue to use any or all of their existing Bank Accounts, including, but not limited to, the Bank Accounts identified on **Exhibit 1** hereto, in the names and with the account numbers existing immediately before the Petition Date; (c) deposit funds in and withdraw funds from the Bank Accounts by all usual means, including checks, wire transfers, and other debits; (d) treat their prepetition Bank Accounts for all purposes as debtor-in-possession accounts; (e) open new debtor-in-possession bank accounts or close existing accounts, *provided* that (i) any new account is with a bank that (x) is insured with the FDIC or the Federal Savings and Loan Insurance Corporation and (y) has executed (or is willing to execute) a Uniform Depository Agreement (“UDA”) with the U.S. Trustee, and (ii) the Debtors provide three business days’ advance notice to the U.S. Trustee, the DIP Lenders, and any statutory committee(s) appointed in the Chapter 11 Cases of the opening or closing of an account, and *provided further* that any account opened by any of the Debtors on or after the Petition Date at any Bank shall, for purposes of this Order, be deemed a Bank Account as if it had been listed on **Exhibit 1** hereto and entitled to the relief granted herein; and (g) pay the Bank Fees (including any prepetition amounts).
3. The Debtors are authorized to continue to maintain and manage the Resident Trust Accounts, Resident Trust Petty Cash Accounts, and the Resident Care Cost Accounts on behalf of their residents in the ordinary course of business consistent with prepetition practices. For the avoidance of doubt, the funds in the Resident Trust Accounts and Resident Trust Petty Cash

Accounts are not property of the Debtors' estates and shall not be available for distribution to creditors of the Debtors.

4. The Debtors are authorized to continue to maintain the Divested Facilities Accounts and continue to remit funds deposited by third parties into the Divested Facilities Accounts to the Third-Party Operators and, pursuant to the Final DIP Order, to MidCap Funding IV Trust ("MidCap") in accordance with prepetition practices. To the extent any funds owed to the Third-Party Operators are first paid to MidCap as described in Footnote 8 to the Motion, prior to the discontinuation of the sweep from the Concentration Accounts to MidCap, MidCap shall have no liability to any Third-Party Operator on account of receiving funds owed to such Third-Party Operator, and MidCap is authorized to remit any such funds to the Debtors. The Debtors are authorized to remit any such funds received from MidCap to the applicable Third-Party Operator.

5. The Debtors are further authorized, but not directed, to continue to use, in their present form, all Business Forms as well as checks and other documents related to the Bank Accounts existing immediately before the Petition Date; *provided, however*, that the Debtors will include the designation "Debtor-in-Possession" and the joint case number on all checks issued after the Petition Date and, when reordering checks, will require the designation "Debtor-in-Possession" and the corresponding bankruptcy case number on all such checks. For the avoidance of doubt, the Debtors are not required to add "Debtor-in-Possession" to the Resident Trust Account, Resident Trust Petty Cash Accounts, or Resident Care Cost Accounts.

6. Beginning July 17, 2024, the Debtors shall review on a weekly basis the balance in each Threshold Account (as defined herein) and transfer any amounts that exceed \$25,000 into the LaVie Main Funding Account. The ("Threshold Accounts") are the following accounts: (a) TD Bank account ending in 7220, (b) Somerset Trust Co. account ending in 2211, (c) First National

Bank account ending in 6191, (d) Pennian Bank account ending in 4935, and (e) Skyline Bank account ending in 5322. In addition, if, for any reason, the balance in any of the Threshold Accounts, respectively, ever exceed \$250,000.00, Debtors shall immediately notify the Office of the United States Trustee. Bankruptcy Code section 345(b), to the extent applicable and not otherwise met, is waived with respect to the Threshold Accounts.

7. The Debtors shall perform a weekly sweep of amounts that exceed \$25,000 into the LaVie Main Funding Account from the following accounts: (a) TD Bank account ending in 7220, (b) Somerset Trust Co., account ending in 2211, (c) First National Bank accounts ending in 6191 and 0563, (d) Pennian Bank account ending in 4935, and (e) Skyline Bank account ending in 5322.

8. The Banks are authorized to debit the Debtors' Bank Accounts in the ordinary course of business and without further order of the Court on account of (a) all checks drawn on the Debtors' accounts that were cashed at the Banks' counters or exchanged for cashier's or official checks by the payees thereof prior to the Petition Date; (b) all Bank Fees and costs in connection with any checks or other items deposited in one of the Debtors' accounts with such Bank prior to the Petition Date, which have been dishonored or returned unpaid for any reason, to the same extent the Debtors were responsible for such items prior to the Petition Date; and (c) all undisputed prepetition amounts outstanding as of the date hereof, if any, owed to any Bank as to service charges for the maintenance of the Cash Management System. The Debtors are authorized to issue postpetition checks, or to effect postpetition fund transfer requests, in replacement of any checks or fund transfer requests that have been (i) dishonored as a consequence of the Chapter 11 Cases and (ii) authorized by an order of this Court.

9. Subject to the terms of this Order, and only to the extent sufficient funds are available in each applicable Bank Account, all Banks at which the Bank Accounts are maintained

are authorized to continue to service and administer the Bank Accounts as accounts of the Debtors as debtors-in-possession, without interruption and in the ordinary course, and to receive, process, honor, and pay any and all checks, drafts, credit card payments, and wire transfers issued and drawn on the Bank Accounts after the Petition Date by the holders or makers thereof, as the case may be.

10. Any of the Banks may rely on the representations of the Debtors with respect to whether any check or other payment order drawn or issued by the Debtors prior to the Petition Date should be honored pursuant to this or any other order of the Court. Notwithstanding any other provision of this Order, should a Bank honor a prepetition check or other item drawn on any account that is the subject to this Order at the direction of the Debtors to honor such prepetition check or item, the Bank shall not be deemed to be, nor shall be liable to, the Debtors, their estates, or any other party on account of such prepetition check or other item being honored postpetition, or otherwise deemed to be in violation of this Order.

11. The Debtors are authorized, but not directed to (a) pay undisputed prepetition amounts outstanding as of the Petition Date, if any, owed in the ordinary course to the Banks as service charges for the maintenance of the Cash Management System and (b) reimburse the Banks for any claims arising before or after the Petition Date in connection with customer checks deposited with the Banks that have been dishonored or returned as a result of insufficient funds in the Bank Accounts in the ordinary course of business, to the same extent the Debtors were responsible for such items prior to the Petition Date.

12. The Debtors are authorized, but not directed, to enter into, engage in, and continue to perform under the Intercompany Transactions in the ordinary course of business and in compliance with past practices. The Debtors shall maintain accurate, current, and detailed records

with respect to all transfers between and disbursements from Bank Accounts, including, but not limited to, all Intercompany Transactions, so that they may be readily ascertained, traced, and properly recorded on intercompany accounts. Notwithstanding the foregoing, the Debtors shall provide the Committee with advance notice of their intent to satisfy any obligations related to a non-operating Debtor or a “DivestCo” that (a)(i) were not previously approved by prior Order of this Court or (ii) otherwise contained in a budget filed with this Court prior to the date hereof and (b) which exceed \$15,000 in the aggregate on a monthly basis. The Committee shall have ten (10) days from receipt of such notice to seek expedited judicial review of the proposed payments before any such payments are made. The foregoing is without prejudice to any and all rights the Committee may have to challenge any proposed payments to be made by the Debtors on behalf of a DivestCo or non-operating Debtor and the Debtors reserve all rights they may have to oppose any such challenge.

13. Notwithstanding the Debtors’ use of a consolidated cash management system, the Debtors shall calculate quarterly fees under 28 U.S.C. § 1930(a)(6) based on the disbursements of each Debtor, regardless of which entity pays those disbursements.

14. The Debtors are authorized, but not directed, to continue to use the Purchasing Card Program and pay prepetition obligations arising in connection with such program.

15. The existing deposit agreements between the Debtors and the Banks shall continue to govern the postpetition cash management relationship between the Debtors and the Banks and all the provisions of such agreements, including, without limitation, the termination and fee provisions, shall remain in full force and effect. Except as otherwise set forth herein, the Debtors and the Banks may, without further order of the Court, agree and implement changes to the Cash

Management System and procedures in the ordinary course of business, including the opening and closing of Bank Accounts as permitted by this Order.

16. Notwithstanding anything to the contrary contained in the Motion or this Order, any payment to be made and any relief or authorization granted hereunder shall be limited by, and shall be subject to, the requirements imposed on the Debtors in the Final DIP Order, including, for the avoidance of doubt, the Approved DIP Budget. To the extent of any conflict (but solely to the extent of such conflict) between the terms of this Order and the terms of the Final DIP Order, the terms of the Final DIP Order will govern.

17. Immediately upon entry of this Final Order, each of the Banks at which Bank Accounts subject to automatic transfers or “sweeps” as part of the Cash Management System are maintained are authorized and directed, solely pursuant to the written direction of the Debtors (email sufficient), without further order of this Court, to execute transfers or sweeps without regard to whether the funds swept and/or transferred include funds deposited prior to the Petition Date, as directed by the Debtors. Until further order of the Court, (a) Wells Fargo shall grant the Debtors unrestricted access to and control of the Bank Accounts maintained at Wells Fargo Bank, National Association (“Wells Fargo,” and such accounts, the “Wells Fargo Bank Accounts”) and any funds on deposit therein, notwithstanding any deposit account control agreements with respect to such Wells Fargo Bank Bank Accounts; and (b) CIBC shall grant the Debtors unrestricted access to and control of the Bank Accounts maintained at CIBC Bank USA (“CIBC,” and such accounts, the “CIBC Bank Accounts”) and any funds on deposit therein, notwithstanding any deposit account control agreements with respect to such CIBC Bank Accounts; and (c) each of Wells Fargo and CIBC shall take direction with respect to the Wells Fargo Bank Accounts or the CIBC Bank Accounts, respectively, solely and exclusively from the Debtors, except that Wells Fargo and/or

CIBC may provide balance statements for the Wells Fargo Bank Accounts and the CIBC Bank Accounts, respectively, to MidCap and OHI Mezz Lender, LLC (“OHI,” and, together with MidCap, collectively, the “Agents”) pursuant to any applicable contract(s) among Wells Fargo, certain Debtors and the Agents (or MidCap, solely) or CIBC, certain Debtors and the Agents (or MidCap, solely), as applicable.

18. Nothing in the Motion or this Order or the relief granted (including any actions taken or payments made by the Debtors pursuant thereto) shall be construed as (a) authority to assume or reject any executory contract or unexpired lease of real property, or as a request for the same; (b) an admission as to the validity, priority, or character of any claim or other asserted right or obligation, or a waiver or other limitation on the Debtors’ ability to contest the same on any ground permitted by bankruptcy or applicable non-bankruptcy law; (c) a promise or requirement to pay any claim or other obligation; (d) granting third-party-beneficiary status, bestowing any additional rights on any third party, or being otherwise enforceable by any third party.

19. Nothing in the Motion or this Order shall be construed to (a) create or perfect, in favor of any person or entity, any interest in cash of a Debtor that did not exist as of the Petition Date or (b) alter or impair the validity, continuation, priority, enforceability, or perfection of any security interest or lien, in favor of any person or entity, that existed as of the Petition Date.

20. The Court finds and determines that the requirements of Bankruptcy Rule 6003 are satisfied and that the relief requested in the Motion is necessary to avoid immediate and irreparable harm.

21. Notice of the Motion as provided therein shall be deemed good and sufficient notice of such Motion and the requirements of Bankruptcy Rule 6004(a), the Local Rules, and the Complex Case Procedures are satisfied by such notice.

22. Notwithstanding Bankruptcy Rule 6004(h), this Order shall be effective and enforceable immediately upon entry hereof.

23. All time periods set forth in this Order shall be calculated in accordance with Bankruptcy Rule 9006(a).

24. The Debtors are authorized to take all actions necessary to implement the relief granted in this Order.

25. The Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
