DECLARATION OF JENNIFER WESTWOOD, ON BEHALF OF KURTZMAN CARSON CONSULTANTS LLC D/B/A VERITA GLOBAL REGARDING SOLICITATION AND TABULATION OF BALLOTS CAST ON DEBTORS' SECOND AMENDED COMBINED DISCLOSURE STATEMENT AND JOINT CHAPTER 11 PLAN OF REORGANIZATION

I, Jennifer Westwood, hereby declare as follows under penalty of perjury that the following is true and correct to the best of my knowledge, information, and belief:

- 1. I am a Senior Consultant of Kurtzman Carson Consultants LLC d/b/a Verita Global ("Verita") located at 222 N. Pacific Coast Highway, 3rd Floor, El Segundo, CA 90245. I am over the age of 18 years and am not a party to the above-captioned action. I do not have a direct interest in the above-captioned chapter 11 cases and should be considered an impartial party.
- 2. I submit this declaration (the "<u>Declaration</u>") with respect to the solicitation and tabulation of votes cast on the *Debtors' Second Amended Combined Disclosure Statement and Joint Chapter 11 Plan of Reorganization* [Docket No. 481] (as may be amended, supplemented,

or modified from time to time, the "<u>Plan</u>").² Except as otherwise indicated herein, all facts set forth herein are based upon my personal knowledge or my review of relevant documents. I am authorized to submit this Declaration on behalf of Verita. If I were called upon to testify, I could and would testify competently as to the facts set forth herein.

- 3. In accordance with the (a) Order Authorizing the Retention and Employment of Kurtzman Carson Consultants LLC as Claims, Noticing, Solicitation, and Administrative Agent Effective as of the Petition Date [Docket No. 43] (the "Verita Retention Order") and (b) Order (I) Conditionally Approving Disclosure Statement, (II) Scheduling Combined Hearing for November 14, 2024 at 9:30 a.m. (Prevailing Eastern Time), (III) Establishing Procedures for Solicitation and Tabulation of Votes on Plan, (IV) Approving Certain Forms and Notices, and (V) Granting Related Relief [Docket No. 480] (the "Solicitation Procedures Order"), Verita was appointed as the Debtors' administrative advisor and authorized to assist the Debtors with, inter alia, soliciting, receiving, reviewing, determining the validity of, and tabulating Ballots cast on the Plan by Holders of Claims in the Voting Classes (as defined herein). Verita and its employees have considerable experience in soliciting and tabulating votes to accept or reject proposed chapter 11 plans, including plans of reorganization.
- 4. As set forth in the Solicitation Procedures Order, the Debtors established September 27, 2024 as the record date (the "<u>Voting Record Date</u>") for determining which Holders of Claims within the Voting Classes were entitled to vote on the Plan. Under the Plan, only Holders of Claims in the following Classes (collectively, the "<u>Voting Classes</u>") were entitled to vote to accept or reject the Plan:

- 5. The procedures for the solicitation and tabulation of votes on the Plan are outlined in the Solicitation Procedures Order. Verita was instructed by the Debtors to solicit, review, determine the validity of, and tabulate Ballots submitted with respect to the Plan by the Holders of Claims in the Voting Classes in accordance with the Solicitation Procedures Order. In addition, Verita consulted with the Debtors and their counsel, as appropriate, to ensure compliance with the Solicitation Procedures Order. I supervised the solicitation and tabulation performed by Verita's employees.
- 6. In accordance with the Solicitation Procedures Order, Verita caused to be served the (a) Combined Hearing Notice on the parties listed in the creditor matrix and all other parties entitled to receive such notice pursuant to the Solicitation Procedures Order; (b) Solicitation Packages on Holders of Claims in the Voting Classes as of the Voting Record Date; and (c) Non-Voting Packages on Holders of Claims and Interest in Class 1 (Other Secured Claims), Class 2 (Other Priority Claims), Class 7 (Intercompany Claims), Class 8 (Existing Equity Interests), and Class 9 (Intercompany Interests). Verita filed the *Certificate of Service of Solicitation Materials* on November 4, 2024 [Docket No. 619].
- 7. Verita tabulated ballots received based on the following rules from the Solicitation Procedures Order with respect to voting amount:
 - a. if a claim is partially liquidated and partially unliquidated, such claim will be allowed for voting purposes only in the liquidated amount;

- b. if a scheduled or filed claim has been paid, such claim will be disallowed for voting purposes;
- c. the holder of a timely-filed proof of claim that is unliquidated, contingent, disputed, and/or unknown amount (as determined on the face of the claim or after reasonable review by the Debtors or the Claims and Noticing Agent), including for the avoidance of doubt, any litigation or tort claim that has not proceeded to final judgment or settlement, and is not the subject of an objection as of the Claims Objection Deadline, is entitled to vote in the amount of \$1.00;
- d. timely-filed proofs of claim based on trade, litigation, or tort claims that arose at one of the Debtors' facilities shall be classified in Class 6A (OpCo General Unsecured Claims), Class 6B (DivestCo General Unsecured Claims), or Class 6C (Joint & Several OpCo General Unsecured Claims), depending on the nature of the claim and/or the facility at which the claim arose; provided, however, creditors with timely proofs of claim against both an OpCo Debtor and a DivestCo Debtor (each as defined in the Plan) shall be entitled to vote in Class 6A (OpCo General Unsecured Claims), Class 6B (DivestCo General Unsecured Claims), and/or Class 6C (Joint & Several OpCo General Unsecured Claims) subject to the provisions contained herein;
- e. timely-filed proofs of claim based on litigation or tort claims will be presumed to be unliquidated, contingent, and/or disputed unless sufficient supporting documentation of a final judgment or settlement was attached to the timely filed proof of claim, as determined by the Debtors or the Claims and Noticing Agent, and such unsupported claims shall be entitled to vote in the amount of \$1.00;
- f. if a proof of claim has been amended by a later-filed proof of claim that is filed on or prior to the Voting Record Date (as defined below), the later filed amending claim will be entitled to vote in a manner consistent with these tabulation rules, and the earlier filed claim will be disallowed for voting purposes, regardless of whether the Debtors have objected to such amended claim; and
- g. proofs of claim for \$0.00 are not entitled to vote.
- 8. Each Ballot received by Verita was date-stamped upon receipt, scanned (if submitted on paper), assigned a ballot number, entered into Verita's voting database, and processed in accordance with the Solicitation Procedures Order.

- 9. Verita received, reviewed, determined the validity of, and tabulated the Ballots submitted to vote on the Plan. In order for a Ballot to be counted as valid, the Ballot must have been (a) properly completed in accordance with the Solicitation Procedures Order, (b) executed by the relevant holder or such holder's authorized representative, (c) returned to Verita via an approved method of delivery as set forth in the Solicitation Procedures Order, and (d) received by Verita by no later than 4:00 p.m. (Eastern Time) on November 4, 2024 (the "Voting Deadline"). Pursuant to paragraph 20 in the Solicitation Procedures Order, the Voting Deadline was extended through November 6, 2024 for Class 3(ABL Claims) and Class 5 (Go-Forward Trade Claims).³
- 10. All validly executed Ballots cast by Holders of Claims in the Voting Classes received by Verita on or before the Voting Deadline were tabulated as outlined in the Solicitation Procedures Order. A true and correct copy of the final tabulation of the votes cast by Holders of Claims in the Voting Classes through timely and properly completed Ballots received by Verita on or before the Voting Deadline is attached hereto as **Exhibit A**.⁴
- 11. A report of all Ballots received and included in the final tabulation prepared by Verita is attached hereto as **Exhibit B**.
- 12. A report of all Ballots received but not included in the final tabulation prepared by Verita and the reasons for exclusion of such Ballots is attached hereto as **Exhibit C**.

As provided in the Ballot for the Holder of Claims in Class 5 (Go-Forward Trade Claims), such Holder could either vote to accept the proposed treatment for Class 5, or could vote to accept or reject the Plan in Class 6A (OpCo General Unsecured Claims) or Class 6B (DivestCo General Unsecured Claims), as applicable. Because the only Holder in Class 5 (Go-Forward Trade Claims) voted to accept the Plan in Class 6A and Class 6B, there were no voting creditors in Class 5.

The dollar figures reflected in the tabulation summaries attached hereto as **Exhibits A-C** represent the aggregate dollar amount of claims filed across Debtor entities by a single creditor, rather than the dollar amount of individual filed or scheduled claims for such creditor. Such aggregation was approved in the Solicitation Procedures Order and was completed for solicitation and voting tabulation purposes only, but may not be reflective of actual claim figures for distribution purposes.

13. Verita reviewed and documented which holders of Claims elected to opt out of the Third-Party Release. A report of all Holders who elected to opt out of the Third-Party Release is attached hereto as **Exhibit D**. For the avoidance of doubt, this Declaration does not certify the validity or enforceability of any opt-out elections received, including those reported on **Exhibit D**, but rather is providing these opt-out election results for reporting and informational purposes only.⁵

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing information concerning the distribution, submission, and tabulation of Ballots in connection with the Plan is true and correct to the best of my knowledge, information, and belief.

As reflected on Exhibit D attached hereto, certain Holders of Claims who voted to accept the Plan also opted out of the Third-Party Release. The inclusion of such opt-out elections on Exhibit D does not modify the Plan, nor does it mean that such Holders who voted to accept and opted out are not "Releasing Parties" under the Plan.
