AGREED ORDER GRANTING MOTION TO ALLOW LATE FILED CLAIM BY KELLY FEEKO, AS EXECUTRIX OF THE ESTATE OF RICHARD J. REILLY

Upon the *Motion to Allow Late Filed Claim* [D.I. 821] filed January 28, 2025 (the "Motion")² filed by Kelly Feeko, as the Executrix of the Estate of Richard J. Reilly ("Movant"), seeking entry of an Order allowing the late filing of a Proof of Claim, pursuant to 11 U.S.C. §§105, 501, 502 and Fed. R. Bankr. P. 3003(c) and 9006(b)(1); and the Court having jurisdiction over the Motion pursuant to 28 U.S.C. §§ 1334 and 157(b) and the Motion being a core matter pursuant to

28 U.S.C. § 157(b)(2); and the Court having found that venue of this proceeding and the Motion in this District is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and it appearing that the Motion was duly served on all creditors and parties in interest; and the GUC Trustee having no objection to entry of this Order; and the Movant having filed a notice setting the Motion for hearing on July 10, 2025; and after due deliberation thereon; and good and sufficient cause appearing therefor, it is hereby ORDERED that:

- 1. The Motion is GRANTED as set forth herein.
- 2. Kelly Feeko, as executrix of the Estate of Richard J. Reilly, is hereby authorized to file a general unsecured unliquidated proof of claim (the "Feeko Claim") against Pavilion at St. Luke Village Facility Operations, LLC d/b/a The Pavilion at St. Luke Village (Case No. 24-55623) ("Pavilion").
- 3. The Feeko Claim shall be deemed timely filed and shall be treated in accordance with, and subject to the provisions of, the Plan, except as set forth herein.
- 4. Any recovery on account of the Feeko Claim shall be limited to Pavilion's available insurance in accordance with such insurance policy's governing terms. The GUC Trustee shall not make a distribution in cash (or cash equivalents) on account of the Feeko Claim.
- 5. The GUC Trustee's right to object to the Feeko Claim on any other grounds apart from timeliness is hereby preserved.
- 6. The Court shall retain jurisdiction with respect to any matters, claims, rights or disputes arising from or relating to the implementation of this Order.
- 7. Counsel shall serve a copy of this Order within three (3) days of entry on the docket and promptly thereafter file a certificate of service evidencing the method and manner of service.
