P. 3003(c) and 9006(b)(1); and the Court having jurisdiction over the Motion pursuant to 28 U.S.C. §§ 1334 and 157(b) and the Motion being a core matter pursuant to 28 U.S.C. § 157(b)(2); and the Court having found that venue of this proceeding and the Motion in this District is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and it appearing that the Motion was duly served on all creditors and parties in interest; and the GUC Trustee having no objection to entry of this Order; and the Movant having filed a notice setting the Motion for hearing on August 7, 2025; and after due deliberation thereon; and good and sufficient cause appearing therefor, it is hereby ORDERED that:

- 1. The Motion is GRANTED as set forth herein.
- 2. Love Browne, as administrator of the estate of Jubelee Browne, is hereby authorized to file a general unsecured unliquidated proof of claim (the "Browne Claim") against Debtor Williamsburg Facility Operations, LLC (Case No. 24-55771) ("Williamsburg").
- 3. The Browne Claim shall be deemed timely filed and shall be treated in accordance with, and subject to the provisions of, the Plan, except as otherwise to the extent set forth herein.
- 4. Any recovery on account of the Browne Claim shall be limited to Williamsburg's available insurance in accordance with such insurance policy's governing terms. The GUC Trustee shall not make a distribution in cash (or cash equivalents) on account of the Browne Claim.
- 5. The GUC Trustee's right to object to the Browne Claim on any other grounds apart from timeliness is hereby preserved.
- 6. Counsel shall serve a copy of this Order within three (3) days of entry on the docket and promptly thereafter file a certificate of service evidencing the method and manner of service.
- 7. The Court shall retain jurisdiction with respect to any matters, claims, rights or disputes arising from or relating to the implementation of this Order.
