## DEBTORS' MOTION FOR ENTRY OF FINAL DECREE CLOSING CERTAIN CHAPTER 11 CASES

LaVie Care Centers, LLC ("<u>LaVie</u>") and certain of its affiliates and subsidiaries, the debtors in the above-captioned chapter 11 cases (collectively, the "<u>Debtors</u>"), hereby move (the "<u>Motion</u>") for entry of a final decree, substantially in the form attached hereto as <u>Exhibit A</u> (the "<u>Final Decree</u>"), and respectfully represent as follows:

#### **RELIEF REQUESTED**

1. By this Motion, the Debtors seek entry of the Final Decree, closing the Chapter 11 Cases (as defined herein) other than the lead case of LaVie Care Centers, LLC, Case No. 24-55507 (PMB) (the "Lead Case"). A list of the Chapter 11 Cases that the Debtors propose to close (collectively, the "Affiliate Cases") is attached hereto as **Exhibit B**.

## **JURISDICTION AND VENUE**

2. The United States Bankruptcy Court for the Northern District of Georgia (the "Court") has jurisdiction to consider the Motion pursuant to 28 U.S.C. §§ 157 and 1334. This is a

core proceeding under 28 U.S.C. § 157(b). Venue of these cases and the Motion in this District is proper under 28 U.S.C. §§ 1408 and 1409.

3. The legal predicates for the relief requested herein are section 350(a) of chapter 11 of title 11 of the United States Code (the "Bankruptcy Code"), Rule 3022 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), and *General Order 26-2019, Procedures for Complex Chapter 11 Cases*, dated February 6, 2023 (the "Complex Case Procedures").

#### **BACKGROUND**

#### I. The Chapter 11 Cases

- 4. On June 2, 2024 (the "<u>Petition Date</u>"), each Debtor commenced a case by filing with the Court a petition for relief under chapter 11 of the Bankruptcy Code (collectively, the "<u>Chapter 11 Cases</u>"), which are being jointly administered for procedural purposes only.
- 5. On June 13, 2024, the Office of the United States Trustee for Region 21, Atlanta Division (the "<u>U.S. Trustee</u>") appointed an official committee of unsecured creditors (the "<u>Committee</u>"). *See* Docket No. 112. To date, no chapter 11 trustee or examiner has been appointed in the Chapter 11 Cases.

## II. The Plan of Reorganization

6. On November 14, 2024, the Court held a hearing on confirmation of the Debtors' proposed chapter 11 plan (the "Confirmation Hearing"). On December 5, 2024, the Court entered the Findings of Fact, Conclusions of Law, and Order Approving on Final Basis and Confirming Debtors' Modified Second Amended Combined Disclosure Statement and Joint Chapter 11 Plan of Reorganization [Docket No. 735] (the "Confirmation Order"), confirming the Debtors' Modified Second Amended Combined Disclosure Statement and Joint Chapter 11 Plan of Reorganization [Docket No. 730] (the "Plan"). As part of confirming the Plan, the Court also

entered the Memorandum Decision on Opt Out Third-Party Releases Included in Debtors' Joint Second Amended Plan of Reorganization [Docket No. 736] (the "Confirmation Opinion"). The Plan became effective on June 1, 2025 (the "Effective Date"). See Docket No. 1016.

#### BASIS FOR RELIEF REQUESTED AND APPLICABLE AUTHORITY

7. Article XVI.I of the Plan provides that:

On or as soon as practicable after the Effective Date, the Reorganized Debtors shall file with the Bankruptcy Court all documents required by Bankruptcy Rule 3022 and any applicable order necessary to close the Chapter 11 Cases except for the Lead Case, which shall remain open pending the full administration of the GUC Trust. Promptly thereafter, the GUC Trustee shall be responsible and deemed authorized to file with the Bankruptcy Court all documents required to close the Lead Case.

Plan, Art. XVI.I. As set forth below, the Debtors believe that the Affiliate Cases have been fully administered and, accordingly, seek to close the Affiliate Cases as required under the Plan.

- 8. Moreover, Bankruptcy Code section 350(a) provides that "[a]fter an estate is fully administered and the court has discharged the trustee, the court shall close the case." 11 U.S.C. § 350(a). Bankruptcy Rule 3022, which implements Bankruptcy Code section 350, further provides that "[a]fter an estate is fully administered in a chapter 11 reorganization case, the court, on its own motion or on motion of a party in interest, shall enter a final decree closing the case." Fed. R. Bankr. P. 3022.
- 9. Although the term "fully administered" is not defined in the Bankruptcy Code, the Bankruptcy Rules, or the Local Bankruptcy Rules, the Advisory Committee Note to Bankruptcy Rule 3022 (the "Advisory Committee Note") sets forth the following non-exclusive factors to be considered in determining whether a case has been fully administered:
  - (a) whether the order confirming the plan has become final;
  - (b) whether deposits required by the plan have been distributed;

- (c) whether the property proposed by the plan to be transferred has been transferred;
- (d) whether the debtor or the successor of the debtor under the plan has been assumed the business or the management of the property dealt with by the plan;
- (e) whether payouts under the plan have commenced; and
- (f) whether all motions, contested matters, and adversary proceedings have been finally resolved.

Fed. R. Bankr. P. 3022, Advisory Comm. Note (1991). The Advisory Committee Note further indicates that the Court "should not keep the case open only because of the possibility that the court's jurisdiction may be invoked in the future." *Id.* Additionally, "a final decree closing the case after the estate is fully administered does not deprive the court of jurisdiction to enforce or interpret its own orders and does not prevent the court from reopening the case for cause pursuant to § 350(b) of the [Bankruptcy] Code." *Id.* In addition to the factors set forth in the Advisory Committee Note, courts have considered whether the plan of reorganization has been substantially consummated. *See, e.g., In re Gates Cmty. Chapel of Rochester, Inc.*, 212 B.R. 220, 224 (Bankr. W.D.N.Y. 1997) (considering substantial consummation as a factor in determining whether to close a case); *Walnut Assocs. v. Saidel*, 164 B.R. 487, 493 (E.D. Pa. 1994) (same).<sup>2</sup>

10. Courts generally use the six factors listed in the Advisory Committee Notes to determine whether an estate has been fully administered. *See, e.g., Ericson v. IDC Servs., Inc. (In re IDC Servs., Inc.)*, No. 97 CIV. 3081(TPG), Case No. 93 B 45922(SMB), 1998 WL 547085, at \*3 (S.D.N.Y. Aug. 28, 1998) ("[T]he approach that looks to the Advisory Note provides a more complete and flexible standard for determining when to close a chapter 11 case, and is therefore

Bankruptcy Code section 1101(2) defines substantial consummation as the: "(A) transfer of all or substantially all of the property proposed by the plan to be transferred; (B) assumption by the debtor or by the successor to the debtor under the plan of the business or of the management of all or substantially all of the property dealt with by the plan; and (C) commencement of distribution under the plan." 11 U.S.C. § 1101(2).

preferable."); *In re Kerley*, No. 09-43154-JJR11, 2011 WL 5330667, at \*1 (Bankr. N.D. Ala. Nov. 4, 2011) (citing factors). Courts also note that the factors are "plainly an aid or checklist that serves to insure that there is no unfinished business before the Court or in the case." *In re KlieglBros. UniversalElec. Stage Lighting Co.*, 238 B.R. 531, 542 (Bankr. E.D.N.Y. 1999); *see also In re Mold Makers, Inc.*, 124 B.R. 766, 768 (Bankr. N.D. Ill. 1990) ("[A]ll of the factors in the Committee Note need not be present before the Court will enter a final decree. Instead, the Committee Note and the factors therein merely serve as a guide in assisting the Court in its decision to close a case.").

- 11. Here, the Debtors submit that the Affiliate Cases will have been "fully administered" within the meaning of Bankruptcy Code section 350, making it appropriate for the Court to enter the Final Decree, leaving on ly the Lead Case open. In particular:
  - (a) the Confirmation Order has become final and is non-appealable;
  - (b) all payments required to be made pursuant to the Plan have been paid or provided for as of the Effective Date, or otherwise will be administered in connection with the Lead Case;
  - (c) the business and management of the property dealt with by the Plan has been assumed;
  - (d) all anticipated motions, contested matters, and adversary proceedings in the Affiliate Cases have been or will be resolved at or before the hearing on the Motion;
  - (e) all of the transactions contemplated by the Plan closed on the Effective Date; and
  - (f) the Plan has been substantially consummated within the meaning of Bankruptcy Code section 1101(2).
- 12. The Debtors do not anticipate that there will be further case activity in the Affiliate Cases, as all outstanding issues in these cases have been addressed or otherwise will be addressed in the Lead Case. *See* Fed. R. Bankr. P. 3022, Advisory Comm. Note (1991) ("The court should

not keep [a] case open only because of the possibility that the court's jurisdiction may be invoked in the future.").<sup>3</sup> Moreover, the Plan provides that the GUC Trust may proceed in the Lead Case as if the Affiliate Cases had not been closed. *See* Plan, Art. XIV.I. Thus, the Debtors submit that it is appropriate to close the Affiliate Cases at this time.

- 13. Article XVI.C of the Plan provides that the Reorganized Debtors shall file any post-confirmation reports for the quarterly period during which the Chapter 11 Cases are closed and pay any Statutory Fees (as defined in the Plan) to the U.S. Trustee in accordance with 28 U.S.C. § 1930 for such periods. *See* Plan, Art. XVI.C. Thereafter, until the Lead Case is closed or converted and/or the entry of a final decree, the GUC Trustee shall file post-confirmation quarterly reports for the Lead Case and the GUC Trust and shall pay Statutory Fees to the U.S. Trustee arising from distributions made by the GUC Trust as well as the minimum Statutory Fee (\$250) for the Lead Case. *Id.* The Debtors have filed the post-confirmation quarterly report for Q2 2025 and will work with the GUC Trustee to facilitate filing of the post-confirmation quarterly report for Q3 2025. The Debtors request that they be relieved of the obligation to file U.S. Trustee post-confirmation quarterly summary reports (and pay the associated quarterly fees) for the Affiliate Cases for time periods after entry of the Final Decree.
- 14. For the foregoing reasons, the Debtors respectfully request that the Court enter the Final Decree closing the Affiliate Cases.

In recognition that certain relief later requested in the Lead Case could affect multiple Debtors, the proposed Final Decree provides that all motions, notices, and other pleadings relating to any of the Debtors shall be filed, administered, and adjudicated in the Lead Case without the need to reopen the Affiliate Cases, and that the Court will retain jurisdiction over such matters.

#### **NOTICE**

15. The Debtors will provide notice of the Motion to: (a) the U.S. Trustee; (b) the Limited Service List; and (c) counsel to the GUC Trustee. The Debtors submit that no other or further notice is required.

#### NO PRIOR REQUEST

16. No previous request for the relief sought herein has been made to this or any other court.

## **CONCLUSION**

WHEREFORE, the Debtors respectfully request that the Court enter the Final Decree, substantially in the form attached hereto as Exhibit A, granting the relief requested herein and such other and further relief as may be just and proper.

3. The chapter 11 case of LaVie Care Centers, LLC, Case No. 24-55507 (PMB) (the "Lead Case"), shall remain open pending further order of the Court; and from and after the date of entry of this Order, all motions, notices, and other pleadings relating to any of the Debtors shall be filed, administered, and adjudicated in the Lead Case, without the need to reopen the Affiliate Cases, and the Court shall retain jurisdiction over such matters. The GUC Trustee shall be

responsible and deemed authorized to file with the Court all documents required to close the Lead Case following the full administration of the GUC Trust.

- 4. The Clerk of the Court shall enter this Order on the docket of each of the above-captioned chapter 11 cases, and each such docket shall be marked as "Closed."
- 5. The Debtors' post-confirmation quarterly summary report for the period from July 1, 2025 through September 30, 2025 (the "Third Quarter Summary Report") shall include information for the Affiliate Cases only through the date of entry of this Order; and the fees due and payable pursuant to 28 U.S.C. § 1930(a)(6)(A) and (B) in connection with the Affiliate Cases shall be calculated based on disbursements only through the date of entry of this Order. Subsequent post-confirmation quarterly summary reports shall contain information for the Lead Case only and shall be the responsibility of the GUC Trustee only.
- 6. Entry of this Order is without prejudice to (a) the rights of the Debtors or any party-in-interest to seek to reopen any of the Chapter 11 Cases for cause pursuant to Bankruptcy Code section 350(b), (b) the rights of the Debtors and/or the GUC Trustee to dispute, before the Court or in an appropriate non-bankruptcy forum, all proofs of claim that were filed against the Debtors in the Chapter 11 Cases to the extent permitted by the Plan and the Confirmation Order, or (c) the GUC Trust to bring and pursue claims, causes of action, or otherwise seek relief in connection with the GUC Trust Assets.
- 7. The Debtors are authorized to take all actions necessary to effectuate the relief granted in this Order in accordance with the Motion.
- 8. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation and enforcement of this Order.
