PLEASE TAKE NOTE that on July 1, 2025, **UnitedHealthcare Insurance Company** filed *UnitedHealthcare Insurance Company’s Motion for Allowance and Payment of Administrative Expense Claim* [Doc. 1108] (the “Motion”) with the United States Bankruptcy Court for the Northern District of Georgia (the “Bankruptcy Court”), which seeks the allowance and payment of \$324,611.89 as an administrative expense pursuant to section 503(b) of the Bankruptcy Code. The hearing was scheduled for August 7, 2025 at 9:30a.m. [Doc. 1111], and then rescheduled to August 29, 2025 at 10:00a.m. [Doc. 1167], September 20, 2025 at 9:30a.m.[Doc. 1200], and October 20, 2025 at 10:100a.m.[Doc. 1228].

PLEASE TAKE FURTHER NOTICE that by agreement of UnitedHealthcare and Debtors, the hearing on the Motion has been rescheduled and continued and the Court will hold a hearing on the **Motion on November 20, 2025 at 1:30 P.M.** before the **Honorable Paul M. Baisier** in **Courtroom 1202** of the **United States Bankruptcy Court for the Northern District of Georgia, 75 Ted Turner Drive, SW, Atlanta, Georgia 30303**, which may be attended in person or via the Court’s Virtual Hearing Room. **You may join the Virtual Hearing Room through the “Dial-in and Virtual Bankruptcy Hearing Information” link at the top of the homepage of the Court’s website, www.ganb.uscourts.gov, or the link on the judge’s webpage, which can also be found on the Court’s website.** Please also review the “Hearing Information” tab on the judge’s webpage for further information about the hearing.
