**GUC TRUSTEE’S SUPPLEMENTAL NOTICE OF  
DESIGNATION OF CLASS 6B CLAIMS**

**PLEASE TAKE NOTICE** that, on December 5, 2024, this Court confirmed the *Debtors’ Modified Second Amended Combined Disclosure Statement and Joint Chapter 11 Plan of Reorganization* [D.I. 730-1] (the “Plan”),<sup>2</sup> which, among other things, appointed Ryniker Consultants, LLC as trustee (the “GUC Trustee”) for the trust established on behalf of the Debtors and granted the GUC Trustee the authority to reconcile Claims in Class 6A, Class 6B, and Class 6C in accordance with the Plan and the GUC Trust Agreement.

**PLEASE TAKE FURTHER NOTICE** that, pursuant to the Plan, the GUC Trustee is required to review and sort all claims presented and place them in the appropriate class for distribution purposes. Section 1.206 of Article II.A of the Plan also provides that any General Unsecured Claim asserted against an OpCo Non-Facility Debtor (i.e., a Class 6A Claim) that the GUC Trustee determines is related to, arises out of, or is based upon transactions with, or acts or omissions of, a DivestCo Debtor must be treated as a DivestCo General Unsecured Claim (i.e., a Class 6B Claim).

**PLEASE TAKE FURTHER NOTICE** that, on October 20, 2025, the GUC Trustee filed its first notice of designation [D.I. 1240] (the “First Notice of Designation”) designating approximately 1,000 claims as Class 6B Claims in accordance with the Plan.

**PLEASE TAKE FURTHER NOTICE** that the GUC Trustee has further analyzed the General Unsecured Claims filed against OpCo Non-Facility Debtors and has determined that the claims identified on **Exhibit A** attached hereto (the “Designated Claims”) are General Unsecured

Claims that relate to, arise out of, or are based upon transactions with, or acts or omissions of, a DivestCo Debtor.

**PLEASE TAKE FURTHER NOTICE** that, as of the date hereof, the Designated Claims are hereby deemed to be DivestCo General Unsecured Claims (Class 6B Claims). As required by the Plan, each Designated Claim shall be treated and receive a single recovery, if any, solely as a DivestCo General Unsecured Claim in Class 6B, to the extent such Designated Claim is deemed an Allowed Claim under the Plan.

**PLEASE TAKE FURTHER NOTICE** that the GUC Trustee reserves all rights to amend the list of Designated Claims, including without limitation designating additional claims as Designated Claims or removing claims previously designated as Designated Claims. For the avoidance of doubt, nothing herein shall affect or alter the First Notice of Designation.

**PLEASE TAKE FURTHER NOTICE** that nothing herein shall be construed to deem any Designated Claim as an Allowed Claim under the Plan. Nothing herein impairs the GUC Trustee's right to object to any Designated Claim on any basis in accordance with the Plan, which is hereby preserved.
