1 **IT IS HEREBY ORDERED THAT:**

2 1. The Application is **GRANTED**.

3 2. The Official Committee of Unsecured Creditors is authorized to issue a subpoena
4 directed to Kathleen Hamlin, trustee of The Kathleen Hamlin Living Trust Dated July 2, 2008
5 (“Ms. Hamlin”) requiring Ms. Hamlin to (a) complete her production, by **January 9, 2026**, of
6 documents responsive to the Requests for Production (the “Requests”) set forth substantially in the
7 form attached as **Exhibit 1** to the Application; and (b) provide oral testimony on a mutually agreed
8 date no later than **January 30, 2026** (unless the Committee and Ms. Hamlin agree to extend that
9 date) relating to (i) Ms. Hamlin’s search for and possession, custody, or control of documents
10 responsive to the Requests; and (ii) the subject matter of the Requests.
