1           Upon consideration of the *First Interim Application of Hogan Lovells US LLP for*  
2 *Allowance and Payment of Compensation and Reimbursement of Expenses for the Period June 9,*  
3 *2025 Through September 30, 2025* [Dkt. No. 2905] (the “Fee Application”), filed by Hogan Lovells  
4 US LLP (“Hogan Lovells”), counsel to debtor and debtor in possession KS Mattson Partners, LP  
5 (“KSMP”) in the above-captioned bankruptcy cases, and upon the declaration filed in support of  
6 the Fee Application, and the notice of voluntary reduction [Dkt. No. 3901]; and this Court having  
7 jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, the *Order Referring*  
8 *Bankruptcy Cases and Proceedings to Bankruptcy Judges*, General Order 24 (N.D. Cal.), and the  
9 Bankruptcy Local Rules; and this Court having found that this is a core proceeding and that this  
10 Court may enter a final order consistent with Article III of the United States Constitution; and this  
11 Court having found that venue of this proceeding and the Fee Application in this district is proper  
12 pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that the relief requested in  
13 the Fee Application is in the best interests of KSMP’s estate, its creditors, and other parties in  
14 interest; and this Court having found that Hogan Lovells’ notice of the Fee Application having been  
15 given; and it appearing that no other notice need be given; and, upon the record and all of the  
16 proceedings had before the Court; and this Court having determined that the legal and factual bases  
17 set forth in the Fee Application establish just cause for the relief granted herein; and after due  
18 deliberation and sufficient cause appearing therefor,

19           **IT IS HEREBY ORDERED THAT:**

- 20           1. The Fee Application is granted as provided herein.
- 21           2. Hogan Lovells’ fees in the amount of \$3,231,236.46 and expenses in the amount of  
22 \$18,516.76 are hereby approved on an interim basis.
- 23           3. KSMP is authorized to pay Hogan Lovells a total of \$3,249,753.22.
