**REPLY OF GUC RECOVERY TRUSTEE TO ALBERTO COLT-SARMIENTO
 LETTER RESPONSE TO GUC RECOVERY TRUSTEE’S OBJECTION TO PROOF
 OF CLAIM NO. 2725 FILED BY ALBERTO COLT-SARMIENTO ON THE MERITS**

William A. Brandt, Jr., in his capacity as trustee (the “**GUC Recovery Trustee**”) of the JCK Legacy GUC Recovery Trust created under GUC Recovery Trust Agreement and the confirmed *First Amended Joint Chapter 11 Plan of Distribution of JCK Legacy Company and Its Affiliated Debtors and Debtors in Possession* [Docket No. 879], through undersigned counsel, files this reply to the response filed by Alberto Colt-Sarmiento (“**Mr. Colt-Sarmiento**”) to the *GUC Recovery Trustee’s Objection to Proof of Claim No. 2725 Filed By Alberto Colt-Sarmiento on the Merits* (the “**Objection**”) [Docket No. 1436].

REPLY

1. On July 15, 2022, the GUC Recovery Trustee received a letter response (the “**Response**”) from Mr. Colt-Sarmiento regarding the Objection. *See* Docket No. 1491. The Response seeks another extension of the response deadline because Mr. Colt-Sarmiento is still unable to access the library at the State of Washington Department of Corrections. Response at 1. Besides, Mr. Colt-Sarmiento suggests that the Court adjourn a hearing on the Objection indefinitely until he is able to complete research on his “second appeal” and “once done [he] can focus on this case again.” *Id.* at 2.

2. The GUC Recovery Trustee opposes any further extension and respectfully requests that the Court deny Mr. Colt-Sarmiento’s extension request and issue a ruling on the Objection regarding the merits of his claims. Mr. Colt-Sarmiento previously raised the issue of inability to access the Department of Correction’s library to research issues raised in the Objection and requested an extension of the previous response deadline: May 4, 2022. *See* Docket Nos. 1436, 1456, 1460. The GUC Recovery Trustee agreed to an extension and filed and served Mr. Colt-Sarmiento the *Amended Notice of Objection and Hearing*. *See* Docket No. 1463.

3. Almost four months has passed since Mr. Colt-Sarmiento received the Objection on or around March 28, 2022. A copy of the Certified Mail Receipt is attached as **Exhibit A**. Although a claimant is entitled to weigh in on a claim objection, Mr. Colt-Sarmiento’s claims completely lack merit such that additional time is not necessary. Mr. Colt-Sarmiento asserted claims against the News Tribune,² arguing that certain statements reported in the newspaper’s article about his criminal trial in which he was convicted of second-degree murder and other

charges, was defamatory and tortious. As detailed in the Objection, the News Tribune's reporting was true and is covered by the fair reporting privilege, and the tort claims fail as a matter of law.

4. In sum, the arguments made and evidence submitted are enough for the Court to issue a ruling without further delay.

CONCLUSION

WHEREFORE, the GUC Recovery Trustee respectfully requests that the Court: (a) sustain the Objection; and (b) grant such other and further relief as the Court deems just and proper.
