Letter Response to Alberto Colt-Sarmiento's Letter Requesting

Credentials

Dear Judge Wiles:

We represent Yale Scott Bogen, the appointed successor trustee (the "Successor GUC Recovery Trustee") of the JCK Legacy GUC Recovery Trust (the "GUC Recovery Trust") created under the confirmed Chapter 11 plan of distribution in the above-referenced case. *See* ECF No. 879.

On October 18, 2023, Alberto Colt-Sarmiento filed a letter requesting the Successor GUC Recovery Trustee's "license profile" and "entire credentials" (the "Letter Request") and, in support, Mr. Colt-Sarmiento stated that he "need[s] to know who [he] is dealing with." It thus appears that this submission by Mr. Colt-Sarmiento may be related to his earlier objection to the *Notice of Presentment of Motion for Entry of an Order Appointing Yale Scott Bogen as Successor GUC Recovery Trustee of the JCK Legacy GUC Recovery Trust (the "Presentment Motion")*. See ECF No. 1547. That objection was overruled by the Court by order dated July 7, 2023. See ECF No. 1548.

The Letter Request should be denied without further action because the Successor GUC Recovery Trustee's credentials were described in detail in the Presentment Motion, which was granted on June 23, 2023, see ECF Nos. 1541 and 1543, and because the Court has overruled Mr. Colt-Sarmiento's objection to the Presentment Motion. See ECF No. 1548. Further, Mr. Colt-Sarmiento is not entitled to additional information about the Successor GUC Recovery Trustee because he is not a beneficiary of the GUC Recovery Trust and therefore is not a party in interest herein.²

For the foregoing reasons, the Letter Request should be denied, and a proposed order for the Court's consideration and entry on the docket is attached as Exhibit C.

ORDER DENYING ALBERTO COLT-SARMIENTO'S LETTER REQUEST

On June 2, 2023, the GUC Recovery Trustee filed the Notice of Presentment of Motion for Entry of an Order Appointing Yale Scott Bogen as Successor GUC Recovery Trustee of the JCK Legacy GUC Recovery Trust (the "Motion") [ECF No. 1541]. The Motion was accompanied by a declaration by Mr. Bogen that detailed his credentials and qualifications for appointment as successor trustee. On June 23, 2023, the Court entered an order granting the Motion and appointing Mr. Bogen as successor trustee (the "Successor GUC Recovery Trustee") of the JCK Legacy GUC Recovery Trust (the "GUC Recovery Trust"). See ECF No. 1543. On July 5, 2023, the Clerk of the Court received an Objection to the Motion from Mr. Colt-Sarmiento [ECF No. 1547], which Objection was overruled by order dated July 7, 2023 [ECF No. 1548]. On October 18, 2023, Alberto Colt-Sarmiento filed a letter requesting the "license" and "entire credentials" of the Successor GUC Recovery Trustee (the "Letter Request"). See ECF No. 1563. Upon consideration of the Motion and the Letter Request, it is hereby ordered that the Letter Request is DENIED because (i) the declaration accompanied by the Motion describes in detail Mr. Bogen's qualifications to serve as the Successor GUC
