PLEASE TAKE NOTICE THAT on March 16, 2026, the Debtors filed the *Motion Pursuant To Sections 105(a), 349 And 1112(b) Of The Bankruptcy Code, For The Entry Of An Order (A) Approving The Dismissal Of The Debtors' Chapter 11 Cases And (B) Granting Certain Related Relief* (the "Structured Dismissal Motion"), which is scheduled for hearing on **April 15, 2026 at 10:00 a.m. (CT)** in Courtroom 7 North of the Thomas F.
