**CERTIFICATION OF JAMES LEE REGARDING  
THE SOLICITATION OF VOTES AND TABULATION OF  
BALLOTS CAST ON THE FIRST AMENDED JOINT CHAPTER 11 PLAN  
OF REORGANIZATION OF MODIVCARE INC. AND ITS DEBTOR AFFILIATES**

I, James Lee, declare, under the penalty of perjury, that the following is true and correct:

1. I am Vice President of Public Securities Services at Kurtzman Carson Consultants, LLC dba Verita Global (“*Verita*”), located at 222 North Pacific Coast Highway, Suite 300, El Segundo, California 90245. I am over the age of eighteen (18) years and not a party to the above-captioned action.

2. I submit this Voting Certification (the “*Certification*”) with respect to the solicitation of votes and the tabulation of Ballots cast on the *First Amended Joint Chapter 11 Plan of Reorganization of ModivCare Inc. and its Debtor Affiliates* [Docket No. 465] (the “*Plan*”).<sup>2</sup> Except as otherwise noted, all facts set forth herein are based on (a) my personal knowledge, (b) knowledge that I acquired from individuals under my supervision, including Sydney Reitzel,

Director of Corporate Restructuring Services, who assisted in the service and tabulation described herein, and (c) my review of the relevant documents. I am authorized to submit this Certification on behalf of Verita. If I were called to testify, I could and would testify competently as to the facts set forth herein.

3. On August 21, 2025, the United States Bankruptcy Court for the Southern District of Texas (the “**Court**”) entered the *Order Authorizing the Employment and Retention of Kurtzman Carson Consultants, LLC dba Verita Global as Claims, Noticing, and Solicitation Agent* [Docket No. 30] (the “**Retention Order**”), authorizing Verita’s retention as the claims, noticing, and solicitation agent of the Debtors. The Retention Order authorizes Verita to assist the Debtors with, among other things, (a) service of solicitation materials to the parties entitled to vote to accept or reject the Plan, and (b) tabulation of votes cast with respect thereto. As set forth in the application and declaration submitted in connection with the Retention Order, Verita and its employees have considerable experience in soliciting and tabulating votes to accept or reject proposed Chapter 11 plans.

#### **A. Service and Transmittal of Solicitation Packages and Related Materials**

4. Pursuant to the *Order (A) Approving Disclosure Statement; (B) Scheduling Confirmation Hearing; (C) Establishing Related Objection and Voting Deadlines; (D) Approving Related Solicitation Procedures, Ballots, and Release Opt-Out Forms and Form and Manner of Notice; (E) Approving Procedures for Assumption of Executory Contracts and Unexpired Leases; (F) Approving Equity Rights Offering Procedures and Related Materials; and (G) Granting Related Relief* [Docket No. 457] (the “**Initial Order**”) entered on October 6, 2025 and the *Amended Order (A) Approving Disclosure Statement; (B) Scheduling Confirmation Hearing; (C) Establishing Related Objection and Voting Deadlines; (D) Approving Related Solicitation*

*Procedures, Ballots, and Release Opt-Out Forms and Form and Manner of Notice; (E) Approving Procedures for Assumption of Executory Contracts and Unexpired Leases; (F) Approving Equity Rights Offering Procedures and Related Materials; and (G) Granting Related Relief* [Docket No. 552] (the “**Amended Order**”, and together with the Initial Order the “**Disclosure Statement Orders**”) entered on October 17, 2025, the Court established, among other things, certain solicitation and voting tabulation procedures with respect to the Plan (the “**Solicitation and Voting Procedures**”). Verita adhered to the Solicitation and Voting Procedures set forth in the Disclosure Statement Orders.

5. The Disclosure Statement Orders established October 6, 2025 as the record date for determining which Holders of Claims were entitled to vote on the Plan (the “**Voting Record Date**”). Pursuant to the Plan and the Solicitation and Voting Procedures, only Holders of Claims as of the Voting Record Date in the following classes were entitled to vote to accept or reject the Plan with respect to the applicable Debtors (collectively, the “**Voting Classes**”):

3	First Lien Claims
4	General Unsecured Claims
5	Subordinated Unsecured Notes Claims

No other classes were entitled to vote on the Plan.

6. In accordance with the Solicitation and Voting Procedures, Verita worked closely with the Debtors and their advisors to identify the Holders entitled to vote in the Voting Classes, and on October 23, 2025, Verita caused the (i) Solicitation Packages to be served on all known Holders of Claims entitled to vote on the Plan as of the Voting Record Date, and (ii) Equity Rights

Offering Materials to be served on Holders of Second Lien Notes Claims in Class 4 and Holders of Subordinated Unsecured Notes Claims in Class 5.<sup>3</sup>

7. On October 23, 2025, Verita also caused the appropriate Non-Voting Packages to be served, in lieu of a Solicitation Package, on all known Holders of Claims or Interests in Class 1 (Other Secured Claims), Class 2 (Other Priority Claims), and Class 9 (Existing Parent Equity Interests) as of the Voting Record Date. There were no Holders of Claims or Interests in the following Non-Voting Class: Class 7 (Subordinated Claims).

8. Furthermore, on October 23, 2025, Verita caused the Confirmation Notice to be served on the creditor matrix and all other parties required to receive such notice pursuant to the Disclosure Statement Orders.

9. In accordance with the Disclosure Statement Orders, neither Solicitation Packages, Non-Voting Packages, nor other Plan-related materials were distributed to holders of Claims or Interests in Class 6 (Intercompany Claims) or Class 8 (Intercompany Interests).

10. A certificate of service evidencing distribution of the foregoing materials was filed with the Court at Docket No. 801. During the voting period, Verita forwarded materials to parties whose packages were returned with a forwarding address. A supplemental certificate of service evidencing the foregoing was filed with the Court at Docket No. 816.

11. October 23, 2025, Verita posted links to the electronic versions of the Plan, the Disclosure Statement, the Amended Order, and the Confirmation Notice on the public access website at [www.veritaglobal.net/ModivCare](http://www.veritaglobal.net/ModivCare).

12. On October 22, 2025, the Confirmation Notice was published in *The New York Times*. An affidavit evidencing the foregoing was filed on November 3, 2025 [Docket No. 651].

**B. The Tabulation Process**

13. Verita worked closely with the Debtors' advisors to create a voting database reflecting the names and addresses of Holders of Claims and Interests, the classification of Claims and Interests, and voting amounts for the Voting Classes. In so doing, Verita relied on, among other things, the following information:

- a. the Debtors' Schedules of Assets and Liabilities;
- b. the claims information reflected on the register of filed proofs of claim, to identify and solicit holders of Claims and Interests in the Voting Classes;
- c. lender register from Paul Hastings LLP as counsel for the First Lien Agent as of the Voting Record Date to identify the holders of Class 3 (First Lien Claims) entitled to vote to accept or reject the Plan; and
- d. security position reports provided by the Depository Trust Company as of the Voting Record Date to identify the banks and brokerage firms of Class 4 (Second Lien Claims) and Class 5 (Subordinated Unsecured Notes Claims) whose Beneficial Holders are entitled to vote to accept or reject the Plan.

14. In accordance with the Solicitation and Voting Procedures, Verita received, reviewed, determined the validity of, and tabulated the Ballots submitted to vote on the Plan. Each Ballot submitted to Verita was date-stamped, scanned (if submitted on paper), assigned a Ballot number, entered into Verita's voting database, and processed in accordance with the Solicitation and Voting Procedures. To be included in the tabulation results as valid, a Ballot must have been (a) properly completed pursuant to the Solicitation and Voting Procedures, (b) executed by the relevant Holder entitled to vote on the Solicited Plan (or such Holder's authorized representative), (c) returned to Verita via an approved method of delivery set forth in the Solicitation and Voting Procedures unless the delivery method requirement was waived by the Debtors, and (d) received

by Verita on or before the Voting Deadline (*i.e.*, November 25, 2025 at 4:00 p.m. (prevailing Central Time)), which was established by the Amended Order.

15. All valid Ballots cast by Holders entitled to vote in the Voting Classes and received by Verita on or before the Voting Deadline or, in the case of any Ballots with deficiencies, to the extent such deficiencies were waived by the Debtors, were tabulated pursuant to the Solicitation and Voting Procedures.

### **C. Tabulation Results**

16. The final tabulation of votes cast by timely and properly completed Ballots received by Verita is attached hereto as **Exhibit A**. The detailed Ballot reports for all Voting Classes are attached hereto as **Exhibit A-1** through **Exhibit A-3**.

17. A report of the Ballots excluded from the final tabulation is attached hereto as **Exhibit B**, along with the reason for exclusion. In total, 97 Ballots out of a total of 1,179 Ballots received were excluded from the final vote tabulation.<sup>4</sup> Of these 97 Ballots, only 24 actually indicated a vote on the Plan (such Ballots, the “*Excluded Votes*”).<sup>5</sup> The Excluded Votes were all votes from holders of Class 4 General Unsecured Claims. With respect to the Excluded Votes, 22 of the 24 were votes to accept the Plan, and only 2 were votes to reject the Plan. Accordingly, even if these Excluded Votes were counted, Class 4 would still be an accepting Class and the acceptance rate from holders of General Unsecured Claims would not be materially different.

18. The chart<sup>6</sup> below shows that (a) the percentage, in number of General Unsecured Claimants who accepted the Plan, would go from 88.87% to 81.27% and (b) the percentage, in dollar amount of General Unsecured Claims who accepted the Plan, would remain at 58.22%.

#### **D. Opt-Out Election**

19. Verita reviewed and documented which holders of Claims and Interests elected to opt out of the Releases. A report of all Holders who elected to opt out of the Releases is attached hereto as **Exhibit C**. For the avoidance of doubt, this Voting Certification does not certify the validity or enforceability of any opt-out elections received, including those reported on **Exhibit C**, but rather is providing these opt-out election results for reporting and informational purposes only.

#### **E. Conclusion**

20. To the best of my knowledge, information, and belief, I declare under penalty of perjury that the foregoing information concerning the distribution, submission, and tabulation of Ballots in connection with the Plan is true and correct.
