**SUPPLEMENTAL DECLARATION OF MATT LAZZERI IN SUPPORT OF DEBTORS’
APPLICATION FOR ENTRY OF AN ORDER (A) AUTHORIZING THE RETENTION
AND EMPLOYMENT OF ERNST & YOUNG LLP AS TAX, CONSULTING,
ACCOUNTING AND VALUATION SERVICES PROVIDER TO THE
DEBTORS AND DEBTORS IN POSSESSION AS OF THE PETITION
DATE; AND (B) GRANTING RELATED RELIEF**

I, Matt Lazzeri, hereby declare pursuant to Rule 2014(a) of the Federal Rules of Bankruptcy Procedure (the “*Bankruptcy Rules*”) as follows:

1. I am a Partner of Ernst & Young LLP (“*EY LLP*”). I provide this supplemental declaration (the “*Supplemental Declaration*”) on behalf of EY LLP in support of the application (the “*Application*”) of the above-captioned debtors (the “*Debtors*”) to retain EY LLP as their tax, consulting, accounting and valuation services provider, effective as of August 20, 2025 (the “*Petition Date*”) [Docket No. 342]. This Supplemental Declaration supplements my declaration that was filed with this Court as Exhibit A to the Application on September 19, 2025 (the “*Initial Declaration*”).²

2. The facts set forth in this Supplemental Declaration are based upon my personal knowledge, upon information and belief, and upon client matter records kept in the ordinary course of business that were reviewed by me or professionals of EY LLP and EY US LLP or employees of other member firms of EYGL under my supervision and direction.

3. After the Initial Declaration was filed, Debtors' counsel provided EY LLP with updated PIILs. EY LLP caused the names of the newly-added Parties in Interest that were not included in Exhibit B to the Initial Declaration to be run through the Database. The disclosure schedule annexed hereto as **Schedule 1** lists the names of these newly-added Parties in Interest and whether a client engagement has been initiated in the Database during the last three years by EY LLP or any other EYGL member firm.

4. To the best of my knowledge, information and belief based on the information set forth in the Database, none of the services rendered to Parties in Interest by EY LLP or any other EYGL member firm have been in connection with the Debtors or these chapter 11 cases, except as otherwise stated herein or in the Initial Declaration.

5. EY LLP conducted a search to determine whether EY US LLP (but not any other member firm of EYGL) has paid any Party-Retained Professionals listed in the PIILs. In addition to the Party-Retained Professionals listed in paragraph 22 of the Initial Declaration, EY LLP has determined that EY US LLP has paid the following Party-Retained Professionals during the last three years for professional services: AlixPartners LLP; Hunton Andrews Kurth LLP; Lazard Freres & Co. LLC; Mercury Public Affairs, LLC; Polsinelli PC; PricewaterhouseCoopers LLP; and Schellman Compliance, LLC.

6. In Paragraph 34 of the Initial Declaration, I disclosed that certain Parties in Interest participate in EY LLP's and EY US LLP's Revolving Credit Program. In addition to the Parties

in Interest disclosed in Paragraph 34 of the Initial Declaration, Barclays Bank PLC also participates in EY LLP's and EY US LLP's Revolving Credit Program, and EY LLP and EY US LLP have borrowed long-term debt from Metropolitan Life Insurance Company (MetLife Inc).

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct to the best of my knowledge, information and belief.
