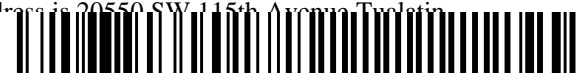

**NOTICE OF HEARING ON DEBTORS' MOTION FOR ENTRY  
OF AN ORDER AUTHORIZING (I) ABANDONMENT OR SALE OF  
REMAINING INVENTORY AND (II) GRANTING RELATED RELIEF  
("ABANDONMENT MOTION")**

**PLEASE TAKE NOTICE** that on June 9, 2025, June 10, 2025 and June 22, 2025 (collectively, the "Petition Date"), the above-captioned debtors and debtors-in-possession (collectively, the "Debtors") each filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code in the United States Bankruptcy Court for the District of New Jersey (the "Bankruptcy Court").

**PLEASE TAKE FURTHER NOTICE** that on October 4, 2025, the Debtors filed a *Motion For Entry of an Order Authorizing (I) Abandonment or Sale of Remaining Inventory and (II) Granting Related Relief* (the "Abandonment Motion") [Docket No. 909].

**PLEASE TAKE FURTHER NOTICE** that a hearing to consider approval of the Abandonment Motion has been scheduled for October 23, 2025, at 12:30 p.m. (the "Hearing"), or as soon thereafter as counsel may be heard.

**PLEASE TAKE FURTHER NOTICE** that, parties wishing to appear at the Hearing must register with the Court by submitting an e-mail to Chambers ([chambers\\_of\\_mbk@njb.uscourts.gov](mailto:chambers_of_mbk@njb.uscourts.gov)) indicating the name of the person appearing, their e-mail address, their affiliation, and whom they represent/interest in this case. If the request is approved, the participant will receive appropriate credentials and further instruction. **PLEASE TAKE FURTHER NOTICE** that objections, if any, to the relief requested in the Abandonment Motion shall: (a) be in writing; (b) state with particularity the basis of the objection; and (c) be filed with the Clerk of the Bankruptcy Court electronically by attorneys who regularly practice before the Bankruptcy Court in accordance with the General Order Regarding Electronic Means for Filing, Signing, and Verification of Documents dated March 27, 2002 (the "General Order") and the Commentary Supplementing Administrative Procedures dated as of March 2004 (the "Supplemental Commentary") (the General Order, the Supplemental Commentary and the User's Manual for the Electronic Case Filing System can be found at [www.njb.uscourts.gov](http://www.njb.uscourts.gov), the official website for the Bankruptcy Court) and, by all other parties-in-interest, on CD-ROM in Portable Document Format (PDF), and shall be served on such parties in accordance with the General Order and the Supplemental Commentary, so as to be actually received no later than **October 16, 2025** ("the Objection Deadline").
