Pursuant to Federal Rule of Bankruptcy Procedure 8009, the Official Committee of Unsecured Creditors (the "Committee") of the Roman Catholic Bishop of Oakland (the "Debtor") hereby submits (i) its counterstatement of the issues to be presented on appeal from the Order Granting Renewed Motion of the Official Committee of Unsecured Creditors to Lift the Automatic Stay to Permit Certain Plaintiffs' Personal Injury Claims to Proceed in State Court [Bankr. Dkt. 2168]; and (ii) its designation of additional items to be included in the record on appeal.

COUNTERSTATEMENT OF ISSUES ON APPEAL

The Committee hereby presents the following counterstatement of the issues on appeal:

- 1. Whether the bankruptcy court acted within its sound discretion in granting the Renewed Motion of the Official Committee of Unsecured Creditors to Lift the Automatic Stay to Permit Certain Plaintiffs' Personal Injury Claims to Proceed in State Court [Bankr. Dkt. 2093] (the "Motion").
- 2. Whether the bankruptcy court acted within its sound discretion in lifting the automatic stay under 11 U.S.C. § 362(d) and authorizing the Superior Court of the State of California, County of Alameda (the "State Court"), overseeing the "Northern California Clergy Cases" being administered under Judicial Council Coordination Proceeding (JCCP 5108), to release six cases commenced by survivors of sexual abuse (the "Survivors") against the Debtor for trial by jury, solely for purposes of liquidation, not collection against the Debtor.
- 3. Whether the Committee had standing to seek the relief requested in the Motion, where the Committee sought this relief, for the benefit of the estate and its creditors, to expedite the resolution of cases against the Debtor.
- 4. Whether the bankruptcy court acted within its sound discretion in determining that the Committee had "cause" to seek the relief requested in the Motion, where authorizing the State Court to allow cases to proceed will help the parties gain clarity on the value of Survivor claims, unlock the liability insurance assets, and encourage resolution of the Chapter 11 case.
