PLEASE TAKE NOTICE THAT a hearing will be held on **Wednesday, May 20, 2026, at 10:30 a.m.** (the "Hearing"), and will take place at the United States Bankruptcy Court, 1300 Clay Street, Oakland, California, before the Honorable William J. Lafferty, United States Bankruptcy Judge, to consider the *Debtor's First Omnibus Objection to Certain Amended, Duplicated, and Late Filed Claims* [Docket No. 2783] (the "Objection"), filed by The Roman Catholic Bishop of Oakland, a California corporation sole, and the debtor and debtor in possession (the "Debtor" or "RCBO") in the above-captioned chapter 11 bankruptcy case (the "Bankruptcy Case")



1 The Objection seeks an order (a) disallowing each proof of claim listed therein as they are either
2 amended, duplicated by another claim, or untimely and (b) granting relief from certain limitations of
3 Bankruptcy Rule 3007 and Local Rule 3007-1, as specified therein.

4 The Objection is based upon this Notice; the Objection; the declaration filed in support thereof;
5 any and all supplemental papers that may be filed by the Debtor; the papers on file in this bankruptcy case;
6 and on such arguments or evidence as may be presented at the hearing. Copies of the Objection and papers
7 filed in support thereof, and all pleadings and papers filed in this Bankruptcy Case, can be obtained from

17 **sought in the Objection must be in writing, filed with the Bankruptcy Court not later than seven (7)**
18 **days before the date set for the Hearing.** Any opposition must be filed in writing with Clerk of the
19 Bankruptcy Court at 1300 Clay Street, Suite 300, Oakland, California, 94612 (mailing address: P.O. Box
20 2070, Oakland, California, 94604) and must be served on counsel for the Debtor at the address listed
21 above. Unless a timely objection is filed, the Court may grant the relief requested in the Objection without
22 a hearing. **Failure to file and serve a timely objection may result in the waiver of any objection.**
