1 **PLEASE TAKE NOTICE THAT** a hearing will be held on **Wednesday, May 20, 2026,**
2 **at 10 a.m.** (the "Hearing"), and will take place at the United States Bankruptcy Court, 1300 Clay
3 Street, Oakland, California, before the Honorable William J. Lafferty, United States Bankruptcy
4 Judge, to consider the *Omnibus Objection of the Official Committee of Unsecured Creditors to*
5 *Amended, Duplicative, and Late-Filed Claims* [Dkt. No. 2829] (the "Objection"), filed by the
6 Official Committee of Unsecured Creditors (the "Committee") of The Roman Catholic Bishop of
7 Oakland appointed in the above-captioned chapter 11 bankruptcy case (the "Chapter 11 Case").

8 The Objection seeks an order (a) disallowing certain proofs of claim as either superseded
9 by amendment, duplicative of another claim, or untimely filed, and (b) granting relief from certain
10 limitations of Local Rule 3007-1, as specified therein.

11 The Objection is based on the facts and law set forth therein, ; the declaration filed in
12 support thereof; all supplemental papers that may be filed by the Committee; the papers on file in
13 this bankruptcy case; and on such arguments or evidence as may be presented at the hearing.
14 Copies of the Objection and papers filed in support thereof, and all pleadings and papers filed in
15 this Bankruptcy Case, can be obtained from the website maintained by the Debtor's claims and
16 noticing agent, Kurtzman Carson Consultants LLC, d/b/a Verita, at

18 **PLEASE TAKE FURTHER NOTICE THAT** the Hearing will be held in person in the
19 courtroom, provided that (1) hearings will be held in person but parties may attend by Zoom
20 Webinar/AT&T Teleconference; (2) additional information is available on Judge Lafferty's
21 Procedures page on the Court's website, which is <http://www.canb.uscourts.gov>; and
22 (3) information on how to attend the hearing by Zoom Webinar/AT&T Teleconference will be
23 included with each calendar posted under Judge Lafferty's Calendar on the court's website.

24 **PLEASE TAKE FURTHER NOTICE THAT** opposition, if any, to the granting of the
25 relief sought in the Objection must be in writing, filed with the Bankruptcy Court not later than
26 seven (7) days before the date set for the Hearing. Any opposition must be filed in writing with
27 the Clerk of the Bankruptcy Court at 1300 Clay Street, Suite 300, Oakland, California, 94612
28 (mailing address: P.O. Box 2070, Oakland, California, 94604) and must be served on counsel for
the Committee at the address listed above. Unless a timely objection is filed, the Court may grant
the relief requested in the Objection without a hearing. Failure to file and serve a timely objection
may result in the waiver of any objection.
