3 notice to inform the Court of its of voluntary reduction in fees and expenses requested in the *Eighth*
4 *Interim Fee Application of Lowenstein Sandler LLP for Allowance and Payment of Compensation*
5 *and Reimbursement of Expenses for the Period of September 1, 2025, Through December 31, 2025*

7 1. The Application was filed on February 24, 2026.

8 2. On March 31, 2026, David M. Klauder (the “**Fee Examiner**”) provided preliminary
