**ORDER SUSTAINING REORGANIZED DEBTORS' OBJECTION TO PROOF OF CLAIM NO. 1253 FILED BY FRANCHISE TAX BOARD**

Upon the objection, dated June 9, 2022 (the "**Objection**"),<sup>2</sup> of SpeedCast International Limited and its affiliates in the above-captioned chapter 11 cases (collectively, the "**Debtors**" and, as reorganized, the "**Reorganized Debtors**"), seeking entry of an order (this "**Order**") disallowing the Proof of Claim No. 1253 filed by Franchise Tax Board (the "**FTB Claim**") and granting related relief, all as more fully set forth in the Objection, and upon the *Declaration of Michael Healy in Support of the Reorganized Debtors' Objection to Proof of Claim No. 1253 Filed by Franchise Tax Board*; and after due deliberation,

3. This Court retains exclusive jurisdiction to hear and determine all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
