**NOTICE OF INTENT TO ADDUCE TESTIMONY FROM A
REMOTE LOCATION BY TELEPHONE AND VIDEO TECHNOLOGY**

1. This Notice is filed pursuant to BLR 9017-1(c)(2)(B) by SpeedCast International Limited and Maritime Communication Services, Inc., as reorganized debtors in the above-captioned chapter 11 cases (together with their reorganized debtor affiliates, the “**Reorganized Debtors**”).
2. This Notice pertains to the matters scheduled for hearing in these chapter 11 cases on March 25, 2026 at 9:30 a.m. (Central Time) (the “**Hearing**”).
3. The Debtors may call the following witness to testify at the Hearing by telephone and video technology:
 - (i) Clint Stewart, Chief Financial Officer, Reorganized Debtors.
4. **Any party in interest may object to this notice within three days of its filing on the Court’s docket. If no party in interest files a timely objection, the Court will allow the identified witness to give testimony remotely using the Court’s telephone and video technology. If the Court does not authorize the testimony to be taken remotely, the witness and the objector must appear in person at the Hearing.**
5. This Notice may be withdrawn or amended at any point prior to the Hearing.
