History

I filed [ECF 2226] 6/2/25 with this honorable court, it shows the date the notice was sent to me was 5-16-25 witch was the same day the debtor filed [ECF 2160] omnibus motion to enjoin plaintiffs from Prosecuting cases against released parties, specifically corizon and yescare in my case. I received notice of being enjoined 5/21/25 at this prison "see below".

7/2/25 I was at the hearing today. I was late signing in because the prison whom is also named a defendant in the civil suit giving rise to the complaint, wants to deny the participation of said hearing. The prison made me present evidence which took an hour to retrieve from the housing unit, and there were no documents addressed to me specifically and they can't interoperate as lawyers can. The prison asked for something from the court with my name at the top saying I had court. I was not allowed to use the dial pad to raise my hand so, I didn't get a chance to speak.

I wanted to say to this honorable court; I adopt the arguments made by the creditors against yes care attorneys in this court 7/2/25

1. I never received **notice** until 5/21/25 and I had cases in the county court being litigated by Yescare and Corison attorneys since 2022, they never once disclosed to me I was being medically treated by a bankrupt company or that there was a nationwide injunction. This whole process undermined my constitutional rights.
2. I never received solicitation to opt out, or vote on the plan
3. This debtor took a vote behind closed doors to alienate me from the promulgation process and subvert my constitutional right to due process.
4. The debtor was still providing medical service as a bankrupt company "this screams negligence" and being allowed by the conservators to harm wards of the state, who have no choice in the matter as of June 2024.
5. My name was on a list of creditors and I had no idea. All I know is I suffered permeate heart damage [Left atrial enlargement] due to neglecting to treat my A-Fib for 5 years now.

Please do not reward this behavior, **I'm asking this honorable court to order;**

- I. the clerk to send me documents pertaining to me. The prison doesn't allow me to use the E-File system to send things. **I am not on the E-File System, I can't send with it, so please do not use it to send stuff to me.**
- ~~II. **Reset the clock for me to engage in the opt out process.**~~
- III. **deny the debtors attempt to systematically release parties I have not even been given a fair opportunity to litigate or settle with.**

WHEREFORE, Petitioner respectfully moves this Honorable Court to RECONSIDER [ECF2160] WITH REGARDS TO SEAN ROGERS as noted above.

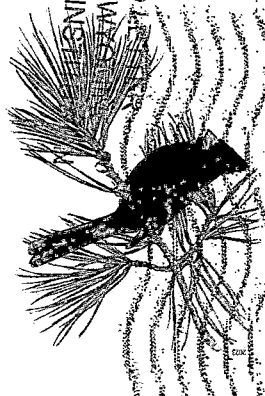
