**YESCARE’S NOTICE OF LIMITED WITHDRAW OF
MOTION TO ENJOIN AS TO CERTAIN PLAINTIFFS**

On May 16, 2025, CHS TX, Inc. d/b/a YesCare (“YesCare”) filed an Omnibus Motion to Enjoin, seeking to enjoin the plaintiffs listed in Exhibit A¹ to the Motion from prosecuting their cases against certain Released Parties and Former Corizon Employees. ECF Nos. 2160, 2160-1.
