NOTICE OF EXTENSION OF TIME FOR RILWAN AKINOLA TO RESPOND TO
YESCARE'S SUPPLEMENTAL MEMORANDUM IN SUPPORT OF OMNIBUS
MOTION TO ENJOIN
[Relates to Docket No. 2425]

On May 16, 2025, CHS TX, Inc. d/b/a YesCare ("YesCare") filed its *Omnibus Motion to Enjoin Plaintiffs from Prosecuting Cases Against Released Parties* [Docket No. 2160] (the "Omnibus Motion"), which was decided, in part, by the Court's order dated August 7, 2025 [Docket No. 2374] (the "Omnibus Order"). The Court withheld decision on the Omnibus Motion as to parties listed in Exhibit C to the Omnibus Order ("Exhibit C Plaintiffs"), including Rilwan Akinola. On August 27, 2025, YesCare filed a supplemental memorandum of law in support of the Omnibus Motion with respect to the Exhibit C Plaintiffs [Docket No. 2425]. By agreement of YesCare and Rilwan Akinola (together with YesCare, the "Parties"), the deadline for Rilwan Akinola to respond to YesCare's supplemental memorandum in support of the Omnibus Motion shall be September 22, 2025 (unless otherwise agreed or ordered). The Parties reserve all rights with respect to the relief requested by the Omnibus Motion as to the Exhibit C Plaintiffs.
