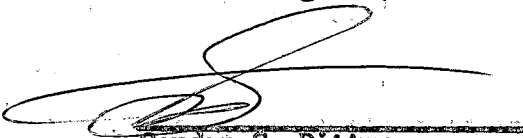

Greetings!!! I am writing to you in hope that this request will not fall on deaf ears. This Courthouse has violated my Constitutional rights several times over, and I would like for you to address this matter with Judge Lopez and your Court Clerks. It is my understanding that Judge Lopez, not wanting to deal with the hundreds and hundreds of prisoners and the many pleadings that they would be sure to file, did designate the Debtor in the above entitled cause as the entity to decide which prisoner pleadings would be heard by the Court in that cause. It is not possible for the Debtor to be neutral in that cause, and for the Judge to have gifted the Debtor with that power is no less than the Judge himself erecting a barrier between us and the court, in violation of our Constitutional rights of court access and due process. It is my belief that the Judge has granted YesCare's Omnibus motion without having heard my Objections, thereby depriving me my inalienable rights of court access and due process. I would like for Judge Lopez to hear my Objections, along with YesCare's Response, and then to alter or amend his Order with regard to YesCare's Omnibus Motion. Furthermore, I cannot get the Court Clerk(s) to send me any requested information. My latest request was for a copy of the Register of Actions so that I will be able to know how I have to appeal the granting of YesCare's Omnibus Motion. That was more than a month ago, and to date, I have not received said requested Register of Actions. I want for the Court Clerk(s) to send me any requested information which I am entitled, including the Register of Actions. I believe that the Courthouse is treating us prisoners in a manner that equates to prisoner prejudice/bias, and this is my attempt to resolve this matter in-house prior to taking other measures. Please, look into this matter, and keep me informed as to the progress and outcome of your inquiries.
