1. My name is Ikemefuna Chukwurah, first name pronounced as; E-kay-may-fu-na, last name pronounced as; Choo-koo-rah. I'm a 43 year old muslim African-American man who's been incarcerated since the age of 19 serving a life suspended all but 50 years sentence.
2. I'm also a personal injury claimant in the above mentioned chapter 11 Bankruptcy case.
3. On October 3rd, 2025 I received a deficiency notice from Tehum personal injury Settlement Trust stating that I Ikemefuna Chukwurah (Token# M4JXNCGK) must give them my social security number within 60 days or they'll deny my claim (see attached).
4. I've already specified to Tehum personal injury

Settlement Trust in my claim submission form earlier this year that I don't remember my Social Security number because I've been in prison for the past 23 years and I already gave them a copy of my Prison ID Card which contains my State Identification number aka SID#.

Maryland state law and Department of Public Safety and Correctional Services prohibits prisoners from possessing their vital records while physically incarcerated due to previous scandals, scams and identity theft that occurred years ago by prisoners and staff alike. Also by law, Maryland DPSCS staff are prohibited from giving away prisoners vital records information.

5. Maryland state prisoners are required by law to conduct all transactions within and beyond prison parameters with our state identification number aka (SID#) and Prison ID Card which Tehum Personal Injury Settlement Trust already has. (Once closer to release or upon release from prison, Maryland DPSCS does allow her prisoners to obtain their vital records info.).
6. My mom passed away 15 years ago, and as an only child I don't have anybody trustworthy in society to help me with this.
7. Today October 7th, 2025 at 9:30 am Eastern time, I talked to the supervisor for Tehum personal injury settlement trust over the phone. (Her name is Rachel) and she told me there's no law that mandates me to

give them my social security number, I respectfully ask the Court to Supoena the transcripts to my Phone Conversation with Rachel (Maryland Intelligence and Investigation Divison) maintains, manages and keep records of all Maryland state prisoners phone records, They're located in Savage - Maryland.

BELIEF I'M SEEKING,

I respectfully ask the Court to please Order Tehum Personal Injury Settlement Trust to process my claim for the following Reasons:

1. Tehum Personal Injury Settlement Trust did not list any other deficiency with my claim.
2. The Claimant Ikemefuna Chukwurah is unable to remember his social security number at this time because he's been in prison for 23 years and the state law & Rule at his location prohibit him from possessing it while in prison.
3. There's no law that requires a claimant to give his/her personal information to a company they sued for personal injury incurred due to their negligence, (Tehum Personal Injury Settlement Trust Supervisor even admits so over the phone & stated that it's Tehum Personal Injury Settlement Trust own Requirement).
4. The letter claimant received from Tehum Personal Injury Settlement Trust that demands

his Social Security number, does not even include the name and signature of the Supervisor or Administrator who sent him the Deficiency Notice.

5. The claimant Ihemefuna Chukwurah Fears Tehum Personal Injury Settlement Trust is vindictively and maliciously looking for any reason to deny his claim.
6. We live in a day and age where a lot of Companies mis-handle and even sell personal information of people they interacted with.

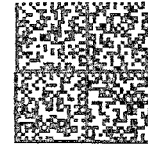

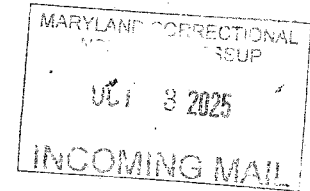

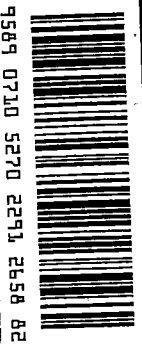
