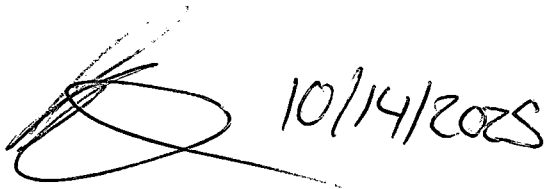

The accident occurred in AZ.

However, many community standard of care practices for T.B.I. aren't given here in AZ, or even In U.S.A. Like ongoing physical therapy, Or group therapy mental

health meetings where victims, of traumatic brain injury can group and discuss the various Marital, Social, Career, and Family consequences we experience.

I've had years of untreated withdrawal symptoms compounded by a cascade of health consequences I never had before the Motorcycle accident that took my Right prefrontal lobe, and I have the first 3D printed Prefrontal Prosthetic in Recorded History which was implanted by Surgeon Dr. Mussman.

Since Covid19, I've had a worsening autoimmune disorder where my feet and lower extremities are always pooling w blood and swollen.

I'm now off illicit Opioids as my medical records will show, and in recovery, and still experience a lack of Continuity of Care, no rational diagnostic testing to diagnose and treat this autoimmune issue, and many medical vendor staff whom cycle me thru, make me wait months, then diagnose me outside the scope of their practice, don't refer me to specialists that may help or treat me in the best hope of a recovery process that ensures me the safest path within myself and, around fellow members of the community I reside in. I ask that the community standard of care be awarded as outlined by founding Fathers.

Due to the judgments handed down in case#-23-90086, filed in TXSB on 11-14-24 (doc.1815-2) by the Honorable Christopher M Lopez, The Federal Rules Civil Procedure are emphatically tried and true regarding the Claims administration and Settlement compensation deemed just and Fit regarding a claimants Settlement Tier Award Designation. 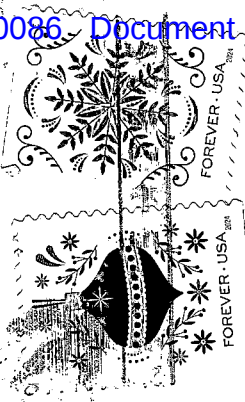
