Cover Letter

To Whom It May Concern,

My name is Tim Campbell, and I am the owner of Campbell Transport Services, LLC, a small transportation business. This letter is submitted in support of our claim regarding unpaid services provided to Tri Color Auto Group prior to its bankruptcy filing.

For the past several years, Campbell Transport Services worked closely with Tri Color Auto Group to transport vehicles from repossession companies, dealerships, and auctions. We were assured consistent work and relied on those representations in the normal course of operating our business. On or about September 5, 2025, we were abruptly notified that Tri Color Auto Group was closing its doors, as communicated to dealerships by Daniel Chu, CEO. This closure occurred without prior notice.

At the time operations ceased, Tri Color Auto Group had multiple outstanding unpaid invoices owed to our company, with some loads dating back as far as April 1, 2025. In the week leading up to the closure, we had already gone more than a week without receiving payment. On the Friday prior to the shutdown, we were dispatched a large number of vehicles scheduled for transport the following week. These loads were assigned directly to us by Tri Color Auto Group through Super Dispatch, and all required transport documentation had been properly completed and submitted.

Attached to this claim is an Excel spreadsheet detailing the unpaid loads, including vehicle information and agreed-upon rates, along with supporting transport documentation. All records demonstrate that these services were completed and that payment was due.

Campbell Transport Services is a small business, and the sudden loss of payment had a significant and immediate financial impact. As a direct result of the unpaid balances and abrupt termination of work, we were forced to sell two company vehicles and are currently in the process of selling a third. Additionally, we had to lay off three employees to remain operational.

We are not seeking any additional compensation beyond the amounts contractually owed to us for services rendered. We respectfully submit this claim for consideration and appreciate your time and attention to this matter.
