**SECOND SUPPLEMENTAL DECLARATION OF AVI ROBBINS  
IN SUPPORT OF THE RETENTION AND EMPLOYMENT OF  
PJT PARTNERS LP, AS INVESTMENT BANKER TO DEBTORS AND DEBTORS IN  
POSSESSION, EFFECTIVE AS OF THE PETITION DATE**

I, Avram Robbins, hereby declare:

1. I am a Partner at the Restructuring and Special Situations Group at PJT Partners LP (“PJT”), investment banker for United Site Services, Inc. and its debtor affiliates, as debtors and debtors-in-possession (collectively, the “Debtors”) in the above captioned chapter 11 cases.
2. On January 6, 2026, the Debtors filed the *Debtor’s Application for Entry of an Order Authorizing the Retention and Employment of PJT Partners LP as Investment Banker to the Debtors and Debtors in Possession Effective as of the Petition Date* (Docket No. 138) (the “Application”).<sup>2</sup>
3. In connection with the Application, I submitted an initial declaration (the “Initial Declaration”) describing PJT’s connections to the Debtors and other potential parties in interest (the “PII”). The Initial Declaration was attached to the Application as Exhibit B.

4. On January 20, 2026, I submitted my *Supplemental Declaration of Avi Robbins in Support of the Retention and Employment of PJT Partners LP, as Investment Banker to the Debtors and Debtors in Possession, Effective as of the Petition Date* [Docket No. 198] (the “Supplemental Declaration”).

5. I hereby submit this second supplemental declaration to provide additional information in respect to the connections of PJT to the PII.

6. My understanding is that, for each of the two-year periods from January 1, 2024 to December 31, 2024 and January 1, 2025 to December 31, 2025, PJT and its affiliates did not receive more than 1% of its revenue from any of PJT’s clients disclosed in the Initial Declaration or the Supplemental Declaration, other than Comcast Corporation during the period January 1, 2025 to December 31, 2025 (1.1%).

Pursuant to 28 U.S.C. § 1746, I declare under penalty of perjury that the foregoing is true and correct to the best of my information, knowledge, and belief.
