Unless otherwise stated in this Supplemental Declaration, I have personal knowledge of the facts set forth herein and, if called as a witness, I would testify thereto. Certain of the disclosures set forth herein relate to matters not within my personal knowledge, but rather within the knowledge of other attorneys and employees at Milbank and are based on information provided to me by them.

3. To the extent any information disclosed herein requires amendment or modification as additional information becomes available to Milbank, a supplemental declaration reflecting such amended or modified information will be promptly submitted to this Court.

#### **I. ADDITIONAL DISCLOSURES**

4. As set forth in the Original Declaration, Milbank has served as outside counsel to the Debtors since 2024 in connection with various corporate, financing, and restructuring matters. Due to Milbank’s prior representation of the Debtors, there were no negotiations regarding Milbank’s rates specific to the bankruptcy representation.
