NOTICE IS HEREBY GIVEN as follows:

On January 13, 2026, the above-captioned debtors and debtors in possession (the “**Debtors**”), filed the *Debtors’ Motion for Entry of an Order (I) Authorizing Employment and Payment of Professionals Utilized in the Ordinary Course of Business and (II) Granting Related Relief* [Dkt. No. 187] (the “**OCP Motion**”) with the United States Bankruptcy Court for the District of New Jersey (the “**Court**”).

On February 3, 2026, the Court entered the *Order (I) Authorizing Employment and Payment of Professionals Utilized in the Ordinary Course of Business and (II) Granting Related Relief* [Dkt. No. 265] (the “**OCP Order**”)² granting the relief requested in the OCP Motion. The initial OCP List is attached as Exhibit 1 to the OCP Order.

Pursuant to paragraph 2(c) of the OCP Order, the Debtors are authorized to file with the Court an OCP List Supplement with the name, address, type of service that the additional Ordinary Course Professional will provide, the applicable Monthly Fee Cap, and Aggregate Fee Cap. Within 30 calendar days of the later of (i) the filing of the OCP List Supplement and (ii) the date on which the additional Ordinary Course Professional begins providing postpetition services to the Debtors for which the additional Ordinary Course Professional seeks payment, the additional Ordinary Course Professional shall provide to the Debtors and Debtors’ counsel completed copies of the OCP Declaration and Retention Questionnaire.
