**DECLARATION IN SUPPORT OF EMPLOYMENT OF
PERKINS COIE LLP AS PROFESSIONAL
UTILIZED IN THE ORDINARY COURSE OF BUSINESS**

I, Kristine Wilson, pursuant to 28 U.S.C. § 1746, hereby declare that the following is true to the best of my knowledge, information, and belief.

1. I am a Partner of Perkins Coie LLP, located at 10885 NE 4th Street, Suite 700, Bellevue, WA 98004 (the “**Company**”).

2. United Site Services, Inc. and its affiliated debtors and debtors in possession (collectively, the “**Debtors**”) have requested that the Company provide limited legal services to the Debtors while they remain debtors in possession, specifically to be available to assist them in responding to any inquiries received from the City of Mount Vernon, Washington in connection with a pending land use permit application (“**Application**”) filed on behalf of United Site Services, Inc. before the Petition Date, and the Company has consented to provide such services.

3. The Company may have in the past performed and may in the future perform services, in matters unrelated to the Debtors’ Chapter 11 Cases, for persons that are parties in interest in these cases. As part of its customary practice, the Company is retained in cases, proceedings, and transactions involving many different parties, some of whom may represent or be claimants, employees of the Debtors, or other parties-in-interest in these cases. conflict check of all of the Debtors, its secured creditors, noteholders, its thirty largest unsecured creditors, and the parties adverse to the Debtors in connection with the Matter, the Company does not perform services for any such persons in connection with these cases, and the Company does not have any relationship with any such persons, their attorneys, or accountants that would be adverse to the Debtors or their estates.

4. Neither I, nor any principal of or professional employed by the Company has agreed to share or will share any portion of the compensation to be received from the Debtors with any other person other than the principals and regular employees of the Company.

5. Neither I, nor any principal of, or professional employed by the Company, insofar as I have been able to discover, holds or represents any interest adverse to the Debtors or their estates.

6. The Company believes that it is currently owed approximately \$6,500 on account of services rendered and expenses incurred prior to the Petition Date in connection with the Company's employment by the Debtors, the payment of which is subject to limitations contained in title 11 of the United States Code.

7. As of the date on which the Debtors commenced these Chapter 11 Cases, the Company was not party to an agreement for indemnification with the Debtors.

8. As of the date on which the Debtors commenced these Chapter 11 Cases, the Company was not party to an agreement that contains dispute resolution language. The Company used independent contractors or subcontractors in connection with providing services to the Debtors prior to the Petition Date. The name(s) of the independent contractor(s) or subcontractor(s) are as follows: David Marshall and Marieke Lacasse, GGLO; landscape architects, and Aaron Hartvigsen, PE, GeoEngineers, Inc., an engineer. The independent contractors or subcontractors assisted the Company in preparing the Application prior to the Petition Date. If the City of Mount Vernon has questions on the Application during the pendency of these Cases, the Company may seek their input in responding.

9. At any time during the period of its employment, if the Company discovers any facts bearing on the matters described herein, the Company will supplement the information contained in this Declaration.

10. I, or a representative of the Company, have read and am familiar with the requirements of the *Order (I) Authorizing Employment and Payment of Professionals Utilized in the Ordinary Course of Business and (II) Granting Related Relief*.
