- 1. There are no disciplinary proceedings pending against me.
- 2. On November 8, 2024 the Official Committee of Unsecured Creditors in the above captioned cases (the "Committee") filed the Application for Entry of an Order Authorizing the Retention and Employment of Willkie Farr & Gallagher LLP as Counsel to the Official Committee

of Unsecured Creditors Effective as of October 9, 2024 [Docket No. 395] (the "Application") to employ and retain Willkie as counsel for the Committee. In support of the Application, I filed the Declaration of Jennifer J. Hardy in Support of the Application for Entry of an Order Authorizing the Retention and Employment of Willkie Farr & Gallagher LLP as Counsel to the Official Committee of Unsecured Creditors Effective as of October 9, 2024 [Docket No. 395, Ex. C] (the "Initial Declaration").² On December 2, 2024, the Court entered the Order Authorizing the Retention and Employment of Willkie Farr & Gallagher LLP as Counsel to the Official Committee of Unsecured Creditors Effective as of October 9, 2024 [Docket No. 498] (the "Retention Order").

3. In connection with the Application and Retention Order, I submit this first supplemental declaration (the "<u>First Supplemental Declaration</u>") to provide additional disclosures in accordance with rules 2014(a) and 2016(b) of the Bankruptcy Rules and as required under the Retention Order. Unless otherwise stated in this Second Supplemental Declaration, I have personal knowledge of the facts set forth herein.

Additional Disclosures

- 4. As stated in the Initial Declaration, Willkie searched its electronic database of representations for connections to parties in interest in these Chapter 11 Cases. In connection with the filing of the Initial Declaration, Willkie searched all Potential Parties in Interest disclosed on Schedule 1 attached to the Initial Declaration (the "Original Potential Parties in Interest List"). This First Supplemental Declaration supplements Willkie's disclosures by supplementing the Original Potential Parties in Interest List in two ways:
 - *First*, since the filing of the Initial Declaration, Willkie received the names of additional entities that may be parties in interest in these Chapter 11 Cases that were not identified on

- the Original Potential Parties in Interest List. Such additional entities are set forth on Schedule A attached hereto (the "Supplemental Potential Parties in Interest").

The Sale Process Parties are included on the Supplemental Potential Parties in Interest.
- 5. The Supplemental Potential Parties in Interest have been searched by Willkie. **Schedule B** is a list of current and former clients affiliated with Potential Parties in Interest listed on the Supplemental Potential Parties in Interest. Except as disclosed below, Willkie does not have any connections to the Supplemental Potential Parties in Interest.
- 6. As disclosed on Schedule B, Willkie currently represents and/or has in the past represented Ara Advisors, LLC, Ara Partners, Arena, Atlas, Blue Torch, Blue Torch Capital, BP Products North America Inc., BPT&MSD, Brookfield Special Investments LLC, Canyon Capital, Cargill, CCI (Castleton Commodities International LLC), Citgo Petroleum Corporation, Citigroup Energy Inc. (CEI), Cresta, Donovan Ventures, Elliott, Fitzwalter, Fortress, Goldman (WSSS), Goldman Sachs, Hilco Trading LLC, HPS, HPS Investment Partners LLC, HPS Investment Partners, LLC, ISQ (I Squared Capital Advisors (US) LLC), King Street, Macquarie, Mercuria, NTR Partners LLC, Oak Hill Advisors, Oaktree, Oaktree Opportunities Fund XI & XII Holdings (Delaware), L.P., OMV Aktiengesellschaft, One Rock Capital Management, LLC, Oracle America, Inc., PBF Energy, Phicap Advisors / Squareone, Rev Innovations, Sculptor, Shell, Silver Point Capital, Silver Point Finance, LLC, Silverpoint, Sixth Street, Sounds Point Capital, SQ1 (Squareone Energy, LLC), Stewart Holdings, Stonepeak Partners LLC, Tailwater, Trafigura,

Except as otherwise disclosed herein, Willkie does not have any connections to the Sale Process Parties.

- 7. Willkie currently represents and has in the past represented Citgo Petroleum Corporation and/or certain subsidiaries and/or affiliates (collectively, "Citgo Petroleum") in various litigation and regulatory matters. Citgo Petroleum is listed in the "363 Sale Parties" category on the Supplemental Potential Parties in Interest List. Willkie has not represented, and will not represent, Citgo Petroleum in connection with the Debtors or these Chapter 11 Cases. Citgo Petroleum represented less than 1.8% of Willkie's revenues in each of 2021, 2022, and 2023. In 2024, Citgo Petroleum represented less than 1.0% of Willkie's revenues. Willkie intends to continue to represent Citgo Petroleum on matters wholly unrelated to the Debtors or these Chapter 11 Cases.
- 8. Except as provided above, each of the Sale Process Parties and the Supplemental Potential Parties in Interest listed in **Schedule B** attached hereto represented significantly less than 1% of Willkie's revenues in each of 2021, 2022, 2023, and 2024.
- 9. Willkie will continue to review its files periodically during the pendency of these Chapter 11 Cases to ensure that no conflicts or other disqualifying circumstances exist or arise. If any new relevant facts or relationships are discovered or arise, Willkie will use reasonable efforts

to identify such further developments and will promptly file an additional supplemental

declaration, as required by Bankruptcy Rule 2014(a).

10. By reason of the foregoing, I continue to believe that Willkie is eligible for retention

Code and the applicable Bankruptcy Rules and Local Rules.
