NOTICE OF TELEPHONIC AND VIDEO CONFERENCE HEARING ON EMERGENCY MOTIONS

In accordance with Sections A and I of the *Procedures for Complex Cases in the Southern District of Texas* (the "Complex Case Procedures"), the Hearing shall be held *virtually only*. The Court will use both audio and video communication. If you want to see the documents as presented to the Court and hear the proceeding you should be (i) dialed in through the audio system and (ii) logged into the Court's video via GoTo platform.

Video Communication

Any evidence and demonstrative exhibits will be offered by the Debtors from a remote location. Parties may participate in electronic hearings by use of an internet connection.
