**ORDER TRANSFERRING VENUE TO THE UNITED STATES  
BANKRUPTCY COURT FOR THE EASTERN DISTRICT OF VIRGINIA**

Upon the joint motion (the “Motion”)<sup>2</sup> of Chesterfield County, Virginia, and the Virginia Department of Environmental Quality to transfer the venue of these bankruptcy cases to the United States Bankruptcy Court for the Eastern District of Virginia pursuant to 28 U.S.C. § 1412 and Bankruptcy Rule 1014(a)(1); and this Court having jurisdiction over this matter pursuant to 28 U.S.C. § 1334; and this Court having found that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and this Court having found that the relief requested in the Motion is in the best interests of the Debtors’ estates, creditors, and other parties in interest; and this Court having found that the notice of the Motion and opportunity for a hearing on the Motion were appropriate under the circumstances and no other notice need be provided; and this Court having reviewed the Motion and having heard the statements in support of the relief requested therein at a hearing before this Court; and this Court having determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor,
