Tenent shall not engage in any activity in, on or about the Premises which constitutes a Reportable Use (as hereinafter defined) of Hazardous Substance shall include, but not be limited compliance in a timely memor (at Tenant's sole cost and expense) with all Applicable Law (as defined in Paragraph 6.3). This lease shall constitute consent for all activities reasonably contemplated by the permitted uses stated in Paragraph 1.6. "Reportable Use" shall mean (i) the installation or use of any above or below ground storage tank, (ii) the generation possession, storage, use, transportation, or disposal of a Hazardous Substance that requires a permit from, or with respect to which a report, notice, registration or business plan is required to be filed with, any governmental authority. Reportable Use shall also include Tenant's being responsible for the presence in, on or about the Premises of a Hazardous Substance with respect to which any applicable Law requires that a notice be given to persons entering or occupying the Premises or neighboring properties. Notwithatanding the foregoing. Tenant may, without Landford's prior consent, but in compliance with all Applicable Law, use any ordinary and cus

- (c) Indemnification. Tenant shall indemnify, protect, defend and hold Landlord, its agents, employees, lenders and ground Landlord, if any, and the Premises, harmless from and against any and all loss of rents and/or damages, liabilities, judgments, costs, claims, liens, expenses, penalties, permits and attorney's and consultant's fees arising out of or Involving any Hazardous Substance or storage tank brought onto the Premises by or for Tenant or under Tenant's control. Tenant's obligations under this Paragraph 6 shall include, but not be limited to, the effects of any contamination or injury to person, property or the environment created or suffered by Tenant, and the cost of investigation (including consultant's and attorney's fees and testing), removal, remediation, restoration and/or abatement thereof, or of any contamination therein involved and shall survive the expiration or earlier termination of this Lease. No termination, cancellation or release agreement entered into by Landlord and Tenant shall release Tenant from its obligations under this Lease with respect to Hazardous Substances or storage tanks, unless specifically so agreed by Landlord in writing at the time of such agreement.
- 6.3 Tenant's Compliance with Law. Except as otherwise provided in this Lease. Tenant shall, at Tenant's sole cost and expense, fully, diligently and in a timely manner, comply with all "Applicable Law," which term is used in this Lease to include ail laws, rules, regulations, ordinances, directives, covenants, easements and restrictions of record, permits, the requirements of any applicable fire insurance underwriter or rating bureau, and the recommendations of Landford's engineers and/or consultants, relating in any manner to the Premises (including but not limited to matters pertaining to (i) industrial hygiene, (ii) environmental conditions on, in, under or about the Premises, including soil and groundwater conditions, and (iii) the use, generation, manufacture, production, installation, maintenance, removal, transportation, storage, spill or release of any Hazardous Substance or storage tank), now in effect or which may hereafter come into effect, and whether or not reflecting a change in policy from any previously existing policy. Notwithstanding the foregoing, Tenant shall not be required to remedy the conditions existing prior to the commencement of this Lease. Tenant shall, within five (5) days after receipt of Landford's written request, provide Landford with copies of all documents and information, including, but not limited to, permits, registrations, manifests, applicables, perports and certificates, evidencing Tenant's compliance with any Applicable Law specified by Landford, and shall immediately upon receipt, notify Landford in writing (with copies of any documents involved) of any threatened or actual claim, notice, citation, warning, complaint or report pertaining to or involving failure by Tenant or the Premises to comply with any Applicable Law.
- 6.4 Inspection; Compliance. Landlord and Landlord's Lender(s) (as defined in Paragraph 8.3(a)) shall have the right to enter the Premises at any time, in the case of an emergency, and otherwise at reasonable times upon 24 hours prior notice, for the purpose of inspecting the condition of the Premises and for verifying compliance by Tenant with this Lease and all Applicable Laws (as defined in Paragraph 6.3), and to employ experts and/or consultants in connection therewith and/or to advise Landlord with respect to Tenant's activities, including but not limited to the installation, operation, use, monitoring, maintenance, or removal of any Hazardous Substance or storage tank on or from the Premises. The costs and expenses of any such inspections shall be paid by the party requesting same, unless a Default or Breach of this Lease, violation of Applicable Law, or a contamination, caused or materially contributed to by Tenant is found to exist or be imminent, or unless the inspection is requested or ordered by a governmental authority as the result of any such existing or imminent violation or contamination. In any such case, Tenant shall upon request reimburse Landlord's Lender, as the case may be, for the costs and expenses of such inspections.
- 7. Maintenance: Repairs: Utility Installations: Trade Fixtures and Alterations.

# 7.1 Tenant's Obligations

- Subject to the provisions of Paragraphs 7.2 (Landford's obligations to repair), 9 (damage and destruction), and 14 (condemnation), Tenant shall, at Tenant's sole cost and expense and at all times, keep the Premises and every part thereof in good order, condition and repair, non-structural (whether or not such portion of the Premises requiring repairs, or the means of repairing the same, are reasonably or readily accessible to Tenant, and whether or not the need for such repairs occurs as a result of Tenant's use, the elements or the age of such portion of the Premises), including, without limiting the generality of the foregoing, the roofs, all equipment or facilities serving the Premises, such as plumbing, heating, air conditioning, ventilating, electrical, lighting facilities, boilers, fired or unfired pressure vessels, fire sprinkler and/or standpipe and hose or other automatic fire extinguishing system, including fire alarm and/or smoke detection systems and equipment, fire hydrants, fixtures, floors, landscaping, driveways. parking lots, fences, sidewalks, retaining walls, interior walls, ceitings, interior windows and doors, plate glass, skylights, landscaping and signs, located in, on, about, or adjacent to the Premises. Tenant shall not cause or permit any Hazardous Substance to be spilled or released in, on, under or about the Premises (including through the plumbing or sanitary sewer system) and shall promptly, at Tenant's expense; take all investigatory and/or remedial action reasonably recommended, whether or not formally ordered or required, for the cleanup of any contamination of, and for the maintenance, security and/or monitoring of the Premises, the elements surrounding same, or neighboring properties, that was caused or materially contributed to by Tenant, or pertaining to or involving any Hazardous Substance and/or storage tank brought onto the Premises by or for Tenant or under its control. Tenant, in keeping the Premises in good order, condition and repair, shall exercise and perform good maintenance practices. Tenant's obligations shall include restorations, replacements or renewals when necessary to keep the Premises and all improvements thereon or a part thereof in good order, condition and state of repair. Not withstanding anything in this paragraph, Landlord shall be responsible for roof replacement and repairs throughout the Lease term and any roof costs incurred by Landford shall not be passed through to Jenant as part of any operating expenses (NNN) during the term. If Tenant occupies the Premises for seven (7) years or more, Landlord may require Tenant to repaint the exterior of the buildings on the Premises as reasonably required, but not more frequently than once every seven (7) years.
- (b) Tenent shall, at Tenant's sole cost and expense, procure and maintain contracts, with copies to Landford, in customary form and substance for, and with contractors specializing and experienced in, the inspection, maintenance and service of the following equipment and improvements, if any, located on the Premises: (i) heating, air conditioning and ventilation equipment, (ii) boiler, fired or unfired pressure vessels. (iii) fire sprinkler and/or standpipe and hose or other automatic fire extinguishing systems, including fire alarm and/or smoke detection, (iv) landscaping and irrigation systems, (v) roof, gu covering, and drain maintenance and (vi) asphalt and parking to maintenance.
- 7.2 Landlord's Obligations. Landlord shall, at Landlord's sole cost and expense and at all times, keep the exterior walls, roof and roof membrane and foundations, in good order, condition and repair (whether or not such portion of the Premises requiring repairs, or the means of repairing the same, are reasonably or readily accessible to Landlord, and whether or not the need for such repairs occurs as a result of Landlord's activities, the elements or the age of such portion of the Premises). Landlord shall pay for any HVAC replacements during the initial term of the lease and renewal options, however, they shall be able to amortize and pass through this cost, over the useful life of assets (per GAAP), within the NNN's. Except as set forth in the previous sentence and except for the warranties and agreements of Landlord contained in Paragraphs 2.2 (relating to condition of the Premises), 2.3 (relating to compliance with covenants, restrictions and building code), 9 (relating to destruction of the Premises) and 14 (relating to condemnation of the Premises), it is intended by the Parties hereto that Landlord have no obligation, in any manner whatsoever, to repair and maintain the Premises, the improvements located thereon, or the squipment therein, whether structural or non structural, all of which obligations are intended to be that of the Tenant under Paragraph 7.1 hereof. It is the intention of the Parties that the terms of this Lease govern the respective obligations of the Parties as to maintenance and repair of the Premises.

# 7.3 Utility installations: Trade Fixtures: Alterations.

(a) Definitions; Consent Required. The term "Utility Installations" is used in this Lease to refer to all carpeting, window coverings, air fines, power parsets, electrical distribution, security, fire protection systems, communication systems, lighting fixtures, heating, ventilating, and air conditioning equipment, plumbing, and fencing in, on or about the Premises. The term "Trade Fixtures" shall mean any modification of the improvements on the Premises from that which are provided by Landkord under the terms of this Lease, other than Utility Installations or Trade Fixtures, weither by

addition or deletion. "Tenant Owned Alterations and/or Utility Installations" are defined as Alterations and/or Utility Installations made by Tenant that are not yet owned by Landtord as defined in Paragraph 7.4(a). Tenant shall not make any Alterations or Utility Installations in, on, under or about the Premises that would require a permit from a governmental authority without Landtord's prior written consent, not to be unreasonably withheld. Tenant may, however, make non-structural Utility Installations to the Interior of the Premises (excluding the roof), as long as they are not visible from the outside, do not involve puncturing, relocating or removing the roof or any existing load bearing wells, and the cumulative cost thereof during the term of this Lesse as extended does not exceed \$50,000.

- (b) Consent. Any Alterations or Utility Installations that Tenant shall desire to make and which require the consent of the Landlord shall be presented to Landlord in written form with proposed detailed plans. All consents given by Landlord, whether by virtue of Paragraph 7.3(a) or by subsequent specific consent, shall be deemed conditioned upon: (f) Tenant's applicable permits required by governmental authorities, (ii) the furnishing of copies of such permits together with a copy of the plans and specifications for the Alteration or Utility installation to Landlord prior to commencement of the work thereon, and (iii) the compliance by Tenant with all conditions of said permits in a prompt and expeditious manner. Any Alterations or Utility Installations by Tenant during the term of this Lease shall be done in a good and workmanike manner, with good and sufficient marterials, and in compliance with all Applicable Law. Tenant shall promptly upon completion thereof furnish Landlord with as-built plans and specifications
- (c) Indemnification. Tenent shall pay, when due, all claims for labor or meterials (umlabed or alleged to have been furnished to or for use on the Premises, which claims are or may be secured by any mechanics' or materialmen's isin against the Premises or any interest therein. Tenent shall give Landlord not less than ten (10) days' notice prior to the commencement of any work in, on or about the Premises, and Landlord shall have the right to post notices of non-responsibility in or on the Premises as provided by law. If Tenent shall, in good faith, contest the validity of any such lien, claim or demand, then Tenent shall, at its sole expense defend and protect itself, Landlord and the Premises against the same and shall require. Tenent shall furnish to Landlord at the surely be rendered thereon before the enforcement thereof against the Landlord or the Premises. If Landlord shall require, Tenent shall furnish to Landlord satisfactory to Landlord in a mount equal to one and one-half times the amount of such contested lien claim or demand, Indemnifying Landlord against lieblity for the same, as required by law for the holding of the Premises free from the effect of such lien or claim. In addition, Landlord may require Tenent to pay Landlord's attorney's fees and costs in participating in such action if Landlord shall decide it is to its best interest to do so.

# 7.4 Ownership; Removal; Surronder; and Restoration.

- (a) Ownership. Subject to Landlord's right to require their removal or become the owner thereof as hereinafter provided in this Paragraph 7.4, all Attentions and Utility Additions made to the Premises by Tenant shall be the property of and owned by Tenant, but considered a part of the Premises. Landlord may, at any time and at its option, elect in writing to Tenant to be the owner of all or any specified part of the Tenant Owned Alterations and Utility Installations. Unless otherwise instructed per subparagraph 7.4(b) hereof, all Tenant Owned Attentions and Utility Installations. Unless otherwise instructed per subparagraph 7.4(b) hereof, all Tenant Owned Attentions and Utility Installations that, at the expiration or earlier termination of this Lesse, become the property of Landlord and remain upon and be surrendered by Tenant with the
- (b) Removal, Unless otherwise agreed in writing, Landlord may require that any or all Tenant Owned Alterations or Utility installations be removed by the expiration or earlier termination of this Lease, notwithstanding their installation may have been consented to by Landlord. Landlord may require the removal at any time of all or any part of any Tenant Owned Alterations or Utility Installations made without the required consent of Landlord.
- (c) Surrender/Restoration. Tenent shall surrender the Premises by the end of the last day of the Lease term or any earlier termination date, with all of the improvements, perte and surfaces thereof clean and free of debris and in good operating order, condition and state of repair, ordinary wear and test excepted. "Ordinary wear and test" shall not include any lange or deterioration that would have been prevented by good meintenance practice or by Tenant performing all of its obligations under this Lease. Except as otherwise agreed or specified in writing by Landford, the Premises, as surrendered, shall include the Utility Installations. The obligation of Tenant shall include the repair of any damage occasioned by the installation, maintenance or removal of Tenant's Trade Fixtures, furnishings, equipment, and therefaces and/or Utility Installations, as well as the removal of any storage tank installed by or for Tenant, and the removal, replacement, or romediation of any soil, material or ground water contaminated by Tenant, all as may then be required by Applicable Law and/or good service practice. Tenant's Trade Fixtures shall remain the property of Tenant and shall be removed by Tenant subject to its obligation to repair and restore the Premises per this Lease. Tenant has the right to remove any existing equipment within the facility and dispose of such at Tenant's expense.
- 7.5 Limitation on Alterations. Anything in this Lease to the contrary notwithatanding, Tenent may not remove any portion of the offices, break room, conference rooms or restrooms during the term of this Lease without Landiord's express written consent, which consent may be withheld or conditioned in Landiord's sole and unfettered discretion.

# 8. Insurance; Indemnity.

8.1 Payment For Insurance. Regardless of whether the Landlord or Tenant is the Insuring Party, Tenant shall pay for all insurance required under this Paragraph 8 except to the extent of the cost attributable to fiability insurance carried by Landlord in excess of \$3,000,000 per occurrence. Premiums for policy periods commencing prior to or extending beyond the Lease term shall be prorated to correspond to the Lease term. Payment shall be made by Tenant to Landlord within ten (10) days following receipt of an invoice for any amount due. Any failure by Tenant to have and maintain required insurance under this lease shall be penaltized with a fee of 10% of the then base rental amount per month until the violation is corrected and proof of insurance is provided to Landlord in writing.

# 8.2 Liability Insurance.

- (a) Carried by Tenant. Tenant shall obtain and keep in force during the term of this Lease a Commercial General Liability policy of insurance protecting Tenant and Landlord and Agent (as an additional insured) against claims for bodily injury, personal injury and property damage based upon, involving or arising out of the ownership, use, occupancy or maintenance of the Premises and all ereas appurtenant thereto. Such insurance shall be on an occurrence basis providing single limit coverage in an amount not less than \$3,000,000 per occurrence with en "Additional Insured-Managera or Landlords of Premises" Endorsement and contain the "Amendment of the Poliution Exclusion" for damage caused by heat, amoke or turnes from a hostile fire. The policy shall not contain any intra-insured exclusions as between insured persons or organizations, but shall include coverage for liability assumed under this Lease as an "insured contract" for the performance of Tenant's indemnity obligations under this Lease. The limits of said insurance required by this Lease or as carried by Tenant shall not, however, timit the liability of Tenant nor relieve Tenant of any obligation hereunder. All insurance to be carried by Tenant shall be primary to and not contributory with any similar insurance carried by Landlord, whose insurance shall be considered excess insurance only.
- (b) Carried By Landlord. In the event Landlord is the Insuring Party, Landlord shall also maintain liability insurance described in Paragraph 8.2(e), above, in addition to, and not in lieu of, the insurance required to be maintained by Tanant. Tenant shall be named as an additional insured therein.

# 8.3 Property insurance-Building, improvements and Rental Value.

(a) Building and improvements. The insuring Party shall obtain and keep in force during the term of this Lease a policy or policies in the name of Lendlord, with loss payable to Landlord and to the holders of any mortgages, deeds of trust or ground leases on the Premises (\*Lender(s)\*), insuring loss or damage to the Premises. The amount of such insurance shall be equal to the full replacement cost of the Premises, as the same shall exist from time to time, or the amount required by Lenders, but in no event more than the commercially reasonable and available insurable

value thereof if, by reason of the unique nature or age of the improvements involved, such latter amount is less than full replacement cost. If Landlord is the Insuring Party, however, Tenant Owned Alterations and Utility Installations shall be insured by Tenant under Paragraph 8.4 rather than by Landlord, If the coverage is available and commercially appropriate, such policy or policies shall insure against all risks of direct physical loss or damage (except the perilis of flood and/or earthquake unless required by a Lender), including coverage for any additional costs resulting from debris removal and reasonable amounts of coverage for the enforcement of any ordinance or law regulating the reconstruction or replacement of any undamaged sections of the Premises required to be demoished or removed by reason of the enforcement of any building, zoning, safety or land use laws as the result of a covered cause of loss. Said policy or policies shall also contain an agreed valuation provision in tieu of any colnaurance clause, waiver of subrogation, and inflation guard protection causing an increase in the annual property insurance coverage amount by a factor of not less than the adjusted U.S. Department of Labor Consumer Price Index for All Urban Consumers for the city nearest to where the Premises are located. If such insurance coverage has a deductible clause, the deductible amount shall not exceed \$1,000 per occurrence, and Tenant shall be liable for such deductible amount in the event of an insured Loss, as defined in Paragraph 9.1(c).

- (b) Rental Value. The insuring Party shall, in addition, obtain and keep in force during the term of this Lease a policy or policies in the name of Landlord, with loss payable to Landlord and Lender(s), insuring the loss of the full rental and other charges payable by Tenant to Landlord under this Lease for one (1) year (including all real estate taxes, insurance costs, and any scheduled rental increases). Said insurance shall provide that in the event the Lease is terminated by reason of an insured loss, the period of indemnity for such coverage shall be extended beyond the date of the completion of repairs or replacement of the Premises, to provide for one full year's loss of rental revenues from the date of any such loss. Said insurance shall contain an agreed valuetion provision in lieu of any coinsurance clause, and the amount of coverage shall be adjusted annually to reflect the projected rental income, property taxes, insurance premium costs and other expenses, if any, otherwise payable by Tenant, for the next twelve (12) month period. Tenant shall be liable for any deductible amount in the event of such loss.
- (c) Adjacent Premises. If the Premises are part of a larger building, or if the Premises are part of a group of buildings owned by Landlord which are adjacent to the Premises, the Tenant shall pay for any increase in the premiums for the property insurance of such building or buildings if said increase is caused by Tenant's acts, omissions, use or occupancy of the Premises.
- (d) Tenant's Improvements. If the Landlord is the Insuring Party, the Landlord shall not be required to insure Tenant Owned Atterations and Utility Installations unless the item in question has become the property of Landlord under the terms of this Lease. If Tenant is the insuring Party, the policy carried by Tenant under this Paragraph 8.3 shall insure Tenant Owned Atterations and Utility Installations.
- 8.4 Tenant's Property Insurance. Subject to the requirements of Paragraph 8.5, Tenant at its cost shall either by separate policy or, at Landlord's option, by endorsement to a policy already carried, maintain insurance coverage on all of Tenant's personal property. Tenant Owned Alterations and Utility Installations in, on, or about the Premises similar in coverage to that carried by the Insuring Party under Paragraph 8.3. Such insurance shall be full replacement cost coverage with a deductible of not to exceed \$1,000 per occurrence. The proceeds from any such insurance shall be used by Tenant for the replacement of personal property or the restoration of Tenant Owned Alterations and Utility Installations. Tenant shall be the insuring Party with respect to the insurance required by this Paragraph 8.4 and shall provide Landlord with written evidence that such insurance is in force.
- 6.5 Insurance Policies, Insurance required hereunder shall be in companies duly licensed to transact business in the state where the Premises are located, and maintaining during the policy term a "General Policyholders Rating" of at least B+, V, or such other rating as may be required by a Lender having a lilen on the Premises, as set forth in the most current issue of "Best's Insurance Guide." Tenant shall not do or permit to be done anything which shall invalidate the insurance policies referred to in this Paragraph 8. If Tenant is the Insuring Party, Tenant shall cause to be delivered to Landlord certified copies of policies of such insurance or certificates evidencing the existence and amounts of such insurance with the insurance and loss payable clauses as required by this Lease. No súch policy shall be cancelable or subject to modification except after thirty (30) days prior written notice to Landlord. Tenant shall at least thirty (30) days prior to the expiration of such policies, furnish Landlord with evidence of renewals or "insurance binders" evidencing renewal thereof, or Landlord may order such insurance and charge the cost thereof to Tenant, which amount shall be payable by Tenant to Landlord upon demand. If the Insuring Party shall fail to procure and maintain the insurance required to be carried by the Insuring Party under this Paragraph 8, the other Party may, but shall not be required to, procure and maintain the areas, but at Tenant's expense.
- 8.6 Waiver of Subrogation. Without affecting any other rights or remedies, Tenant and Landlord ("Waiving Party") each hereby release and relieve the other, and waive their entire right to recover damages (whether in contract or in tort) against the other, for loss of or damage to the Waiving Party's property arising out of or incident to the perils required to be insured against under Paragraph 8. The effect of such releases and waivers of the right to recover damages shall not be limited by the amount of insurance carried or required, or by any deductible applicable thereto.
- 8.7 Indemnity of Landtord. Except for Landtord's negligence and/or breach of express warranties, Tenant shall indemnify, protect, defend and hold harmless the Premises, Landtord and its agents, Landtord's master or ground Landtord, partners and Lenders from and against any and all claims, loss of rents and/or damages, costs, liens, judgments, penalties, permits, attomey's and consultant's fees, expenses and/or liabilities arising out of, involving, or in dealing with, the occupancy of the Premises by Tenant, the conduct of Tenant's business, any act, omission or neglect of Tenant, its agents, contractors, employees or invitees, and out of any Default or Breach by Tenant in the performance in a timely manner of any obligation on Tenant's part to be performed under this Lease. The foregoing shall include, but not be limited to, the defense or pursuit of any claim or any action or proceeding involved therein, and whether or not (in the case of claims made against Landtord) litigated and/or reduced to judgment, and whether well founded or not. In case any action or proceeding be brought against Landtord by reason of any of the foregoing matters, Tenant upon notice from Landlord shall defend the same at Tenant's expense by counsel reasonably satisfactory to Landtord and Landtord shall cooperate with Tenant in such defense. Landtord need not have first paid any such claim in order to be so indemnified.
- 8.8 Indemnity of Tenant. Except for Tenant's negligence and/or breach of express warranties, Landlord shall indemnify, protect, defend and hold harmless the Premises, Tenant and its agents, partners and Lenders from and against any and all claims, damages, costs, liers, judgments, penalties, permits, attorney's and consultant's fees, expenses and/or liabilities arising out of, involving, or in dealing with, the activities on the Premises by Landlord, the conduct of Landlord's business, any act, omission or neglect of Landlord, its agents, contractors, employees or invitees, and out of any Default or Breach by Landlord in the performance in a timely manner of any obligation on Landlord's part to be performed under this Lease. The foregoing shall include, but not be limited to, the defense or pursuit of any claim or any action or proceeding involved therein, and whether or not (in the case of claims made against Tenant) litigated and/or reduced to judgment, and whether well founded or not. In case any action or proceeding be brought against Tenant by reason of any of the foregoing matters, Landlord upon notice from Tenant shall defend the same at Landlord's expense by counsel reasonably satisfactory to Tenant and Tenant shall cooperate with Landlord in such defense. Tenant need not have first paid any such claim in order to be so indemnified.
- 8.9 Exemption of Landlord from Liability. Landlord shall not be liable for injury or damage to the person or goods, wares, merchandise or other property of Tenant, Tenant's employees, contractors, invitees, customers, or any other person in or about the Premises, whether such damage or injury is caused by or results from fire, steam, electricity, gas, water or rain, or from the breakage, leakage, obstruction or other defects of pipes, fire sprinklers, wire, appliances, plumbing, air condition or lighting fixtures, or from any other cause, whether the said injury or damage results from conditions arising upon the Premises or upon other portions of the building of which the Premises are a part, or from other sources or places, and regardless of whether the cause of such damage or injury or the means of repairing the same is accessible or not. Landlord shall not be liable for any damages arising from any act or neglect of any other tenant of Landlord. Notwithstanding Landlord's negligence or breach of this Lease, Landlord shall under no circumstances be liable for injury to Tenant's business or for any loss of income or profit therefrom.
- 9. Damage or Destruction.
  - 9.1 Definitions.

- (a) "Premises Partial Damage" shall mean damage or destruction to the improvements on the Premises, other than Tenant Owned Alterations and Utility Installations, the repeir cost of which damage or destruction is less than 50% of the then Replacement Cost of the Premises Immodelety prior to such damage or destruction, excluding from such calculation the value of the land and Tenant Owned Alterations and Utility Installations.
- (b) "Premises Total Destruction" chall mean demage or destruction to the Premises, other than Tenant Owned Alterations and Utility Installations the repair cost of which damage or destruction is 50% or more of the then Replacement Cost of the Premises immediately prior to such damage or destruction, excluding from such calculation the value of the land and Tenant Owned Alterations and Utility Installations.
- (c) "insured Loss" shall mean damage or destruction to improvements on the Premises, other than Tenant Owned Alterations and Utility Installations, which was caused by an event required to be covered by the insurance described in Paragraph 8.3(a), irrespective of any deductible amounts or coverage limits involved.
- (d) "Reptacement Cost" shall meen the cost to repair or rebuild the improvement owned by Landlord at the time of the occurrence to their condition existing immediately prior thereto, including demolition, debris removal and upgrading required by the operation of applicable building codes, ordinances or laws, and without deduction for depreciation.
- (e) "Hazardous Substance Condition" shall mean the occurrence or discovery of a condition involving the presence of, or a contamination by, a Hazardous Substance as defined in Paragraph 6.2(a), in, on, or under the Premises.
- expense, repair such damage (but not Tenant's Trade Fixtures or Tenant Owned Alterations and Utility installations) as soon as reasonably possible and this Lease shall continue in full force and effect; provided, however, that Tenant shall, at Landlord's election, make the repair of any damage or destruction to total cost to repair of which is \$10,000 or less, and, in such event, Landlord shall make the insurance proceeds evaluable to Tenant on a reasonable basis for that purpose. Notwithstanding the foregoing, if the required insurance was not in force or the insurance proceeds are not sufficient to effect such repair, the Insuring Party shall promptly contribute the shortage in proceeds (except as to the deductible which is Tenant's responsibility) as and when required to complete said repairs. In the event, however, the shortage in proceeds was due to the fact that, by reason of the unique nature of the improvements' full replacement cost, insurance coverage was not commercially reasonable and available, Landlord shall have no obligation to pay for the shortage in insurance proceeds or to fully restore the unique aspects of the Premises unless Tenant provides Landlord with the funds to cover same, or adequate assurance thereof, within ten (10) days following receipt of written notice of such shortage and request thereof. It Landlord receives said funds or adequate assurance thereof within said ten (10) days period, the party responsible for making the repairs shall complete them as soon as reasonably possible and this Lease shall remain in full force and effect. If Landlord does not receive such funds or assurance within said period, Landlord may nevertheless elect by written notice to Tenant within ten (10) days thereafter to make such restoration and repair as is commercially reasonable with Landlord paying any shortage in proceeds, in which case this Lease shall remain in full force and effect, if it is such case Landlord does not so efect, then this Lease shall terminate sixty (60) days following the occ
- 9.3 Partial Damage-Uninsured Loss. If a Premisea Partial Damage that is not an insured Loss occurs, unless caused by a willful act of Tenant (in which event Yenant shall make the repairs at Yenant's expense and this Lesse shall confinue in full force and effect, but subject to Landiord's rights under Paragraph 13), Landiord may at Landiord's option, either: (i) repair such damage as soon as reasonably possible at Landiord's expense, in which event this Lesse shall confinue in full force and effect, or (i) give written notice to Tenant within thirty (30) days after receipt by Landiord of knowledge of the occurrence of such damage of Landiord's desire to terminate this Lesse as of the date sixty (60) days following the giving of such notice. In the event Landiord elects to give such notice of Landiord's intention to terminate this Lesse, Tenant shall have the right within ten (10) days after the receipt of such notice to give written notice to Landiord of Tenant's commitment to pay for the repair of such damage stelly at Tenant's expense and without reimbursement from Landiord. Tenant shall provide Landiord with the required funds or satisfactory assurance thereof within thirty (30) days following Tenant's said commitment. In such event this Lesse shall continue in full force and effect, and Landiord shall proceed to make such repairs as soon as reasonably possible and the required funds are available. If Tenant does not give such notice and provide the funds or assurance thereof within the times specified above, this Lesse shall terminate as of the date specified in Landiord's notice of termination.
- 9.4 Total Destruction. Notwithstanding any other provision hereof, if a Premises Total Destruction occurs (including any destruction required by any authorized public authority), this Lease shall terminate sixty (60) days following the date of such Premises Total Destruction, whether or not the demage or destruction is an insured Loss or was caused by a negligent or willful act of Tenant. In the event, however, that the damage or destruction was caused by Tenant, Landlord shall have the right to recover Landlord's demages from Tenant except as released under the terms of any insurance policy then in effect.
- Damage Near End of Term. If at any time during the last six (6) months of the term of this Lease there is damage for which the cost to repair exceeds one (1) month's Base Rent, whether or not an Insured Loss, either Party may, at the Party's option, (eminate this Lease effective sixty (60) days following the date of occurrence of such damage by giving written notice to the other Party of Landlord's election to do so within thinky (30) days after the date of occurrence of such damage. Provided, however, if Tenant at that time has an exercisable option to extend this Lease or to purchase the Premises, then Tenant may preserve this Lease by, within twenty (20) days following the occurrence of the damage or before the expiration of the time provided in such option for its exercise, whichever is earlier ("Exercise Period"), exercising such option. If Tenant duly exercises such option during said Exercise Period, Landlord shall, at Landlord's expense repair such damage as soon as reasonably possible and this Lease shall continue in full force and effect. If Tenant fails to exercise such option during said Exercise Period, then Landlord's applied terminate this Lease as of the expiration of said strip (60) day particle following the occurrence of such damage by giving written notice to Tenant of Landlord's election to do so within ten (10) days after the expiration of the Exercise Period, notwithstanding eny term or provision in the grant of option to the contrary.

# 9.6 Abstement of Ront; Tenant's Romadies.

- (e) In the event of damage described in Paragraph 9.2 (Partiel Demage-Insured), whether or not Landlord or Tenant repairs or restores the Premises, thre Base Rent, Real Property Taxes, insurance premisms, and other charges, if any, payable by Tenant hereunder for the period during which such damage, its repair or the restoration continues (not to exceed the period for which rental value insurance is required under Paragraph 8.3(b)), shall be abaled in proportion to the degree to which Tenant's use of the Premises is impaired. Except for abatement of Base Rent, Real Property Taxes, insurance premiums, and other charges, if any, as aforesaid, all other obligations of Tenant hereunder shall be performed by Tenant, and Tenant shall have no claim against Landlord for any damage suffered by reason of any such repair or restoration so long as Landlord promptly commences such repair or restoration and thereafter disjently pursues the repair or restoration to completion.
- (b) If Lendlord shall be obligated to repair or restore the Premises under the provisions of this Paragraph 9 and shall not commence, in a substantial and meaningful way, the repair or restoration of the Premises within ninary (90) days after such obligation shall accrue. Tenant way, at any time prior to the commencement of such repeir or restoration, give written notice to Lendlord and to any Lenders of which Tenant has actual notice of Tenant's election to terminate this Lease on a date not less than sixty (60) days following the giving of such notice. If Tenant gives such notice to Landlord and such Lenders and such repeir or restoration is not commenced within thirty (30) days after receipt of such notice, this Lease shall terminate as of the date specified in said notice. If Landlord or a Lender commences the repair or restoration of the Premises within thirty (30) days after receipt of such notice, this Lease shall continue in full force and effect. "Commence" as used in this Paragraph shall mean either the unconditional authorization of the proparation of the required plans, or the beginning of the actual work on the Premises, whichever first occurs.

- 9.7 Hazardous Substance Conditions. If a Hazardous Substance Condition occurs, unless Tenant is legally responsible therefor (in which case Tenant shall make the Investigation and remediation thereof required by Applicable Law and this Lease shall continue in full force and effect, but subject to Landlord's rights under Paragraph 13), Landlord may at Landlord's option either (i) investigate and remediate such Hazardous Substance Condition, if required, as soon as reasonably possible at Landlord's expense, in which event this Lease shall continue in full force and effect, or (ii) if the estimated cost to investigate and remediate such condition exceeds twelve (12) times the then monthly Base Rent or \$100,000, whichever is greater, give written notice to Tenant within thirty (30) days after receipt by Landlord of knowledge of the occurrence of such Hazardous Substance Condition of Landlord's desire to terminate this Lease as of the date sixty (60) days following the giving of such notice. In the event Landlord elects to give such notice of Landlord's intention to terminate this Lease, Tenant shall have the right within ten (10) days after the receipt of such notice to give written notice to Landlord's intention to terminate this Lease. Tenant shall have the right within ten (10) days after the receipt of such notice to give written notice to Landlord of Tenant's commitment to pay for the investigation and remediation of such Hazardous Substance Condition totally at Tenant's expense and without reimbursement from Landlord except to the extent of an amount equal to twelve (12) times the then monthly Base Rent or \$100,000, whichever is greater. Tenant shall provide Landlord with the funds required of Tenant os snot give such notice and provide the required funds or assurance thereof within theirty (30) days following Tenant's soon as reasonably possible and the required funds are available. If Tenant does not give such notice and provide the required funds or assurance thereof within the times specified above, this
- 9.8 Termination-Advance Payments. Upon termination of this Lease pursuant to this Paragraph 9, an equitable adjustment shall be made concerning advance Base Rent and any other advance payments made by Tenant to Landlord. Landlord shall, in addition, return to Tenant so much of Tenant's Security Deposit as has not been, or is not then required to be, used by Landlord under the terms of this Lease.
- 9.9 Waive Statutes. Landlord and Tenant agree that the terms of this Lease shall govern the effect of any damage to or destruction of the Premises with respect to the termination of this Lease and hereby waive the provisions of any present or future statute to the extent inconsistent herewith.

# 10. Real Property Taxes.

- 10.1 (a) Payment of Taxes. Tenant shall pay the Real Property Taxes, as defined in Paragraph 10.2, applicable to the Premises during the term of this Lease. Subject to Paragraph 10.1(b), all such payments shall be made at least ten (10) days prior to the delinquency date of the applicable installment. Tenant shall promptly furnish Landlord with satisfactory evidence that such taxes have been paid. If any such taxes to be paid by Tenant shall cover any period of time prior to or after the expiration or earlier termination of the term hereof. Tenant's share of such taxes shall be equitably prorated to cover only the period of time within the tax flacal year this Lease is in effect, and Landlord shall reimburse Tenant for any overpayment after such proration. If Tenant shall fail to pay any Real Property Taxes required by this Lease to be paid by Tenant, Landlord shall have the right to pay the same, and Tenant shall reimburse Landlord therefor upon demand.
- (b) Advance Payment. In order to insure payment when due and before delinquency of any or all Real Property Taxes, Landlord reserves the right, if Tenant is in default under this Lease, to eatimate the current Real Property Taxes applicable to the Premises, and to require such current year's Real Property Taxes to be paid in advance to Landlord by Tenant, either: (i) in a lump sum amount equal to the installment due, at least twenty (20) days prior to the applicable delinquency date, or (ii) monthly in advance with the payment of the Base Rent. If Landlord elects to require payment monthly in advance, the monthly payment shall be that equal monthly amount which, over the number of months remaining before the month in which the applicable tax installment would become delinquent (and without interest thereon), would provide a fund large enough to fully discharge before delinquency the estimated installment of taxes to be paid. When the actual amount of the applicable tax bill is known, the amount of such equal monthly advance payment shall be adjusted as required to provide the fund needed to pay the applicable taxes before delinquency. If the amounts paid to Landlord by Tenant under the provisions of this Paragraph are insufficient to discharge the obligations of Tenant to pay such Real Property Taxes as the same become due, Tenant shall pay to Landlord, upon Landlord's demand, such additional sums as are necessary to pay such obligations. All moneys paid to Landlord under this Paragraph may be intermingled with other moneys of Landlord and shall not bear interest. In the event of a Breach by Tenant in the performance of the obligations of Tenant under this Lease, then any balance of funds paid to Landlord under the provisions of this Paragraph may, subject to proration as provided in Paragraph 10.1(a), at the option of Landlord be treated as an additional Security Deposit under Paragraph 5.
- (c) Delayed Payment. Tenant may pay Real Property Taxes in installments if permitted by the taxing authority with jurisdiction over the Premises. Tenant shall have the right at Tenant's expense to contest or review the amount or validity of any Real Property Taxes or to seek a reduction in the assessed valuation on which any Real Property Taxes are based, by appropriate legal proceedings, and may delay payment of Real Property Taxes until such contest or review is fully and finally resolved.
- Definition of "Real Property Taxes." As used herein, the term "Real Property Taxes" shall include any form of real estate tax or assessment, general, special, ordinary or extreordinary, and any license fee, commercial rental tax, improvement bond or bonds, levy or tax (other than inheritance, income or estate taxes) imposed upon the Premises by any authority having the direct or indirect power to tax, including any city, state or federal government, or any school, agricultural, sanitary, fire, street, drainage or other improvement distinct thereof, levied against any legal or equitable interest of Landlord in the Premises or in the real property of which the Premises are a part, and/or Landlord's business of leasing the Premises, but not including any Income tax on the rentals accruing hereunder. The term "Real Property Taxes" shall also include any tax, fee, levy, assessment or charge, or any increase therein, imposed by reason of events occurring, or changes in applicable law taking effect, during the term of this Lease, including but not include to a change in the improvements on the Premises, the execution of this Lease, or any modification, amendment or transfer thereof, and whether or not contemplated by the Parties.
- 10.3 Joint Assessment. If the Premises are not separately assessed, Tenant's liability shall be an equitable proportion of the Real Property Taxes for all of the land and improvements included within the tax parcel assessed, such proportion to be determined by Landlord from the respective valuations assigned in the assessor's work sheets or such other information as may be reasonably available. Landlord's reasonable determination thereof, in good faith, shall be conclusive.
- 10.4 Personal Property Taxes. Tenant shall pay prior to delinquency all taxes assessed against and levied upon Tenant Owned Atterations, Utility Installations, Trade Fixtures, furnishings, equipment and all personal property of Tenant contained in the Premises or elsewhere. When possible, Tenant shall cause its Trade Fixtures, furnishings, equipment and all other personal property to be assessed and billed separately from the real property of Landdord. If any of Tenant's said personal property shall be assessed with Landdord's real property. Tenant shall pay Landdord the taxes attributable to Tenant within ten (10) days after receipt of a written statement setting forth the taxes applicable to Tenant's property or, at Landdord's option, as provided in Paragraph 10.1 (b).
- 11. Utilities. Tenant shall pay for all water, gas, heat, light, power, telephone, trash disposal and other utilities and services supplied to the Premises, together with any taxes thereon. If any such services are not separately metered to Tenant, Tenant shall pay a reasonable proportion, to be determined by Landlord, of all charges jointly metered with other premises.

# 12. Assignment and Subletting.

# 12.1 Landlord's Consent Required.

(a) Tenant shall not voluntarily or by operation of law assign, transfer, mortgage or otherwise transfer or encumber (collectively, "assignment") or sublet all or any part of Tenant's interest in this Lease or in the Premises without Landlord's prior written consent, said consent shall not to be unreasonably withheld, conditioned or delayed subject to the terms of Paragraph 36.

(b) A change in the control of Tenant shall constitute an assignment requiring Landlord's consent. The transfer, on a cumulative basis, of twenty-five percent (25%) or more of the voting control of Tenant shall constitute a change in control for this purpose.

#### 12.2 Terms and Conditions Applicable to Assignment and Subletting.

- (a) Regardless of Landlord's consent, any assignment or subletting shall not: (i) be affective without the express written assumption by such assignee or subTenent of the obligations of Tenent under this Lease, (ii) release Tenent of any obligations hereunder, or (iii) after the primary liability of Tenent for the payment of Base Rent and other sums due Landlord hereunder or for the performance of any other obligations to be performed by Tenant under this Lease.
- (b) Landford may accept any rent or performance of Tenant's obligations from any person other than Tenant pending approval or disapproval of an assignment. Neither a delay in the approval or disapproval of such assignment nor the acceptance of any rent or performance shall constitute a waiver or astoppel of Landford's right to exercise its remedies for the Default or Breach by Tenant of any of the terms, covenants or conditions of this Lease.
- (c) The consent of Landford to any assignment or subletting shalf not constitute a consent to any subsequent assignment or subletting by Tenant or to any subsequent or successive assignment or subletting by the subTenant. However, Lendlord may consent to subsequent sublettings and assignments of the sublease or any amendments or modifications thereto without notifying Tenant or anyone else liable on the Lease or sublease and without obtaining their consent, and such action shalf not refere such persons from liability under this Lease or any sublease.
- (d) In the event of any Default or Breach of Tenant's obligations under this Lease, Landlord may proceed directly against Tenant, any Guarantor or any one else responsible for the performance of the Tenant's obligations under this Lease, including the subTenant, without first exhausting Landlord's romedies against any other person or entity responsible therefor to Landlord, or any security held by Landlord or Tenant
- (e) Any assignee of, or subTenant under, this Lease shall, by reason of accepting such assignment or entering into such sublease, be deemed, for the benefit of Lendlord, to have assumed and agreed to conform and comply with each and every term, coverant, condition and obligation herein to be observed or performed by Tenant during the term of said assignment or sublease, other than such obligations as are contrary to or inconsistent with provisions of an assignment or sublease to which Landlord has specifically consented in writing.
- (f) It is expressly allowed and contemplated that Tenant may charge a monthly fee to its customers for warehouse space in the ordinary course of its business.
- 12.3 Terms and Conditions Applicable to Assignment and Subletting. The following terms and conditions shall apply to any subletting by Tenant of all or any part of the Premises and shall be deemed included in all sublesses under this Lesse whether or not expressly incorporated therein:
- (a) In the event of a Breach by Tenant in the performance of its obligations under this Lease, Landford, at its option and without any obligation to do so, may require any subTenant to attem to Landford, in which event Landford shall undertake the obligations of the subLandford under euch sublease from the time of the exercise of said option to the expiration of such sublease; provided, however, Landford shall not be liable for any prepaid rents or security deposit paid by such subTenant to such subLandford or for any other prior Defaults or Breaches of such subLandford under such sublease.
- (b) Any matter or thing requiring the consent of the subLandford under a sublease shall also require the consent of Landlord herein.
  - (c) No subTenant shall further essign or sublet all or any part of the Premises without Landlord's prior written consent.
- (d) Landford shall deliver a copy of any notice of Default or Breach by Tenant to the subTenant, who shall have the right to cure the Default of Tenant within the grace period, if any, specified in such notice. The subTenant shall have a right of reimbursement and offset from and against Tenant for any such Defaults cured by the subTenant.

# 13. Default; Breach; Remedies.

- 13.1 Default; Breach. Landkord and Tenant agree that if an altomey is consulted by Landkord in connection with a Tenant Default or Breach (as hereinafter defined), \$500.00 is a reasonable minimum sum per such occurrence for legal services and costs in the preparation and service of a notice of Default, and that Landkord may include the cost of such services and costs in said notice as rent due and payable to cure said Default. A "Default" is defined as a failure by the Tenant to observe, comply with or perform any of the terms, covenants, conditions or rules applicable to Tenant under this Lease. A "Breach" is defined as the occurrence of any one or more of the following Defaults, and, where a grace period for cure after notice is specified herein, the faiture by Tenant to cure such Default prior to the expiration of the applicable grace period, shall entitle Landkord to pursue the remedies set forth in Paragraphs 13.2 and/or 13.3:
- (a) Except as expressly otherwise provided in this Lease, the failure by Tenant to make any payment of Base Rent or any other monetary payment required to be made by Tenant hereunder, whether to Landford or to a third party, as and when due, the failure by Tenant to provide Landford with reasonable evidence of insurance or surely bond required under this Lease, or the failure of Tenant to fulful any obligation under this Lease which endangers or threatens life or property, where such failure continues for a period of ten (10) days following written notice thereof by or on behalf of Landford to Tenant.
- (b) Except as expressly otherwise provided in this Lease, the failure by Tenant to provide Landlord with reasonable written evidence (in duly executed original form, if applicable) of (i) compliance with Applicable Law per Peragraph 8.3, (ii) the Inspection, maintenance and service contracts required under Paragraph 7.1 (b), (iii) the resolation of an unauthorized assignment or subletting per Peragraph 12.1 (b), (iv) a Tenancy Statement per Paragraphs 16 or 37, (v) the subordination or non-subordination of this Lease per Paragraph 30, (vi) the gueranty of the performance of Tenant's obligations under this Lease if required under Paragraphs 1.11 and 37, (vi) the execution of any document requested under Paragraph 42 (easements), or (viii) any other documentation or information which Landlord may reasonably require of Tenant under the terms of this Lease, where any such failure continues for a period of ten (10) days following written notice by or on behalf of Landlord to Tenant.
- (c) A Default by Tenant as to the terms, covenants, conditions or provisions of this Lease, or of the rules adopted under Paragraph 40 hereof, that are to be observed, compiled with or performed by Tenant, other than those described in subparagraphs (a), (b) or (c), above, where such Default continues for a period of thirty (30) days after written notice thereof by or on behalf of Landerg to Tenant; provided, however, that if the nature of Tenant's Default is such that more than thirty (30) days are reasonably required for its cure, then it shall not be deemed to be a Breach of this Lease by Tenant if Tenant commences such cure within said thirty (30) day period and thereafter diligently prosecutes such cure to completion.
- (d) The occurrence of any of the following events: (i) The making by Tenant of any general arrangement or assignment for the benefit of creditors; (ii) Tenant's becoming a "debtor" as defined in 11 U.S.C. §101 or any successor statute thereto (unless, in the case of a petition filed against Tenant, the same is dismissed within sixty (60) days); (iii) the appointment of a trustee or receiver to take possession of substantially all of Tenant's assets located at the Premises or of Tenant's interest in this Lesse, where possession is not restored to Tenant within thirty (30) days; or (iv) the stlackment.

execution or other judicial seizure of substantially all of Tanant's assets located at the Premises or of Tenant's interest in this Lease, where such seizure is not discharged within thirty (30) days; provided, however, in the event that any provision of this subparagraph (e) is contrary to any applicable law, such provision shall be of no force or effect, and not affect the validity of the remaining provisions.

- (e) The discovery by Landlord that any financial statement given to Landlord by Tenant or any Guarantor of Tenant's obligations hereunder was materially false.
- (f) If the performance of Tenent's obligations under this Lease is guaranteed: (i) the death of a guarantor, (ii) the termination of a guarantor is this Lease other than in accordance with the terms of such guaranty, (ii) a guarantor's becoming insolvent or the subject of a bentruptor filing, (iii) a guarantor's refusal to hence the guaranty or (iv) a guarantor's breach of its guaranty obligation on an anticipatory breach basis, and Tenant's failure, within sixty (60) days following written notice by or on behalf of Landlord to Tenant of any such event, to provide Landlord with written alternative assurance or security, which, when outpied with the then existing resources of Tenant, equals or exceeds the combined financial resources of Tenant and the guarantors that existed at the time of execution of this Losse.
- 13.2 Remedies. If Tenant falls to perform any affirmative duty or obligation of Tenant under this Lease, within ten (10) days after written notice to Tenant (or in case of an emergency, without notice), Landlord may at its option (but without obligation to do so), perform such duty or obligation on Tenant's behalf, including but not limited to the obtaining of reasonably required bonds, insurance policies, or governmental licenses, permits or approvals. The costs and expenses of any such performance by Landlord shall be due and payable by Tenant to Landlord upon invoice therefor. If any check given to Landlord by Tenant shall not be honored by the bank upon which it is drawn, Landlord, at its option, may require all future payments to be made under this Lease by Tenant to be made only by cashier's check. In the event of a Breach of this Lease by Tenant, as defined in Paragraph 13.1, with or without further notice or demand, and without limiting Landlord in the exercise of any right or remedy which Landlord may have by reason of such Breach, Landlord may.
- Terminate Tenant's right to possession of the Premises by any lawful means, in which case this Lease and the term hereof shall terminate and Tenant shall immediately surrender possession of the Premises to Landlord. In such event Landlord shall be entitled to recover from Tenant: (i) the worth at the time of the award of the uppaid rent which had been earned at the time of termination: (ii) the worth at the time of award of the amount by which the unpaid rent which would have been earned after termination until the time of award exceeds the amount of such rental loss that the Tenant proves could have been reasonably avoided; (iii) the worth at the time of award of the amount by which the unpaid rent for the balance of the term after the time of award exceeds the amount of such rental loss that the Tenant proves could be reasonably avoided; and (iv) any other amount necessary to compensate Landlord for all the detriment proximately caused by the Tenant's failure to perform its obligations under this Lease or which in the ordinary course of things would be likely to result therefrom, including but not limited to the cost of recovering possession of the Premises, expenses of reletting, including necessary renovation and alteration of the Premises, reasonable attorneys' fees, and that portion of the leasing commission paid by Landlord applicable to the unexpired term of this Lease. The worth at the time of award of the amount referred to in provision (III) of the prior sentence shall be computed by discounting such amount at the discount rate of the Federal Reserve Bank of San Francisco at the time of award plus one percent (1%), Efforts by Landford to mitigate damages caused by Tenant's Default or Breach of this Lease shall not waive Landford's right to recover damages under this Paragraph. If termination of this Lease is obtained through the provisional remedy of unlawful detainer, Landlord shall have the right to recover in such proceeding the unpaid rent and damages as are recoverable therein, or Landford may reserve therein the right to recover all or any part thereof in a separate suit for such rent and/or damages. If a notice and grace period required under subparagraphs 13.1 (b), (c) or (d) was not previously given, a notice to pay rent or quit, or to perform or quit, as the case may be, given to Tenant under any statute authorizing the forfeiture of leases for unlawful detainer shall also constitute the applicable notice for grace period purposes required by subparagraphs 13.1(b), (c) or (d). In such case, the applicable grace period under subparagraphs 13.1(b), (c) or (d) and under the unlawful detainer statute shall run concurrently after the one such statutory notice, and the failure of Tenant to cure the Default within the greater of the two such grace periods shall constitute both an unlawful detainer and a Breach of this Lease entitling Landlord to the remedies provided for in this Lease and/or by said statute
- (b) Continue the Lease and Tenant's right to possession in effect after Tenant's Breach and abandonment and recover the rent as it becomes due, provided Tenant has the right to sublet or assign, subject only to reasonable limitations. See Paragraphs 12 and 36 for the limitations on assignment and subletting which limitations Tenant and Landord agree are reasonable. Acts of maintenance or preservation, efforts to relet the Premises, or the appointment of a receiver to protect the Landord's interest under the Lease, shall not constitute a termination of the Tenant's right to possession.
- (c) Pursue any other remedy now or hereafter available to Landford under the laws or judicial decisions of the state wherein the Premises are located.
- (d) The expiration or termination of this Lease and/or the termination of Tenant's right to possession shall not relieve Tenant from liability under any indemnity provisions of this Lease as to matters occurring or accruing during the term hereof or by reason of Tenant's occupancy of the Premises.
- 13.3 Inducement Recapture In Event Of Breach. Any agreement by Landlord for free or abated rent or other charges applicable to the Premises, or for the giving or paying by Landlord to or for Tenant of any cash or other bonus, inducement or consideration for Tenant's entering into this Lease, all of which concessions are hereinafter referred to as 'Inducement Provisions,' hall be deemed conditioned upon Tenant's full and faithful performance of all of the terms, covenants and conditions of this Lease to be performed or observed by Tenant during the term hereof as the same may be extended. Upon the occurrence of a Breach of this Lease by Tenant, as defined in Paragraph 13.1, any such inducement Provision shall automatically be deemed deleted from this Lease and of no further force or affect, and any rent, other charge, bonus, inducement or consideration theretofore abated, given or paid by Lendford under such an Inducement Provision shall be immediately due and payable by Tenant to Landlord, and recoverable by Landlord as additional rent due under this Lease, nowthelstanding any subsequent cure of said Breach by Tenant. The acceptance by Landlord of rent or the cure of the Breach which initiated the operation of this Paragraph shall not be deemed a waiver by Landlord of the provisions of this Paragraph unless specifically so stated in writing by Landlord at the time of such acceptance.
- 13.4 Late Charges. Tenant hereby acknowledges that late payment by Tenant to Landlord of rent and other sums due hereunder will cause Landlord to incur costs not contemplated by this Lease, the exact amount of which will be extremely difficult to ascertain. Such costs include, but are not limited to, processing and accounting charges, and late charges which may be imposed upon Landlord by the terms of any ground lease, mortgage or trust deed covering the Premises. Accordingly, if any installment of rent or any other sum due from Tenant shall not be received by Landlord or Landlord's designee within five (5) days after such amount shall be due, then, without any requirement for notice to Tenant, Tenant shall pay to Landlord a late charge equal to twelve percent (12%) of such overdue amount. The parties hereby agree that such late charge represents a fair and reasonable estimate of the costs Landlord will incur by reason of late payment by Tenant. Acceptance of such late charge by Landlord shall in no event constitute a weiver of Tenant's Default or Breach with respect to such overdue amount, nor prevent Landlord from exercising any of the other rights and remedies granted hereunder. In the event that a late charge is payable hereunder, whether or not collected, for three (3) consecutive installments of Base Rent, then notwithstanding Paregraph 4.1 or any other provision of this Lesse to the contrary, Base Rent shall, at Landlord's option, become due and payable quarterly in advance.

For purposes of this Paragraph 13.5, a reasonable time shall in no event be less than thirty (30) days after receipt by Landlord, and by the holders of any ground lease, mortgage or deed of trust covering the Premises whose name and address shall have been furnished Tenant In writing for such purpose, of written notice specifying wherein such obligation of Landlord has not been performed; provided, however, that if the nature of Landlord's obligation is such that more than thirty (30) days after such notice are reasonably required for its performance, then Landlord shall not be in breach of this Lease if performance within such thirty (30) day period and thereafter diligently pursued to completion.



Regardless of Landlord's knowledge of a Default or Breach at the time of accepting rent, the acceptance of rent by Landlord shall not be a waiver of any preceding Default or Breach by Tenant of any provision hereof, other than the failure of Tenant to pay the particular rent so accepted. Any payment given Landlord by Tenant may be accepted by Landlord on account of moneys or damages due Landlord, notwithstanding any qualifying statements or conditions made by Tenant in connection therewith, which such statements and/or conditions shall be of no force or effect whatsoever unless specifically agreed to in writing by Landlord at or before the time of deposit of such payment.
- 25. Recording. Either Landlord or Tenant shall, upon request of the other, execute, acknowledge and deliver to the other a short form memorandum of this Lease for recording purposes. The Party requesting recordation shall be responsible for payment of any fees or taxes applicable thereto.
- 26. No Right To Holdover. Tenant has no right to retain possession of the Premises or any part thereof beyond the expiration or earlier termination of this Lease.
- Cumulative Remedies. No remedy or election hereunder shall be deemed exclusive but shall, wherever possible, be cumulative with all other remedies at law or in equity.
- 28. Covenants and Conditions. All provisions of this Lease to be observed or performed by the Parties are both covenants and conditions
- 29. Binding Effect; Choice of Law. This Lease shall be binding upon the parties, their personal representatives, successors and assigns and be governed by the laws of the State in which the Premises are located. Any litigation between the Parties hereto concerning this Lease shall be initiated in the county in which the Premises are located.
- 30. Subordination: Attornment: Non-Disturbance.
- 30.1 Subordination. This Lease and any Option granted hereby shall be subject and subordinate to any ground lease, mortgage, deed of trust, or other hypothecation or security device (collectively, "Security Device"), now or hereafter placed by Landlord upon the real property of which the Premises are a part, to any and all advances made on the security thereof, and to all renewals, modifications, consolidations, replacements and extensions thereof. Tenant agrees that the Lenders holding any such Security Device shall have no duty, liability or obligation to perform any of the obligations of Landlord under this Lease, but that in the event of Landlord's default with respect to any such obligation. Tenant will give any Lender whose name and address have been furnished Tenant in writing for such purpose notice of Landlord's default and allow such Lender thirty (30) days following receipt of such notice for the cure of said default before invoking any remedies Tenant may have by reason thereof. If any Lender shall elect to have this Lease and/or any Option granted hereby superior to the lien of its Security Device and shall give written notice thereof to Tenant, this Lease and such Options shall be deemed prior to such Security Device, notwithstanding the relative dates of the documentation or recordation thereof.
- 30.2 Attornment. Subject to the non-disturbance provisions of Paragraph 30.3, Tenant agrees to attorn to a Lender or any other party who acquires ownership of the Premises by reason of a foreclosure of a Security Device, and that in the event of such foreclosure, such new owner shall not: (i) be liable for any act or omission of any prior Landford or with respect to events occurring prior to acquisition of ownership, unless the act or omission is ongoing, (ii) be subject to any offsets which Tenant might have against any prior Landford, or (iii) be bound by prepayment of more than one (1) month's rent.
- 30.3 Non-Disturbance. With respect to Security Devices entered into by Landlord after the execution of this Lease, Tenant's subordination of this Lease shall be subject to receiving assurance (a "non-disturbance agreement") from the Lender that Tenant's possession and this Lease, including any options to extend the term hereof, will not be disturbed so long as Tenant is not in Breach hereof and attorns to the record owner of the Premises.
- 30.4 Self-Executing. The agreements contained in this Paragraph 30 shall be effective without the execution of any further documents; provided, however, that upon written request from Landlord or a Lender in connection with a sale, financing or refinancing of the Premises, Tenant and Landlord shall execute such further writings as may be reasonably required to separately document any such subordination or non-subordination, attornment and/or non-disturbance agreement as is provided for herein.
- 31. Attorney's Fees. If any Party or Broker brings an action or proceeding to enforce the terms hereof or declare rights hereunder, the Prevailing Party (as hereafter defined) or Broker in any such proceeding, action, or appeal thereon, shall be entitled to reasonable attorney's fees. Such fees may be awarded in the same suit or recovered in a separate suit, whether or not such action or proceeding is pursued to decision or judgment. The term, "Prevailing Party" shall include, without limitation, a Party or Broker who substantially obtains or defeats the relief sought, as the case may be, whether by compromise, settlement, judgment, or the abandonment by the other Party or Broker of its claim or defense. The attorney's fees award shall not be computed in accordance with any court fee schedule, but shall be such as to fully reimburse all attorney's fees reasonably incurred. The Parties shall be entitled to attorney's fees, costs and expenses incurred in the preparation and service of notices of Default and consultations in connection therewith whether or not a legal action is subsequently commenced in connection with such Default or resulting Breach.
- 32. Landlord's Access; Showing Premises; Repairs. Landlord and Landlord's agents shall have the right to enter the Premises at any time, in the case of an emergency, and otherwise at reasonable times upon 24 hours prior notice, for the purpose of showing the same to prospective purchasers, lenders, or (during the last one hundred twenty (120) days of the term hereof) Tenants, and making such alterations, repairs, improvements or additions to the Premises or to the building of which they are a part, as Landlord may reasonably deem necessary. Landlord may at any time during the last one hundred twenty (120) days of the term hereof place on or about the Premises any ordinary "For Lease" signs. All such activities of Landlord shall be without abatement of rent or liability to Tenant as long as Landlord uses reasonable efforts to minimize any disruption of Tenant's activities at the Premises.
- 33. Auctions. Tenant shall not conduct, nor permit to be conducted, either voluntarily or involuntarily, any suction upon the Premises without first having obtained Landlord's prior written consent. Notwithstanding anything to the contrary in this Lease, Landlord shall not be obligated to exercise any standard of reasonableness in determining whether to grant such consent.
- 34. Signs. Tenant shall not place any sign upon the Premises, except that Tenant may, with Landlord's prior written consent, install (but not on the roof) such signs as are reasonably required to advertise Tenant's own business. The installation of any sign on the Premises by or for Tenant shall be subject to the provisions of Paragraph 7 (Maintenance, Repairs, Utility Installations, Trade Fixtures and Alterations). Unless otherwise expressing agreed herein, Landlord reserves all rights to the use of the roof and the right to install, and all revenues from the installation of, such advertising signs on the Premises, including the roof, as do not unreasonably interfere with the conduct of Tenant's business. Landlord will not unreasonably withhold its consent to Tenant's installation of a solar array upon the roof of the Premises, at Tenant's sole cost and expense. Tenant shall provide



Landlord with reasonably detailed plans with respect to its request to install any such array, including detailed plans regarding the manner in which the array will be affixed to the roof, and what precautions will be used to avoid teaks or other damage to the roof and the roof covering. All revenues and credits from any solar array will accrue to the Tenant.

38. Termination; Merger, Unless specifically stated otherwise in writing by Landiord, the voluntary or other sumender of this Lease by Tenant, the mutual termination or cancellation hereof, or a termination hereof by Landiord for Branch by Tenant, shall automatically terminate any sublesse or tesser estate in the Premises; provided, however, Landiord shall, in the event of any such sumender, termination or cancellation, have the option to continue any one or all of any existing sub-tenancies. Landiord's failure within ten (10) days following any such event to make a written election to the contrary by written notice to the holder of any such lesser interest, shall constitute Landiord's election to have such event constitute the termination of such interest.

#### 36. Consents.

- (e) Except for Paragraph 33 hereof (Auctions) or as otherwise provided herein, wherever in this Lease the consent of a Party is required to an act by or for the other Party, such consent shall not be unreasonably withheld or delayed. Landlord's actual reasonable costs and expenses (including but not limited to architects', attorneys', engineers' or other consultants' fees) incurred in the consideration of, or response to, a request by Tenant for any Landlord consent pertaining to this Lease or the Premisea, including but not limited to consents to an assignment, a subletting or the presence or use of a Hazardous Substance, practice or storage tank, shall be paid by Tenant to Landlord upon receipt of an invoice and supporting documentation therefor. Subject to Paragraph 12.2(e) (applicable to assignment or subletting), Landlord may, as a condition to considering any such request by Tenant, requise that Tenant deposit with Landlord an emount of money (in addition to the Security Deposit held under Paragraph 5) reasonably calculated by Landlord to represent the cost Landlord will incur in considering and responding to Tenant's request. Except as otherwise provided, any unused portion of said deposit shall be refunded to Tenant without interest. Landlord's consent to any sct, assignment of this Lease or subletting of the Premises by Tenant shall not constitute an acknowledgement that no Default or Breach by Tenant of this Lease exists, nor shall such consent be deemed a waiver of any then existing Default or Breach, except as may be otherwise specifically stated in writing by Landlord at the time of such consent.

- 27.2 It shall constitute a Default of the Tonant under this Lease If any such Guarantor falls or refuses, upon reasonable request by Landlord to give: (a) evidence of the due execution of the guaranty saled for by this Lease, including the authority of the Guarantor (and of the party signing on Guarantor's behalf) to obligate such Guarantor on said guaranty; and including in the case of a corporate Guarantor, a cartificate of incumbency showing the eignature of the persons authorized to beard of directors authorizing the making of such guaranty; together with a cartificate of incumbency showing the eignature of the persons authorized to sign on its behalf, (b) current financial statements of Guarantor se may from time to time be requested by Landlord, (c) a Tenancy Statement, or (d) written confirmation that the guaranty is edit in effect.
- 38. Quiet Possession. Upon payment by Tenant of the rent for the Premises and the observance and performance of sit of the covenants, conditions and provisions on Tenant's part to be observed and performed under this Lease. Tenant shall have quiet possession of the Premises for the entire term hereof subject to all of the provisions of this Lease.

# 39. Option to Extend

- 39.1 Right to Extend. As long as Tenant is not in default under this Lease beyond any applicable cure period at the time the option is exercised or at the time the renewal term is to commence, Tenant shall have the Option to extend the term of this Lease for two (2) terms of five (5) years each, commencing on the day following expiration of the prior term and, on the same terms and conditions contained herein. Other than as set for herein, Tenant shall have no further Option to extend this Lease. Tenant shall exercise each extension Option, if at all, by written notice given to Landord at least one hundred and eighty (180) days prior to expiration of the original term, or the precading extended term, if any. - 39.2 Determination of Rent. Within thirty (30) days after Tenant's notice of exercise of its Option, Landlord-shall notify Tenant of its determination of the fair market rent after a
- 39.3 Arbitration Procedure. Within len days after Tenant's rejection of Landford's determination of fair market rantal value, each party shall designate a representative who is either an Oregon licensed MAI appraiser skilled in determining rental rates for comparable space in the Portland, Oregon, metropolitan area, or a real estate broker experienced in leasing comparable space in the Portland, Oregon, metropolitan area. - 42. Reservations. 
