**MOTION FOR ORDER PERMITTING ELECTRONICS IN COURTHOUSE**

COMES NOW the Committee of Creditors Holding Unsecured Claims (the "**Committee**"), in the above-captioned cases, by and through the undersigned counsel, and hereby submits this *Motion for Order Permitting Electronics in Courthouse* (the "**Motion**") for an order substantially in the form attached hereto as Exhibit "A" (the "**Proposed Order**") authorizing its representatives to bring certain electronics into the Courthouse. In support of the Motion, the Committee respectfully shows the Court as follows:

1.

On August 4, 2025 (the "**Petition Date**"), the Debtors filed voluntary petitions for relief under Chapter 11, Title 11, of the United States Code with this Court. The cases were consolidated upon that certain *Order Authorizing and Directing the Joint Administration of the Debtors' Chapter 11 Cases for Procedural Purposes Only* entered on August 7, 2025 day. [Doc. No. 25].

2.

On August 14, 2025, the United States Trustee appointed the Committee pursuant to 11 U.S.C. §1102(a). [Doc. No. 59], consisting of: (i) Flooring Investments, LLC; (ii) Yu Cong Liu; and (iii) The Sherwin-Williams Company which subsequently resigned.

3.

The Committee, pursuant to 11 U.S.C. § 1103(a), have met, conferred, and unanimously agreed to employ the law firm Pachulski Stang Ziehl & Jones LLP, located at, 1700 Broadway, 36th Floor, New York, NY, 10019 as its lead counsel in these Chapter 11 Cases (the “**Counsel**”).

4.

The following attorneys are employed by Counsel and will be appearing on behalf of the Committee as lead counsel in these Chapter 11 Cases: Bradford J. Sandler, Shirley S. Cho, Cia H. Mackle and Maxim B. Litvak (the “**Attorneys**”).

5.

The Attorneys have been admitted *pro hac vice* in the Chapter 11 Cases.

6.

The Attorneys have requested approval to bring their respective cell phones (which shall remain off or on silent while the Court is in session if in the Courtroom) and their laptop and/or tablet computer, with all accompanying chargers, wires, and/or earbuds (together, the “**Electronics**”).

7.

Accordingly, the Committee moves for an order permitting the Attorneys to bring the Electronics past courthouse security and into the Courthouse through the conclusion of the Chapter 11 Cases, including but not limited to the hearing set for Monday, October 6, 2025.

**WHEREFORE**, the Committee respectfully requests that the Court enter an order substantially in the form of the Proposed Order and for such other and further relief as may be deemed just and proper.
