NOTICE OF FILING OF ASSUMED CONTRACTS IN CONNECTION WITH THE MOTION OF THE DEBTORS FOR ENTRY OF AN ORDER (A) APPROVING PRIVATE SALE OF THE DEBTORS' ASSETS FREE AND CLEAR OF ALL LIENS, CLAIMS, ENCUMBRANCES, AND INTERESTS, (B) AUTHORIZING THE ASSUMPTION AND ASSIGNMENT OF CERTAIN EXECUTORY CONTRACTS AND UNEXPIRED LEASES, AND (C) GRANTING RELATED RELIEF

PLEASE TAKE NOTICE THAT:

- 1. On August 4, 2025, the above-captioned debtors and debtors in possession (collectively, the "<u>Debtors</u>") each filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Northern District of Georgia (the "<u>Court</u>").
- 2. On August 8, 2025, the Debtors filed the Motion of the Debtors for Entry of Orders (I)(A) Establishing Bidding Procedures Relating to the Sale of the Debtors' Assets, (B) Approving the Debtors' Entry into the Stalking Horse Purchase Agreements and Related Bid Protections, (C) Establishing Procedures Relating to the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases, (D) Approving Form and Manner of Notices Relating Thereto, (E) Scheduling a Hearing to Consider the Proposed Sale, and (F) Granting Related Relief (the "Bid Procedures Motion"); and (II)(A) Approving the Sale of the Debtors' Assets Free and Clear of All Liens, Claims, Encumbrances, and Interests, (B) Authorizing the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases, and (C) Granting Related Relief [D.I. 38] (the "Sale Motion", and together with the Bid Procedures Motion, the "Motion") with the Court.
- 3. On August 25, 2025, the Court entered an order approving the Bid Procedures Motion [D.I. 99] (the "<u>Bidding Procedures Order</u>"), granting certain of the relief sought in the Bid Procedures Motion, including, among other things, approving the Bidding Procedures and the Assumptions and Assignment Procedures and scheduling a Sale Hearing (the "<u>Sale Hearing</u>").

- 4. On August 26, 2025, the Debtors filed a *Notice of Proposed Sale, Bidding Procedures, Auction, and Sale Hearing* [D.I. 101] (the "<u>Auction and Sale Notice</u>").²
- 5. On September 12, 2025, the Debtors filed a *Notice of Proposed Assumption and Assignment of Certain Executory Contracts* [D.I. 168] (the "Notice of Potential Assumption and Assignment").
- 6. On September 17, 2025, the Debtors filed a *Notice of Cancelation of Auction* [D.I. 177].
- 7. On September 26, 2025, the Debtors filed a Motion of the Debtors for Entry of an Order (A) Approving Private Sale of the Debtors' Assets Free and Clear of All Liens, Claims, Encumbrances, and Interests, (B) Authorizing the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases, and (C) Granting Related Relief [D.I. 194] (the "Private Sale Motion"). Along with the Private Sale Motion, the Debtors filed an Order (A) Approving the Private Sale of the Debtors' Assets Free and Clear of all Liens, Claims, Encumbrances, and Interests, (B) Authorizing the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases, and (C) Granting Related Relief (the "Proposed Sale Order").
- 8. The Proposed Sale Order referenced a list of Assumed Contracts (the "<u>Assumed Contracts List</u>") to be attached as Exhibit "B" thereto. The Assumed Contracts List was anticipated to be supplemented at or before the Hearing.
 - 9. Attached hereto as **Exhibit A** is the Assumed Contracts List.⁴
