女性運動抬頭 專屬用品掀商機

穿男性足球鞋?「縮水粉紅版」思維淘汰 婦女主導企業推新品

女子運動越來越受到重視，國家女子籃球協會(WNBA)觀眾人數創新高，而且有若干新的職業運動聯盟相繼成立。顧問公司德勤(Deloitte)的數據顯示，全球女子運動相關營收今年預計可增至23.5億元。為搶食深具潛力的商機，婦女主導企業紛紛推出專為女性設計的用品。

美聯社報導，在女性運動風潮下，女性品牌有更多發展機會。長久以來，把男性用品賣給女性將就使用、為女性推出徒具外觀而不實用的商品等「縮水粉紅版」(shrink it and pink it)思維，正在被淘汰。

體育行銷和贊助平台 Parity 執行長斯里尼瓦桑(Leela Srinivasan)表示，男性產品根本不是為女性打造的。密西根大學運動機能學院(Michigan School of Kinesiology)體育行銷研究中心的郭大熙(Dae Hee Kwak，音譯)則說，有誰比女性更了解女性運動迷和運動員的需求？

於是，婦女主導的企業紛紛推出專為女性設計的用品，以女性為優先考量的運動用品公司相繼成立。

IDA便是近年成立的女性運動用品業者之一。創辦人揚森(Laura Youngson)一開始只是組織一群女子登山，並於2017年參加一場高海拔足球比賽，旨在突顯

女性運動受到不平等待遇。

比賽期間，揚森驚訝發現所有女運動員都穿著男式足球鞋，而不是專為她們設計的裝備，促使她創立IDA Sports，針對女性獨特需求量身打造專用足球鞋。

在那之後，Moolah Kicks公司也專為女性腳型設計生產女子籃球鞋，WNBA 明尼蘇達山貓隊(Minnesota Lynx)球員威廉斯(Courtney Williams)是其中一個合作夥伴；另有豪斯曼(Lindsay Housman)創辦高性能跑鞋公司 Hettas；奧運金牌得主短跑女獎費利克斯(Allyson Felix)創辦跑鞋公司 Saysh，允許

顧客在懷孕期間尺寸變化時免費換貨。

愛迪達(Adidas)、耐吉(Nike)等大型鞋企也搶搭女性運動風，開發女子足球鞋和籃球鞋；其中，職業女籃運動員伊內斯庫(Sabrina Ionescu)與耐吉合作推出一款簽名鞋，愛迪達今夏與美國女子足球聯賽(NWSL)球星羅德曼(Trinity Rodman)合作，推出愛迪達F50 Sparkfusion首款球員版足球鞋。

女性運動風也擴及鞋類以外的市場，Liv Cycling製女性高性能自行車，WNBA的印第安納熱隊(Indiana Fever)產製Sequel衛生棉條，螺旋凸槽可防止劇烈運動時外漏。

致敬橄欖球女選手 美泰兒推「芭比隊」

鼓勵年輕女孩「自信做自己」 娃娃採用肌肉型身體 呈現運動員體態

玩具大廠美泰兒(Mattel)近日推出四款全球限量版「芭比隊」(Team Barbie)娃娃，以致敬來自世界各地的四位橄欖球選手，其中包括美國奧運獎牌得主伊洛娜·馬厄(Ilona Maher)、英國球員艾莉·基爾登(Ellie Kildunne)、紐西蘭的波西亞·伍德曼-威克利夫(Portia Woodman-Wickliffe)，以及法國選手娜西拉·孔德(Nassira Konde)。

國家廣播公司新聞網(NBC News)報導，美泰兒在10月6日宣布這項「芭比隊」計畫，鼓勵年輕女孩「自信做自己」

，而這項特別企劃的推出正逢10月11日「國際女童日」(International Day of the Girl)前夕。芭比品牌資深副總裁萊莉·柏格(Krista Berger)表示，美泰兒致力於「打破限制女孩潛能的各種障礙，包括從性別刻板印象到自我懷疑，幫助她們實現無限潛能。」

馬厄：堅持努力 走到今天

馬厄在聲明中坦言，「我們都會懷疑自己，我也一樣，但我之所以能走到今天，是因為我從未放棄。即使在艱苦的訓練日或狀態不佳的時候，我依然堅持努力，提升技術，並相信自己的能力。」

馬厄款芭比娃娃就像她本人的招牌打扮，紫辮子和塗口紅，帶著護膝和詳細復刻的愛迪達足球鞋，似乎對上場應戰準備就緒，使馬厄非常滿意。這款娃娃預計在2026年上市，採用全新「肌肉型身體雕塑」，目的是呈現強壯女性運動員的體態線條。

為自己的成長感到驕傲

馬厄本人更表示，她為自己的成長感到驕傲，也認為不斷的投入與努力讓她在橄欖球場上與內心都更有自信，「如果我的故事能啟發年輕女孩像我一樣相信自己，那我就真的產生了影響力。」

現年29歲的馬厄，曾代表美國出戰2020與2024年奧運，並在巴黎奧運與隊友一同拿下銅牌。她表示，「當人們想到橄欖球時，常會覺得那是男人的運動，但其實女性表現同樣出色。我非常興奮，因為在這項男性主導的運動中，我能成為女性代表。」

其實運動員馬厄的影響力早已超越球場，例如今年她登上「運動畫刊」(Sports Illustrated)伸展台並在2024年成為雜誌封面人物之一。馬厄補充說，「當其他女孩看到我，心想『天啊，我的體態和她一樣』時，不僅讓我更有自信，也能讓她們感到被看見、被鼓勵。」

多平台追觀賽 體育迷看完就退訂

對許多運動迷來說，觀看所有自己喜愛的球隊比賽不再是唾手可得的娛樂，尤其是那些想看每一場常規賽，或觀看非當地球隊的球迷，他們別無選擇只能採取東拼西湊的平台大雜燴。可是各家公司的新服務不斷推出，只剩死忠體育迷能堅持訂閱多個平台和服務，其他觀眾則因荷包受壓，不再定期觀看自己喜歡的體育賽事或球隊。

美聯社報導，現在球迷的例行公事之一是：8月開戰職業美式足球大聯盟(NFL)方案，超級盃結束後退訂，等到職業籃球聯盟(NBA)季後賽開打前，再訂閱NBA串流服務。若要看當地棒球隊比賽的話只能靠有線電視，只好勉強繼續付有線電視費。

美聯社/NORC公共事務研究中心(Associated Press-NORC Center for Public

Affairs Research)的新民調顯示，許多體育迷不得不依賴多個平台，但他們都不想承擔這種成本。極度或非常關注體育的受訪者中，大約有四成同時使用有線/衛星電視與體育專屬串流平台。而在後面這個族群當中，對能夠看到的賽事滿意度最高。

民調也發現體育迷比非體育迷更常更換串流服務。約六成體育迷表示，他們過去一年曾為了某個節目或運動賽季而訂閱串流服務，其中約一半表示看完就退訂。極度或非常關注體育的人更有此傾向，使用體育串流平台的人當中，約三分之二曾為特定節目或賽季而訂閱。

不過正因為賽事獨家性，體育迷反倒不太會是「剪線族」，極度或非常關注體育的人當中，約六成表示仍使用有線或衛星電視；不太關注體育的人僅三分之一。

常換串流服務

45歲的德州球迷蘇約翰(John So)是較早「剪線」的觀眾，他幾乎能收看所有NFL休士頓德州人隊的比賽，但要當當地NBA與職業棒球聯盟(MLB)球隊卻不容易。蘇約翰表示，「我得每月多付15或16元訂購地方體育網路套餐才得到當地比賽，這讓我更不想重複觀賽。」

近半體育迷 不滿意價格

有一點幾乎所有體育迷都同意：昂貴。至少有點關注體育的人當中，約一半表示不滿意自己使用的串流與有線服務價格。所以球迷們也常共體時艱，近半表示曾分享自己的密碼或用別人的密碼。
