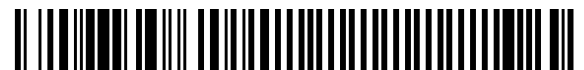

PLEASE TAKE NOTICE that, on December 2, 2025, Aurora Management Partners (the “Applicant”) filed *First Interim Application of Aurora Management Partners for Allowance of Compensation for Services Rendered and Reimbursement of Expenses Incurred For The Debtors for the Period of August 4, 2025 Through September 30, 2025* (the “Application”). Pursuant to the Fifth Amended and Restated General Order No. 24-2018, the Court may consider this matter without further notice or hearing if no party in interest files a response or objection **within twenty-one (21) days** from the date of service of this notice. **If you object to the relief requested in this pleading, you must timely file your objection with the Bankruptcy Clerk at Clerk at the United States Bankruptcy Court for the Northern District of Georgia, 75 Ted Turner Drive, SW, Suite 1340, Atlanta, Georgia 30303, and serve a copy on the Debtors’ attorney, at Greenberg Traurig, LLP, Terminus 200, 3333 Piedmont Road, NE, Suite 2500, Atlanta, Georgia 30305, Attn: John D. Elrod (elrodj@gtlaw.com) and Allison J. McGregor (Allison.McGregor@gtlaw.com), and any other appropriate persons by the objection deadline.** The response or objection must explain your position and be actually received by the Bankruptcy Clerk within the required time.

A hearing on the Application has been scheduled for January 6, 2026. The Court will hold a hearing on the Application at **1:30 p.m. (prevailing Eastern Time) on January 6, 2026 in Courtroom 1201, United States Courthouse, 75 Ted Turner Drive, SW, Atlanta, Georgia 30303.**

If an objection or response is timely filed and served, the hearing will proceed as scheduled. **If you do not file a response or objection within the time permitted, the Court may grant the**

**FIRST INTERIM APPLICATION OF AURORA MANAGEMENT PARTNERS
FOR ALLOWANCE OF COMPENSATION FOR SERVICES RENDERED AND
REIMBURSEMENT OF EXPENSES INCURRED FOR THE DEBTORS, FOR
THE PERIOD FROM AUGUST 4, 2025 THROUGH SEPTEMBER 30, 2025**

Aurora Management Partners (“Aurora”), as provider of a Chief Restructuring Officer and Additional Personnel for the above captioned debtors and debtors in possession (collectively, the “Debtors”) in these Chapter 11 Cases (as defined below), hereby files this *First Interim Application of Aurora Management Partners for Allowance of Compensation for Services Rendered and Reimbursement of Expenses Incurred for the Debtors for the Period of August 4, 2025 Through September 30, 2025* (this “Application”) seeking allowance of compensation and reimbursement of expenses pursuant to sections 330 and 331 of title 11 of the United States Code (the “Bankruptcy Code”), Rule 2016 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), and the *Second Amended and Restated General Order 26-2019, Procedures for Complex Chapter 11 Cases*, dated February 6, 2023 (the “Complex Case Procedures”) for the period from August 4, 2025 through September 30, 2025 (the “Application”).

A u r o r a submits this Application for (a) allowance of reasonable compensation for professional services rendered by Auroa to the Debtors in the amount of \$359,784, and (b) reimbursement of actual and necessary charges and disbursements incurred by Aurora in the rendition of required professional services on behalf of the Debtors in the amount of \$2,868.20. In support of this Application, A u r o r a respectfully represents as follows:

JURISDICTION AND VENUE

1. The United States Bankruptcy Court for the Northern District of Georgia, Atlanta Division (the “Court”) has jurisdiction over these cases and this matter pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding within the meaning of 28 U.S.C. § 157(b). Venue is proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409.

2. The predicates for the relief requested herein are sections 105, 327(a), and 331 of the Bankruptcy Code, Rule 2016 of the Bankruptcy Rules, Rule 9013-2 of the Local Rules of the United States Bankruptcy Court for the Northern District of Georgia (the “Local Rules”), and Procedure J of the Complex Case Procedures.

BACKGROUND

3. On August 4, 2025 (the “Petition Date”), the Debtors filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code in the Court (collectively, the “Chapter 11 Cases”). The Debtors have continued in possession of their properties and have continued to operate and manage their business as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. No request has been made for the appointment of a trustee or examiner in these cases.

4. The factual background relating to the Debtors’ commencement of these cases is set forth in the *Declaration of David Baker, CTP in Support of Chapter 11 Petitions and First Day Pleadings* [Docket No. 14] (the “First Day Declaration”) filed on or about the Petition Date and

incorporated herein by reference.

5. On August 7, 2025, the Court entered the *Order Authorizing and Directing Joint Administration of the Debtors' Chapter 11 Cases for Procedural Purposes Only* [Docket No. 25] (the “Joint Administration Order”) authorizing the joint administration and procedural consolidation of the Chapter 11 Cases pursuant to Bankruptcy Rule 1015(b).

6. On August 14, 2025, the United States Trustee (the “U.S. Trustee”) appointed the official committee of unsecured creditors (the “Committee”). See *Appointment and Notice of Appointment of Committee of Creditors Holding Unsecured Claims* [Docket No. 59].

RETENTION OF AURORA

7. On August 26, 2025, the Debtors filed *Debtors' Application Pursuant to 11 U.S.C. §§ 105(a) and 363(b) to (I) Retain and Employ Aurora Management Partners Inc. to Provide Certain Additional Personnel; and (II) Designate David M. Baker as Chief Restructuring Officer for the Debtors and Debtors-in-Possession, Effective as of the Petition Date* [Docket No. 103] (the “Retention Application”). On September 9, 2025, the Court entered the *Order Authorizing the Debtors, Pursuant to 11 U.S.C. §§ 105(a) and 363(b) to (I) Retain and Employ Aurora Management Partners Inc. to Provide Certain Additional Personnel; and (II) Designate David M. Baker as Chief Restructuring Officer for the Debtors and Debtors-in-Possession, Effective as of the Petition Date, Subject to Objection* [Docket No. 150] (the “Retention Order”) authorizing the Debtors to retain Aurora to (i) provide certain additional personal and (ii) designate David M. Baker as their Chief Restructuring Officer (“CRO”).

8. The terms and conditions of employment and compensation are set forth in the engagement letter attached as Exhibit A to the Retention Application (the “Engagement Letter”).

AURORA SERVICES RENDERED

9. Since July 2025, Aurora has provided interim management services to the Debtors

and provided the Debtors with David Baker to serve as CRO as well as other additional employees of Aurora (the “Additional Personnel”). The CRO and Additional Personnel were critical to the Debtors’ navigation through these chapter 11 cases and the ultimate consummation of the Sale (as defined in the Sale Order).

10. Among other things, the Additional Personnel supported the Debtors with respect to the following:

- Assisted the Debtors in managing the process of filing petitions for relief under chapter 11 of the Bankruptcy Code;
- Assisted the Debtors and collaborated with counsel and the Debtors’ other professionals in preparing to file petitions for relief under chapter 11 of the Bankruptcy Code and all related papers;
- Assisted with the Debtors’ implementation of Court orders;
- Assisted with financing issues either prior to or during a bankruptcy filing, including providing analysis required to obtain and comply with the terms of the Debtors’ usage of cash collateral, post-petition and/or exit financing;
- Participated in meetings and provided support to the Debtors and their other professionals in responding to information requests, communicating with and/or negotiating with lenders, official and unofficial committees of creditors, vendors, customers, the U.S. Trustee, other parties in interest, and professionals hired by the same;
- Based on the Debtors’ underlying records, as and when produced, prepared such financial disclosures required by the Court, including the Debtors’ schedules of assets and liabilities, statements of financial affairs and monthly operating reports;

- Assisted the Debtors with de minimis asset sales and supported a section 363 sale process, including (i) developing materials and documents for potential buyers' review, (ii) assisting the Debtors with the preparation of due diligence materials and responding to buyer diligence requests, (iii) assisting with the evaluation of offers received and (v) working with the Debtors, counsel, and other advisors to prepare and support asset purchase agreements and related motions to obtain Court approval;
- Advised regarding the Debtors' accounting and operating procedures to segregate prepetition and post-petition business transactions;
- Identified the Debtors' executory contracts and unexpired leases, as and when produced, and performed analyses of the financial impact of the assumption or rejection of each, as necessary;
- Participated in the Debtors' claims analysis and reporting;
- Advised the Debtors on the implementation of technical accounting matters resulting from or related to the bankruptcy and restructuring process;
- Rendered testimony, as requested, about the matters regarding which Aurora and its personnel are providing services; and
- Provided such other restructuring or advisory services to the Debtors as are consistent with the role of Chief Restructuring Officer and/or the above described services, requested by the Debtors and their counsel, not duplicative of services provided by other professionals, and agreed to by Aurora.

11. Pursuant to the Complex Case Procedures, Aurora has served two (2) Monthly Reports and Fee Statements, copies of which are attached hereto as **Exhibit A** on the Professional

Fee Notice Parties. No objections to the Monthly Staffing Reports and Fee Statements were received by Aurora.

RELIEF REQUESTED

12. By this Application, Aurora seeks interim approval and allowance of compensation in the amount of \$359,784.00 for professional services rendered, and reimbursement of actual and necessary expenses incurred during the Application Period in the amount of \$2,868.20.

COMPENSATION PAID AND ITS SOURCE

13. All services performed during the Application Period for which Aurora is requesting compensation were performed for or on behalf of the Debtors.

14. As of the date of this Application, Aurora has not received any payment or any promise of payment for the services rendered from anyone in any capacity, nor is there an agreement in place between Aurora and any person or otherwise in connection with the matters in this Application.

SUMMARY OF SERVICES RENDERED

15. This Application is an interim application filed by Aurora in these Chapter 11 Cases. In connection with the professional services described below, by this Application, Aurora seeks compensation in the amount of \$359,784.00 for professional services rendered and \$2,868.20 for expenses incurred during the Application Period.

16. The majority of services rendered by Aurora during the Application Period are summarized below. Moreover, each of the following are set forth in the Monthly Staffing Reports and Fee Statements attached as **Exhibit A**, which include: (i) a description of the Professional performing the services; (ii) the date the services were performed; and (iii) a detailed description of the nature of the services and the related time expended. Summarily, Aurora rendered the

following services during the Application Period:

- Assisted the Debtors in managing the process of filing petitions for relief under chapter 11 of the Bankruptcy Code;
- Assisted the Debtors and collaborated with counsel and the Debtors' other professionals in preparing to file petitions for relief under chapter 11 of the Bankruptcy Code and all related papers;
- Assisted with the Debtors' implementation of Court orders;
- Assisted with financing issues either prior to or during a bankruptcy filing, including providing analysis required to obtain and comply with the terms of the Debtors' usage of cash collateral, post-petition and/or exit financing;
- Participated in meetings and provided support to the Debtors and their other professionals in responding to information requests, communicating with and/or negotiating with lenders, official and unofficial committees of creditors, vendors, customers, the U.S. Trustee, other parties in interest, and professionals hired by the same;
- Based on the Debtors' underlying records, as and when produced, prepare such financial disclosures as may be required by the Court, including the Debtors' schedules of assets and liabilities, statements of financial affairs and monthly operating reports;
- Assisted the Debtors with a section 363 sale process, including (i) developing materials and documents for potential buyers' review, (ii) assisting the Debtors with the preparation of due diligence materials and responding to buyer diligence requests, (iii) assisting with the evaluation of offers received and (v) working with

the Debtors, counsel, and other advisors to prepare and support asset purchase agreements and related motions to obtain Court approval;

- Advised regarding the Debtors' accounting and operating procedures to segregate prepetition and post-petition business transactions;
- Identified the Debtors' executory contracts and unexpired leases, as and when produced, and perform analyses of the financial impact of the assumption or rejection of each, as necessary;
- Participated in the Debtors' claims analysis and reporting, including plan classification modeling and claim estimation;
- Advised the Debtors on the implementation of technical accounting matters resulting from or related to the bankruptcy and restructuring process;
- Rendered testimony, as requested, about the matters regarding which Aurora and its personnel provided services; and
- Provided such other restructuring or advisory services to the Debtors as are consistent with the role of Chief Restructuring Officer and/or the above described services, requested by the Debtors and their counsel, not duplicative of services provided by other professionals, and agreed to by Aurora.

REASONABLE AND NECESSARY SERVICES RENDERED BY AURORA

17. The foregoing professional services rendered by Aurora at the request and on behalf of the Debtors during the Application Period were reasonable, necessary, and appropriate to the administration of the Chapter 11 Cases and related matters. Aurora believes that the fee structure and terms were reasonable and comparable to those generally charged by CROs, restructuring financial advisors, and consultants of similar stature to Aurora for comparable engagements, both

in and out of chapter 11.

ACTUAL AND NECESSARY EXPENSES INCURRED BY AURORA

18. Pursuant to the Retention Order, Aurora is entitled to reimbursement of reasonable and documented out-of-pocket expenses incurred in entering into and providing services to the Debtors during the Application Period. A detailed description of the necessary costs and expenses incurred by Aurora are included in each Monthly Staffing Report and Fee Statement.

**AURORA'S REQUESTED COMPENSATION
AND REIMBURSEMENT SHOULD BE ALLOWED**

19. Aurora has provided valuable services to the Debtors. The services summarized by this Application and rendered by Aurora to the Debtors during the Application Period were substantial, highly professional, and instrumental to the Debtors in pursuing their filing petitions for relief under chapter 11 of the Bankruptcy Code. Aurora respectfully submits that the professional services for which it requests compensation and the expenditure for which it seeks reimbursement in this Application were necessary for and beneficial to the orderly administration of the Debtors' estates and their sale efforts. The professionals of Aurora worked assiduously to anticipate or respond to the needs of the Debtors and to assist the Debtors in navigating through the sale and bankruptcy process. Such services and expenditures were necessary to, and in the best interests of, the Debtors' estates and their creditors. Accordingly, Aurora respectfully submits that the compensation and reimbursement requested by this Application are reasonable and justified in light of the nature and value of such services.

NOTICE

20. Aurora has provided notice of this Application to the following parties and/or their respective counsel, as applicable: (a) the U.S. Trustee; (b) counsel to the Committee; (c) counsel to the Debtors' prepetition lenders; (d) counsel to the DIP Lenders; and (e) all parties entitled to

notice pursuant to Section J of the Complex Case Procedures.

CONCLUSION

WHEREFORE, Aurora respectfully requests that the Court enter an order, substantially in the form attached hereto as **Exhibit B**, (i) allowing on an interim basis (a) compensation in the amount of \$359,784.00 for professional services rendered to the Debtors during the Application Period and (b) reimbursement of actual, reasonable and necessary expenses incurred during the Application Period in the amount of \$2,868.20; (ii) authorizing and directing the Debtors to pay any unpaid portion of the foregoing; and (iii) granting such other or further relief deemed appropriate under the circumstances.
