**ORDER GRANTING FIRST INTERIM APPLICATION FOR COMPENSATION  
OF DUNDON ADVISERS, LLC, AS FINANCIAL ADVISORS FOR THE  
OFFICIAL COMMITTEE OF UNSECURED CREDITORS OF WELLMACED  
FLOOR COVERINGS INTERNATIONAL, INC., AND WELLMACED  
INDUSTRIES MFR N.A., LLC, FOR THE PERIOD FROM AUGUST 19, 2025  
THROUGH NOVEMBER 30, 2025**

Upon consideration of the *First Interim Application for Compensation for Dundon  
Advisers, LLC, as Financial Advisors for the Official Committee of Unsecured Creditors*

*of Wellmade Floor Coverings International, Inc., and Wellmade Industries MFR N.A., LLC* [Docket No. 300] (the “**Application**”), for allowance of reasonable compensation for professional services rendered by Dundon Advisers, LLC (“**Dundon**”) to the Committee for the period from August 19, 2025 through November 30, 2025 (the “**Fee Period**”).

A Notice of Filing of Pleadings, Deadline to Object and Hearing (“**Notice**”) regarding the Application, pursuant to the Fifth Amended and Restated General Order No. 24-2018, was filed on January 12, 2026 [Doc. No. 301], and served by electronic mail and/or First Class U.S. mail on the Master Service, as evidenced by the Certificate of Service filed related thereto [Doc. Nos. 300 and 301]. The Notice scheduled a hearing for February 11, 2026 (“**Hearing**”), if any objections were timely filed on or before February 5, 2026. No parties timely filed an objection to the Application on or before February 5, 2026.

It appearing that the Application meets the standards for the compensation of professionals in these cases, having reviewed and considered the Application and all other matters of record, including the lack of objection thereto, after due deliberation thereon and finding that good cause exists for the entry of this Order and that no further notice or opportunity for hearing is required, for good cause shown, it is hereby ORDERED as follows:

1. The Application is hereby APPROVED in its entirety.
2. Dundon is awarded as an administrative expense in these cases, on an interim basis, the sum of \$108,507.50 as compensation for necessary and reasonable professional services rendered during the Fee Period.

3. Dundon is authorized to apply against such amounts the amounts that have been, and subsequent to the Application were, paid to Dundon by the Debtors in the respective the Fee Period pursuant to the Complex Case Procedures Order.

4. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

5. The Debtors are authorized and empowered to take all actions necessary to implement the relief granted in this Order and to pay any remaining amounts due to Dundon.

6. Notice of the Application as provided therein shall be deemed good and sufficient notice of such Application and the requirements of Bankruptcy Rule 6004(a), the Local Rules, and the Complex Case Procedures Order are satisfied by such notice.

7. The Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
