1. On September 9, 2025, the above-captioned debtors and debtors in possession (the “Debtors”) filed *Debtors’ Motion for Entry of an Order Authorizing the Retention and Compensation of Certain Professionals Utilized in the Ordinary Course of Business* [D.I. 153] (the “Motion”).
2. On October 3, 2025, the United States Bankruptcy Court for the Northern District of Georgia entered the *Order Authorizing the Retention and Compensation of Certain Professionals Utilized in the Ordinary Course of Business* [D.I. 214] (the “Order”).
