RESPONSE OF CITY OF MARLBOROUGH TO DEBTOR'S EIGHTEENTH OMNIBUS OBJECTION TO EQUITY INTEREST CLAIM AND NO LIABILITY CLAIM

Now comes the City of Marlborough (hereinafter, the "City"), and respectfully requests that this Honorable Court overrule the Objection of Debtors to Proof of Claim 7384 (Number 2 of Schedule 2 of the 18th Omnibus Objection, hereinafter the "Objection") which concerns the assessment of outstanding personal property taxes assessed to the Debtor, as well as post-petition interest.

Concurrent to this response, the City has filed an Amended Proof of Claim which differs from the original Proof of Claim in that it reflects an abatement of Fiscal Year 2020 taxes. Insofar as Debtor's maintain any objections and requests also extend to the City's Amended Proof of Claim, however, the City further requests that this Honorable Court overrule all of Debtor's objections thereto and deny all of Debtor's requests. In support thereof, the City avers as follows:

Factual Background

- 1. Upon information and belief, Debtors filed a voluntary Chapter 11 on February 25, 2019.
- 2. Upon request and instruction by Debtors, the City has maintained approximately 10 distinct accounts for personal property tax assessment.
- 3. On or around August 16, 2019 the City filed its original Proof of Claim with an attachment (collectively attached as **Exhibit A** hereto), which Proof of Claim concerns unpaid personal property taxes relating to account number <u>138700</u>. As provided in section 7 and 9 of the Proof of Claim, the City's unsecured claim is in the total amount of \$48,104.77 including taxes, fees, and interest.

- 4. According to its Objection, the Debtor alleges that no amounts are due and no liability exists for the Claim. In addition, the Debtors claim to have provided the City with materials showing the claim is based on a duplicate assessment. ("Debtor's Documentation").
- On or around July 12, 2021, having not received any of the Debtor's Documentation, the City inquired and requested the Debtor resend any documentation it had showing a duplicate assessment.
- 6. On or around July 15, 2021, the City received the Debtor's Documentation which contained three (3) cancelled checks and six (6) tax bills for account numbers 116170, 139160, 139190, 139200, and 139210. See **Exhibit B** attached hereto.
- 7. None of the documents produced by the Debtor shows proof that the taxes owed under account 138700 were paid, or alternatively assessed in duplicate to another account that had been paid.
- 8. Upon information and belief, the Debtor requested that the City close accounts numbered 113830 and 135120 on or around February 5, 2018 and further requested to have all assets reassigned to a new account which became account <u>138700</u>. The assets listed under account <u>138700</u> contain in its entirety the assets of the former accounts 113830 and 135120.
- Accounts 113830 and 135120 were not assessed a personal property tax bill for fiscal year 2019. Personal property taxes assessed under account 138700 were first billed for fiscal year 2019.
- 10. Based on the above, the City believes the personal property taxes were appropriately assessed and no duplication exists as alleged by Debtor.
- 11. The City remains willing to review any additional documentation the debtor may have suggesting a duplicate assessment has taken place.

WHEREFORE, for all the foregoing reasons, the City respectfully requests that this Honorable Court overrule Debtors' objection and deny their requests, as provided in the Objection of Proof of Claim Number 7384 (Number 2 on Schedule 2 of the 18th Omnibus Objection), and allow such claims in the full amounts provided in the City's Amended Proof of Claim, and grant to the City such relief as the court deems appropriate.

If your payments are not made by their due dates, interest at the rate of 14% per annum will be charged on the unpaid and overdue amount. If preliminary bills were mailed on or before August 1, 2018, interest will be computed on overdue first payments from August 1, 2018, or the payment due date, whichever is later, and on overdue payments from November 1, 2018, to the date payment is made. If preliminary bills were mailed after August 1, 2018, interest will be computed on overdue payments from November 1, 2018, or the payment due date, whichever is later, to the date payment is made. You will also be required to pay charges and fees incurred for collection if payments are not made when due. Payments are considered made when received by the Collector. To obtain a receipted bill, enclose a self-addressed stamped envelope and both copies of the bill with your payment.
