### ORDER (I) AUTHORIZING THE DEBTORS TO REDACT CERTAIN PERSONALLY IDENTIFIABLE INFORMATION, (II) APPROVING THE FORM AND MANNER OF THE NOTICE OF COMMENCEMENT, AND (III) GRANTING RELATED RELIEF

Upon the motion (the "**Motion**")<sup>2</sup> of the above-captioned debtors and debtors in possession (collectively, the "**Debtors**") for entry of an order (this "**Order**"), authorizing the Debtors to (i) redact certain personally identifiable information, (ii) approving the form and manner of notice of commencement of these chapter 11 cases, and (iii) granting related relief, all as more fully set forth in the Motion; and upon consideration of the First Day Declaration; and the Court having jurisdiction over this matter pursuant to 28 U.S.C. § 1334; and this matter being a core proceeding within the meaning of 28 U.S.C. § 157(b)(2); and venue of this proceeding and the Motion in this district being proper pursuant to 28 U.S.C. §§ 1408 and 1409; and appropriate notice of and the opportunity for a hearing on the Motion having been given and it appearing that no other or further notice need be provided; and this Court having reviewed the Motion and having heard the

statements in support of the relief requested therein at a hearing before this Court; and no objections having been filed; and the relief requested in the Motion being in the best interests of the Debtors' estates, their creditors, and other parties in interest; and this Court having determined that the legal and factual bases set forth in the Motion and at the hearing establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

1. The Debtors are authorized to redact from any paper filed or to be filed with the Court in the chapter 11 cases, including the Creditor Matrix, the physical and email addresses of the Debtors' current and former employees and any other natural persons. The Debtors shall file a sealed, unredacted version of the Creditor Matrix with the Court provide an unredacted version and any other filings redacted pursuant to this Order to (a) the U.S. Trustee, and counsel to any official committee appointed in the chapter 11 cases and (b) any party in interest upon a request to the Debtors (email being sufficient) or to the Court that is reasonably related to these chapter 11 cases; *provided*, that any receiving party shall not transfer or otherwise provide such unredacted document(s) to any person or entity not party to the request. The Debtors shall inform the Court and the U.S. Trustee promptly after denying any request for an unredacted document pursuant to this Order. Where redactions are made to certificates and/or affidavits of service pursuant to this Order, unredacted versions shall be filed with the Court under seal.

2. The Debtors are authorized to serve the Notice of Commencement, substantially in the form attached hereto as <u>Exhibit A</u>, on all parties on the Creditor Matrix. The form and manner of the Notice of Commencement of the chapter 11 cases and the scheduling of the meeting of creditors under section 341 of the Bankruptcy Code is hereby approved.

3. Notice of the Motion as provided therein shall be deemed good and sufficient notice of such Motion.

5. This Court shall retain exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
