The Reorganized Debtors desire to have Declarant Coronado available to testify regarding the Objection, if necessary, for the benefit of the Court and all parties.

The Reorganized Debtors previously moved to continue hearings on two other objections (Dkt. Nos. 2215 and 2218) for which Declarant Coronado was declarant, which were also previously set for July 7, 2025. See Dkt. No. 3165. The Court granted that motion, re-setting those objections for hearing on July 15, 2025, when Declarant Coronado was available.
